GMA launches integrated, holistic program for drug rehab

The municipal government of General Mariano Alvarez (GMA) headed by Mayor Maricel Echevarria-Torres launched its BUKAS PALAD Program or "Bagong Umaga Kaagapay ang Sarili, Pamilya, Pamayanan at Pamahalaan Laban sa Droga" on Monday, January 23, at the GMA Municipal Plaza during its flag ceremony.



BUKAS PALAD is a multi-sectoral strategy spearheaded by the municipal government and in collaboration with different government agencies such as the Municipal Anti-Drug Abuse Council (MADAC), Peace and Order Council (POC), Philippine National Police (PNP), Bureau of Jail Management and (BJMP), Penology Municipal Health Office, Municipal Social Welfare Development Office (MSWDO), Public **Employment Service** Office (PESO), private

organizations and other stakeholders that aim to rid the town of illegal drugs and be declared a "Drug-Cleared Municipality."

According to Mayor Torres, the program is an integrated, and holistic approach to renabilitating the drug users/dependents in the locality, to help them recover and be reintegrated back to society as a normal and productive citizens.

## Barangay health workers deserve recognition arangay health workers (BHWs) play a vital

role in the country's healthcare system. They act as community organizers, educators, and primary healthcare service providers in their

community. Therefore, they are at the forefront of the delivery of healthcare services at the grassroots level. They are our frontliners in the healthcare system

Yet, the role they play is underrecognized or not recognized at all.

It was only at the height of the Covid-19 pandemic when the role BHWs played in the country's healthcare system came to the fore as most often they were the first responders in the community. They kept those on home quarantine in check and responded to their needs. And they did this even if their work was voluntary in nature and with little training or without training at all.


In 1995, Republic Act 7883 (Barangay Health Workers' Benefits and Incentives Act of 1995) was signed into law to provide benefits and incentives to BHWs. However, these benefits are subject to the decision of local health boards or the local government units

Nothing was certain.

Last month, the House of Representatives passed the Magna Carta for Barangay Health Workers (House Bill 6557), one of the priority measures of President Marcos. This is a welcome development as it gives hope that the role of BHWs will be finally recognized through concrete and guaranteed benefits they truly deserve.

And in a meeting with the Barangay Health and Wellness Partylist on Jan. 25, President Marcos pushed for the immediate passage of the Magna Carta for Barangay Health Workers in recognition of

their contributions.

Under the Magna Carta for Barangay Health Workers, a BHW is defined as a person who has undergone training under any accredited government or nongovernment organization (NGO), and who voluntarily renders primary healthcare services in the community after having been accredited to function as such by the local health board. This means they have to be trained before being accredited. This will enable them to be

better equipped in delivering healthcare services. Once enacted, the House of Representatives said accredited BHWs who actively and regularly perform their duties and responsibilities shall be entitled to the following incentives and benefits — monthly honoraria worth P3,000, hazard allowance not less than P1,000 per month, subsistence allowance for meals worth P100, and transportation allowance worth P1,000 per month.

BHWs shall also be entitled to a 20-percent discount on all items based on Section 4(a) of Republic Act 9994 (Expanded Senior Citizens Act of 2010). But the cited privileges shall not be claimed if the BHW is eligible for a higher discount as may be granted by the commercial establishment and/or other existing laws."

expenses, medicines, x-ray, and other laboratory fees, when confined in any public hospital or health institution; emergency assistance not exceeding P5,000 chargeable against the fund of the barangay concerned, for expenses incurred in the nearest private hospital or clinic in case of extreme emergency where there is no available public hospital; and mandatory and immediate membership in the Philippine Health Insurance Corporation (PhilHealth) as indirect contributors.

An accredited BHW who sustains injury or sickness in the course of the performance of their duties shall be entitled to P2,000 for every year of service as disability benefit.

BHWs shall also be granted insurance coverage and benefits from the Government Service Insurance System (GSIS) which shall be borne by the LGU concerned.

They shall also get a cash gift given every December of not less than the minimum monthly honoraria.

Under the proposed measure, a one-time gratuity cash incentive of not less than P10,000 "in recognition of the BHW's loyalty and dedication and for having They shall be entitled to the following health benefits continuously and satisfactorily served at least 15 years" — free medical care, including surgery and surgical shall be granted to the qualified BHW.

# 48 Bagwis-compliant establishments recognized in Cavite

The Department of Trade and Industry (DTI)-Cavite awarded Bagwis Certificate of Continuous Compliance to forty-eight (48) establishments in the province on Friday, January 20.



The validity of the awards was extended for three (3) years for the establishments' continuous compliance with the Bagwis parameters.

Pursuant to DAO 17-08, 2017, Series of **Implementing Guidelines** on the Grant of Bagwis Award to Business Establishments that Uphold Consumers' Rights and Interest and Practice Business Ethics, the DTI-Award Bagwis is automatically revalidated upon confirmation of the DTI Provincial Office that awardee an

establishment İS consistently complying with the Bagwis parameters within three (3) consecutive years.

Reassessment of all existing Bagwis awardees the respective in jurisdiction could be done within three years before the expiration of the award.

Also, three (3) establishments were awarded the Gold Bagwis Seal of Excellence: the SM Hypermarket Tagaytay; SM Supermarket Trece Martires, and Abenson HomePlus Kawit.

### Maabud NHS in San Nicolas, Batangas receives DOST's digital library

Students of Maabud National High School (NHS) in San Nicolas, Batangas can now access hundreds of thousands S&T information even without internet connection through the digital library called SuperSTARBOOKS they received from the Department of Science and Technology (DOST)-Batangas, Jan. 13.



SuperSTARBOOKS is the country's first digital library, designed to house thousands of digitized science and technology resources in different formats (text, video, and audio) placed inside specially created "pods" set in a user-friendly interface. It stands for Science and Technology Academic and Research-Based Openly Operated Kiosk Station (STARBOOKS), а

technology created by the Science and Technology Information Institute (DOST-STII), which has been improved and

rebranded as SuperSTARBOOKS. As a standalone information kiosk, information access through STARBOOKS is possible even without internet connection. Because it provides a compendium of S&T information gathered from all over the world, it is regarded as a one-stop S&T information source.

As part of the deployment activity, an Orientation-Training on SuperSTARBOOKS was conducted for thirty-six (36) students and nine (9) teachers of the school beneficiary facilitated by

DOST-Batangas staff, Ms. Renalee M. Leyesa and Mr. Cedric L. Rodriguez.

The discussion on SuperSTARBOOKS was delivered in a two-part structure. First part covered the introduction to **STARBOOKS** and orientation on available STARBOOKS platforms. Ms. Leyesa, presented the available platforms which participants can access during normal, new normal and better normal which include STARBOOKS Offline, Online (www.starbooks.ph), Mobile Application, Quiz Application and Geomap



Application. Tons of resources itemized as magazines, books, journals, scientific and research papers, disaster preparedness materials, interactive courseware, and K-12 supplement materials were also discussed as contents of STARBOOKS. According to the DOST-STII report, STARBOOKS' content was upgraded in 2016 to include more materials, such as full-length livelihood videos from the Technology former Resource Center, scientist DOST profiles, publications, Science: Cool Facts, significant dates in Philippine science history, and new science articles.

The second part of the

discussion focused on the site admin training for both Offline and Online STARBOOKS. Mr. Rodriguez urged the participants to become familiar with the responsibilities of the site admin which include user assistance, submission of transmittal files, uploading on the citizen's archive, updating SuperSTARBOOKS contents, and kiosk management. The roles and

responsibilities of Maabud NHS as stipulated in the provisions of the Memorandum of Agreement (MOA) were likewise covered in the discussion. As а fundamental monitoring requirement of DOST-

STII, discussion on the quarterly submission of the transmittal file was pursued. This discussion was followed by responses to the participants' questions and concerns.

Meanwhile, Maabud NHS Principal, Dr. Melani L. Higuit, expressed their gratitude to DOST for the digital library they have received. Migrant Workers Secretary Susan Ople's statement on calls for a deployment ban to Kuwait We appreciate the good intentions behind the calls to impose a deployment ban to Kuwait. But I have always believed in social dialog as the all-important first step in resolving labor migration concerns.

It does not mean we are insensitive to such calls. It only means that for now, we wish to resort to labor diplomacy to add more safeguards and ensure that justice is pursued on behalf of Jullebee and her family.

We acknowledge and appreciate the quick response of the Kuwaiti authorities. The principal

suspect was arrested less than 24 hours after Jullebee's body was discovered.

They have also extended their full assistance in facilitating the repatriation of our OFWs who have been staying at the shelter. There is a working, productive relationship between the Philippines and Kuwait that can be further enhanced not by imposing a deployment ban but by revisiting the existing Bilateral Labor Agreement (BLA).

A new BLA would additional extend protection for our OFWs. We can accomplish more to protect our workers with the cooperation of the Kuwaiti government.

The Magna Carta for Barangay Health Workers is one of the House bills under the Legislative-Executive Development Advisory Council (LEDAC) approved on third reading at the House of Representatives.

The country's BHWs played a major role at the height of the coronavirus pandemic, providing services, conducting houseto-house visits and deciding who among the population have to be sent to hospitals and isolation facilities, the President said.

They are also an important source of information for the national government in its policy decisions, Marcos said, highlighting their presence at the grassroots level.

#### **PROVINCIAL ORDINANCE NO. 372-2022**

#### AN ORDINANCE INSTITUTIONALIZING A SOLO PARENTS' DAY IN THE PROVINCE OF CAVITE

#### Introduced by: Hon. Maurito C. Sison Sponsored by: Hon. Romel R. Enriquez Co-sponsored by: All Sangguniang Panlalawigan Members

WHEREAS, Section 2 of Republic Act No.11861, otherwise known as the Expanded Solo Parents Welfare Act hereby declares that it is the policy of the State to promote a just and dynamic social order that ensures the prosperity and independence of the nation and free the people from poverty through policies that provide adequate social services, promote full employment, a rising standard of living and an improved quality of life. The State shall also promote social justice in all phases of national development, value the dignity of every human person and guarantee full respect for human rights;

**WHEREAS**, Section 21 of Republic Act No.11861 states that to commemorate the role and significance of every solo parent in the Philippines, the third week and third Saturday of April of every year are hereby declared as Solo Parents Week and National Solo Parents Day, respectively;

WHEREAS, Section 2 of Republic Act No. 9710, also known as Magna Carta of Women states that recognizing that the economic, political and sociocultural realities affect women's current condition, the State affirms the role of women in nation building and ensures the substantive equality of women and men. To realize this the State shall endeavour to develop plans,

policies, programs, measures and mechanisms to address discrimination and inequality in the economic, political, social and cultural life of women and men;

WHEREAS, according to a World Health Organization-funded study by the Department of Health and the University of the Philippines-National Institutes of Health, there are currently an estimated 14 to 15 million solo parents in the Philippines, 95% of whom are women;

**WHEREAS**, the Provincial Government of Cavite is committed to recognize and promote the substantive rights of solo parents, to take actions in order to end discrimination against them, and to empower them in this province;

**NOW, THEREFORE,** on motion of Hon. Sison, duly seconded by Hon. Enriquez and unanimously approved by the members present, be it enacted by the Sangguniang Panlalawigan of Cavite in a session duly assembled that:

**SECTION 1. SHORT TITLE.** - This Ordinance shall be known and cited as "SOLO PARENTS' DAY IN THE PROVINCE OF CAVITE".

**SECTION 2. DECLARATION OF POLICY.** It is hereby declared the policy of the Province of Cavite to provide Solo Parents the opportunity to participate fully in the mainstream of society, giving them full support for the improvement of their total wellbeing and value their dignity.

**SECTION 3. DEFINITION OF TERMS.** For purposes of this ordinance, the following terms shall mean:

(a). "Solo Parent" – shall refer to any individual who falls under any of the following categories:

1. A parent who provides sole parental care and support of the child or children due to-

1.1 Birth as a consequence of rape, even without final conviction: Provided, that the mother has the sole parental care and support of the child or children: Provided, further, that the solo parent under this category may still be considered a solo parent under any of the categories;

1.2. Parent left solo or alone with responsibility of parenthood due to death of spouse;

1.3. Parent left solo or alone with the responsibility of parenthood while the spouse is detained or is serving sentence for a criminal conviction for at least three (3) months;

1.4. Parent left solo or alone with the responsibility of parenthood due to physical and/or mental incapacity of spouse as certified by a public or private medical practitioner;

1.5. Parent left solo or alone with the responsibility of parenthood due to legal separation or de facto separation from spouse for at least six (6) months, as long as he/she is entrusted with the custody of the children;

1.6. Parent left solo or alone with the responsibility of parenthood due to declaration of nullity or annulment of marriage as decreed by a court as long as he/she is entrusted with the custody of children;

1.7. Parent left solo or alone with responsibility of parenthood due to abandonment of spouse for at least six (6) months;

2. Spouse or any family member of an Overseas Filipino Worker (OFW), or the guardian of the child or children of an OFW: Provided, that the said OFW belong to the low/semi-skilled worker category and is away from the Philippines for an uninterrupted period of twelve (12) months: Provided, further, that the OFW, his or her spouse, family member, or guardian of the child or children of an OFW falls under the requirements of this section;

3. Unmarried mother/father who has preferred to keep and rear her/his child/children instead of having others care for them or give them up to a welfare institution;

4. Any legal guardian, adoptive or foster parent who solely provides parental care and support to a child or children;

5. Any relative within the fourth (4th) civil degree of consanguinity or affinity of the parent or legal guardian who assumes parental care and support of the child or children as a result of the death, abandonment, disappearance or absence of the parents

or solo parent for at least six (6) months: Provided, That in cases of solo grandparents who are senior citizens but who have the sole parental care and support over their grandchildren who are unmarried, or unemployed and twenty-two (22) years old and below, or those twenty-two (22) years old or over but who are unable to fully take care or protect themselves from abuse, neglect, cruelty, exploitation or discrimination because of a physical or mental disability or condition, they shall be entitled to the benefits of this section; and,

6. A pregnant woman who provides solo parental care and support to her unborn child or children;

(b). "Children" – shall refer to those living with and dependent upon the solo parent for support who are unmarried, unemployed and not more twenty-two years (22) old or below, or those over twenty-two (22) old years but who are unable to fully take care or protect themselves from abuse, neglect, cruelty, exploitation, or discrimination because of physical or mental disability or conditions.

(c). "Parental responsibility" – with respect to their minor children shall refer to the rights and duties of the parents as defined in Article 220 of Executive Order No. 209, as amended, otherwise known as the "Family Code of the Philippines."

(d). "Parental Leave" – shall refer to leave benefits granted to a solo parent to enable him/her to perform parental duties and responsibilities where physical presence is required.

(e). "Flexible work schedule" – shall refer to the right granted to a solo parent employee to vary his/her arrival and departure time without affecting the core work hours as defined by the employer.

(f). "Parental care and support"- shall refer to the acts of providing for the basic needs, health care, mental and physical safety, emotional support and formation of the personality of the child.

**SECTION 4. ESTABLISHMENT OF SOLO PARENTS' DAY.** There shall be a Solo Parents' Day Celebration to be held every third Saturday of April of every year.

**SECTION 5. OBJECTIVES.** The Solo Parents' day Celebration has the following objectives:

1. To commemorate the role and significance of every solo parent in the province;

2. To discuss issues affecting solo parents and their children in their daily struggles and look for possible interventions and/or solutions, and to know their benefits provided under R.A. No. 11861;

3. To recognize their value and importance as integral part of the society;

4. To discuss and develop plans, programs and activities for effective parental responsibilities and address discrimination;

5. To invite speakers who themselves are successful solo parents to share their stories and struggles which will provide inspirations;

6. To educate them on their rights as provided under the labor laws of the Philippines such as "parental leave" and "flexible work schedule" and other updates on labor laws;

7. To update existing records of solo parents, among others; and

8. To create job opportunities, offer livelihood skills enhancement to promote sustainable income.

**SECTION 6. FUNDING.** For the effective implementation of this ordinance, the Provincial Government of Cavite shall appropriate necessary funds to defray the expenses of this activity.

**SECTION 7. MONITORING AND IMPLEMENTATION.** The Office of the Provincial Governor, thru the Provincial Social Welfare and Development Office, in coordination with Provincial Information and Community Affairs Department (PICAD), shall be mainly responsible in the effective observance and implementation of this Ordinance.

SECTION 8. REPEALING CLAUSE. Any provision of any ordinance, rules and regulations and/or part thereof inconsistent

with the provisions of this Ordinance are hereby repealed and/or modified accordingly.

**SECTION 9. APPLICABILITY CLAUSE.** The provisions of existing ordinances, resolutions or executive orders dealing with related, which are not contradictory with this Ordinance, are hereby adopted as an integral part of this Ordinance.

SECTION 10. SEPARABILITY CLAUSE. Should any portion or provision of this Ordinance be declared unconstitutional or invalid, the other parts or provisions thereof which are not affected thereby shall continue to be in full force and effect.

SECTION 11. EFFECTIVITY CLAUSE. This Ordinance shall take effect after its approval and compliance with posting and publication requirements.


