## Editorial

### Revisiting K to 12 program anew HE K to 12 program was initially seen as a

catch-up move by the Department of Education. Fully 99 percent of the countries in the world have 18 years of pre-university education, except for some countries in Africa. President Benigno Aquino 3rd and his Education secretary, Brother Armin Luistro, pushed for it to bring the Philippines into the 21st century.

But like many Philippine laws with good intentions, the problem lay with the execution. We think it was implemented rather rashly. The textbooks were not there. Only a few seminars and workshops were done to cascade the new learning curricula and protocols down the line, from the regional and provincial capitals to the barrio schools. And the teachers, already overworked and underpaid, had to scrounge around for materials that would connect the dots in the syllabi that came from Manila.

Now, there is a clamor again to revisit the K to 12 program. The latest proposal has come from former president and now Senior Deputy House Speaker and Pampanga Rep. Gloria Macapagal Arroyo. She wants to make Grades 11 and 12 mandatory only for those who wish to pursue higher education. It seems like a logical throwback to the National College Entrance Examination (NCEE) of the late 1970s and early 1980s. Those who scored high in the NCEE naturally got into the good schools, while those who lagged behind fell into the cracks and took technical and vocational

Arroyo's K to 10 Plus Two bill seeks to return the basic education system to its previous setup, with students considered as high school graduates after completing kindergarten, six years of elementary school, and four years of secondary school. Grades 11 and 12, currently known as senior high school (SHS), would be required only for those pursuing a college degree.

A similar proposal came from Vice President and concurrent Education Secretary Sara Duterte when she called for a revamp of the K to 12 curriculum. She made the call in her Basic Education Report in January this year to make the program "relevant to produce competent, job-ready, active and responsible citizens." We already analyzed the pros and cons of her proposal in an editorial last January.

Because K to 12 was implemented rashly with not enough learning materials to operationalize it, the products were naturally half-baked. A study by the Philippine Business for Education showed that only 14 out of 70 of the country's leading companies would hire SHS graduates. Most companies still prefer applicants with a college degree, something that is not surprising in a degree-oriented country like the Philippines.

Moreover, a study made by the Philippine Institute for Development Studies in 2020 indicated that 70 percent of SHS graduates went on to get a bachelor's degree. Only a little over 20 percent of these graduates entered the labor force.

Parents — and now, lawmakers — have seen the additional two years of SHS as a financial burden, with almost fruitless results. Arroyo wants to strengthen the technical, vocational and livelihood (TVL) track in SHS.

The agency's 2021-2022 data shows that only 28.93 percent of SHS chose the TVL track, while over 70percent went for the academic track.

The K to 12 program was overpromised but underdelivered. Aside from scant learning materials, the K to 12 curriculum itself is "congested" with too many subjects seven subjects for Grade 3 students. Thailand began to improve in the education arena when it strengthened its K to 12 program with laboratories, computers, and teachers well-trained in critical thinking and 21st-century technological skills. The learning methods are also evidence-based and consulted experts with scientific data borne of research.

Likewise, Singapore boosted its K to 12 program by funding its state schools and giving subsidies to private schools. It also encouraged the production of wellwritten textbooks, workbooks and teacher's guides. Teacher training was done, e-learning was boosted, and regular monitoring and evaluation of students' learning were implemented, with eyes focused on a set of metrics as goals.

On the issue of lack of funds to do all of these, perhaps the Department of Education can realign its huge intelligence funds for this. The intelligence of our students matters more than the dubious intention of an intelligence fund at the DepEd.

"In the case of Panay Island, NGCP's protection systems, which were communicated and coordinated with its grid connected customers from both the generation and distribution sides, functioned as intended," the company explained. "As we explained to Congress yesterday, only the consumers connected to the line that tripped should have been disengaged from the grid. It was unfortunate that a power plant disengaged from the transmission system unexpectedly," explained the company. "This response from the generating unit is both unexpected and undesirable.

resulting The undervoltage and underfrequency was severe and unrecoverable, and was the direct cause of the tripping of other power plants connected to the system, and ultimately, the Panay sub-grid collapse," NGCP said.

The subsequent trippings that occurred on 28 and 29 April 2023 were a direct result of the avoidable events of 27 April 2023.

With regard to the Luzon red alert, NGCP's initial investigation on the sequence of events on 08 May 2023, shows the tripping of Bolo-Masinloc 230kV Line 2. This line is N-1, or operates with a redundancy. The load carried by Line 2 when it tripped was automatically transferred to Line 1. Each of Lines 1 or 2 is more than capable to singularly carry the entire loading of the Bolo-Masinloc 230kV facility at any time. "It should have ended there. Similarly, there was an unexpected and undesired response from generating plant which tipped the balance of supply and demand, and a red alert was raised," NGCP said.

NGCP notes that prior to the occurrence of the faults, unplanned outages of plants and the deration of other plants contributed

to the situation. These unplanned outages are outside of the Grid Operating and Maintenance Program planned well ahead and coordinated by NGCP with the power plants and approved by Department of Energy.

On its part, NGCP commits to complete several large transmission projects within the next few months to help strengthen transmission system and better support the power system.

"We continue to advocate for a holistic approach to power planning. Development in all sectors involved in the power industry must be coordinated, with due attention given to each. support We Department of Energy in all its efforts, and we are confident of its continued support to all sectors," the company said.

NGCP assures the public and its stakeholders that it is exerting all efforts to implement all necessary solutions to prevent any similar grid incident.

Reports had that the Food and Drug Administration (FDA) will approve only the manufacture of cannabis as medicines if the plants were imported. Among the ailments said to be cured by marijuana medicines include depression, epilepsy, Alzheimer's disease, sleep disorder, anxiety, among others.

Other medical experts lamented that FDA had approved ahead the use of acupuncture, a Chinese traditional treatment of disorders by inserting needles into the skin at points where the flow of energy is thought to be blocked meridians.

At the forum with broadcast veteran journalists Rolando "Lakay" Gonzalo and Edwin Eusebio as moderators, one of the quests was UERM Memorial Medical Center, Inc. associate professor

Dr. Macgerald Cueto, who said that his group of acupuncturists had served some communities with the authority of the Department of Health (DÖH) and many had benefitted in their process of treatment.

According to Cueto, acupuncture can help in the treatment of chronic headaches. pain, migraine, erectal dysfunction, among other ailments.

The doctor though revealed the "risk" of using acupuncture in some rare cases like the possibility of bleeding and swelling of body parts pricked by needles. There is also the possibility of contracting infection if needles used unsterilized or will malfunction or unintentionally cut needles. The process should only be entrusted to certified acupuncturists.

On the other hand, medical cannabis has the features that can treat many ailments and has 500 turpins and cannabinoids in one plant alone, said Gomez. The Bauertek Corp. facility is more than ready to process the cannabis plant to turn it into a medical tablet and medical oil.

The research, manufacturing development company process the marijuana to treat various medical ailments.

Scientists as well as medical doctors have long pushed for the legalization of the use of medical marijuana, especially that the same has been used by our forefathers in the treatment of various ailments long time ago.

Dr. Gomez said that once the bills on medical cannabis are enacted into law, his facility is more than ready to process the medical cannabis plant. This, in turn, can be planted with other herbs for food supplement, being which are manufactured Bauertek Corp.

Gomez said that the medical cannabis can be planted in different places in the Philippines. "Millions can benefit from this, farmers or planters can be helped and this can be an income-generating opportunity as this can be exported."

#### Red Cross duns PhilHealth for arrears

After settling at least P5.5 billion in arrears, Philippine Health Insurance Corp. (PhilHealth) still has an outstanding obligation of some P380 million to the Philippine Red Cross (PRC) for the administration of COVID-19 tests during the pandemic.

PRC Chair Richard Gordon on Wednesday said that the humanitarian organization is also exploring legal actions against the state insurer over the unpaid amount.

In a text message to the Inquirer, PhilHealth executive vice president and chief operating officer Eli Santos said the state insurer has yet to confirm the supposed arrears pending discussions with PRC officials. —KATHLEEN DE VILLA
