# Promoting women's rights and gender equality ilipino culture and tradition has always been partial to women giving them due respect

partial to women, giving them due respect and conservative deference especially in social events and public places.

For decades, this traditional courtesy and caring for Filipino women has been with us, but it was only in 2009 that the government passed a law, Republic Act 9710, the Magna Carta of Women, which formally included in the nation's jurisprudence the government's policy of affirming the role of women in nation building, thus ensuring the substantive equality of men and women.

In its declaration of policy, the law says the state shall promote the empowerment of women and pursue equal opportunities for women and men and ensure equal access to resources and to development results and outcome.

Also, the state realizes that equality of men and women entails the abolition of the unequal structures and practices that perpetuate discrimination and inequality.

The Magna Carta of Women, passed during the term of former President Gloria Macapagal Arroyo, promotes a gender-conscious society that touts women empowerment and fights discrimination against women. As such, this piece of legislation is an important item in the list of the nation's human rights legislations.

Lately, the Department of the Interior and Local Government (DILG) prodded all local government units (LGUs) nationwide to establish programs promoting women's rights and gender equality in their respective localities as mandated by RA 9710.

"As active agents of the government in promoting gender equality, our LGUs must ensure the localization of the Magna Carta of Women to ensure that women



empowerment is recognized and mainstreamed in all sectors," DILG Secretary Benjamin Abalos, Jr. said. He assured that the DILG will continuously exert various interventions to ensure that women's rights are protected

He cited the pilot run of the DILG Gender and Development (GAD) Seal Certification Program where the GAD Seal is presented to the agency's offices that adhere to the advocacy of promoting policies in ensuring that women's rights are enforced.

The GAD Seal program is intended to put a premium on the gender mainstreaming efforts implemented and adopted by the DILG regional offices making them gender-responsive. The secretary wants to transform the DILG into a GAD-centered organization promoting gender equality and development with social inclusion, reflecting the department's commitment to creating a more equitable and inclusive society for all.

The DILG chief also recognized the important role that women play in the use of digital technology that enhances economic development and improves the delivery of government service to the public.

The idea behind the GAD Seal program came to Abalos when he, together with Vice President Sara Duterte and Senator Imee Marcos, attended the recently concluded 18th General Assembly of the Philippine Federation of Local Council of Women

The program started to gain traction in the DILG even in the first week of its implementation which encouraged the secretary to roll out the program outside the DILG, particularly the local government units and other government offices that provide primacy to women's rights. This is a welcome development in the field of governance that we wanted to see and monitor in the near future.

# DOST, PNP, and LGU join forces to bring Solar-Powered Water Pump Systems to Remote Communities

The Department of Science and Technology (DOST) Region 02's Community Empowerment through Science and Technology (CEST) program has established a solar-powered water pump system in Sitio Dilukot, Burgos, San Guillermo, Isabela.

The project, which caters to over 176 households, was funded through the community empowerment initiative of the DOST that aims to empower and uplift vulnerable groups including the marginalized sectors through science and technology.

Sitio Dilukot is known to be a conflict-affected community and its geographical location makes it inaccessible to rural areas. The water pump system is located far from rural areas requiring residents to rely on an alternative method: a walk or a cart driven by carabaos. This challenging journey highlighted the dire need for an improved water supply solution in

However, through the CEST program, the DOST02 was able to provide an alternative source of clean water to the community, improving their quality of life and eliminating the need for long walks to fetch water.

The solar-powered water pump system was made possible through the partnership of various agencies, including the Philippine National Police (PNP) and the Local Guillermo, Isabela.

Furthermore, the project aligns with the Sustainable Development Goals (SDG) and places a gender lens on the community, ensuring that men

# SWS: 45% of Pinoys optimistic life will get better in next 12 months

IN its March 26 to 29 survey, the Social Weather Station (SWS) survey shows fewer Filipinos expect their quality of life to improve in the next 12 months.

ne survey found that 45 percent of the respondents were optimistic that their life will get better within a

The latest figure is lower by 4 points from 49 percent obtained in the same survey held in December 2022.

The survey also reveals that 42 percent of the respondents believe that

life will remain the same, 6 percent predict it will get worse. while remaining 7 percent did not give an answer.

SWS said that the net personal optimism between December 2022 to March 2023 has decreased in all areas, specifically:

Metro Manila: +49 to +45 Balance Luzon (areas outside of Metro Manila):

+43 to +37Visayas: +37 to +27. Mindanao: +48 to +47

The poll was conducted face-to-face using interviews of 1,200 adults nationwide.

It has a sampling margin of error of ±2.8% for national percentages, ±5.7% each for Metro Manila, Balance Luzon, the Visayas, and Mindanao. / LOD BELTRAN

#### Drug suspect nabbed in buy-bust operation by Imus DEU

IMUS City police Drug Enforcement Unit (DEU) operatives arrested and jailed a 42-year old parking boy who was on the list of wanted illegal drug pusher during a successful buy bust operation at Barangay Palico 4, this City on Wednesday, June 21, this city.

Imus Component City police director, Lt. Colonel Michael Batoctoy identified the suspect as "Ar-Ar", a resident of Brgy, Panapaan

7, Bacoor City.
The operation was part of the PNP's revitalized Double-Barrel Finale version 2022, also known as Anti-Illegal Drugs Operation through Reinforcement Education (ADORE), Batoctoy said in his report to Cavite Provincial Police Director, Colonel Christopher Olazo who congratulated the DEU operations which resulted in the arrest of alias "Ar-Ar.'

Reports showed that

"Ar-Ar" was Alias arrested after selling one (1) piece of heat sealed transparent plastic sachet containing suspected "shabu" worth Php 300 to police officer who acted as poseur buyer.

NGCP also implemented its power transformer replacements to update old and aging transformers installed prior to the privatization of the transmission grid. From 2018 to 2021, NGCP replaced 33 power transformers improved the efficiency and reliability of substation operations.

Twelve transformers were replaced in North Luzon, 4 in NCR, 5 in South Luzon, 3 in Visayas, and 9 in Mindanao with a total equipment cost of US\$37.7 Million or PhP1.8 Billion. Besides this, 14 spare power transformers worth US\$14.6 Million or PhP764 Million were also delivered to 6 substations in North Luzon, 5 in South Luzon, 1 in Visayas, and 2 in Mindanao.



# SALT CAN OPEN UP OPPORTUNITIES FOR LIVELIHOOD IN COASTAL COMMUNITIES

The efforts by the Marcos administration to create more jobs for Filipinos started to pay off after the country recorded a drop in unemployment rate to 4.5 percent in April 2023, from 5.7 percent in the same month last year.

In its April 2023 Labor Force Survey, the Philippine Statistics Authority (PSA) reported that in terms of level, the number of unemployed persons in April 2023 was estimated at 2.26 million, indicating a decline of 506.20 thousand from the 2.76 million unemployed persons in April last year.

The country's April 2023 employment rate was posted at 95.5 percent, which is higher than the estimates in April 2022 (94.3 percent) and January 2023 (95.2 percent).

In terms of magnitude, the number of employed persons rose to 48.06 million in April 2023, from 45.63 million in the same period of 2022.

According to the PSA, the number of employed persons in April 2023 was also higher than the reported 47.35 million employed persons in January 2023.

PSA data also showed the Labor Force Participation Rate (LFPR) has increased to 65.1 percent in April 2023 or about 50.31 million Filipinos aged 15 years old and over who were either employed or unemployed.

The reported LFPR in April 2023 was also higher than the reported rate of 63.4 percent in April 2022 and 64.5 percent in January 2023.

LFPR among males (75.4 percent) was higher compared to females (54.7 percent) although employment rate was higher among females at 96.0 percent than their male counterparts at 95.2 percent.

The PSA also reported that the underemployment rate among males was higher (14.6 percent) than for females (10.6 percent). Unemployment rate for males was registered at 4.8 percent of the 29.27 million males in the labor force, while 4.0 percent of the 21.04 million females in the labor force were unemployed in April 2023.

The services sector continued to dominate the labor market having the largest share of employed persons of about 61.1 percent of the total employed persons in April 2023, the PSA said.

The statistics agency also reported that the year-on-year gain in employment was driven by the services sector.

The agriculture and the industry sectors accounted for 21.9 percent and 17.0 percent, respectively.

The top five sub-sectors with the highest increase on the number of employed persons from April 2022 to April 2023 include wholesale and retail trade; repair of motor vehicles and motorcycles (914,000); accommodation and food service activities (379,000); administrative and support service activities (345,000); transportation and storage (321,000); and other service activities (242,000). | **PND**



To ensure the power grid's optimal performance, transmission service provider NGCP continues to upgrade its substation facilities nationwide through its ongoing substation reliability projects. These improvements introduced by NGCP are filed with the Energy Regulatory Commission (ERC).

Many of these projects were implemented from 2016 onwards but have not yet received ERC's provisional approval. Given the ional need. NGCP proceeded with the implementation of these projects, setting aside

for later, the issue on recovery approvals from the ERC. "Our priority has and will always be doing what is best for the public.

Financial considerations can take a back seat and be threshed out later," the

company stressed. "We hope to correct the impression that the consumers are somehow shortchanged with how rates are computed. Our commitment has never wavered: we serve the public, and we work within the legal and regulatory framework of our concession and franchise," NGCP emphasized.

Since taking over transmission operations in 2009, NGCP invested PhP3.289 Billion in upgrades across 15 of its substations and converter stations in Taytay, Binan, Quezon, Abaga, Mexico, San Jose, Sucat, Compostela, Davao, Ormoc, Naga, Araneta, Agus 2, Calaca, Agus 6, and Tiwi A and C. These improvements cater to the increasing load growth and reliability of the system.
