President Marcos to ease entry requirements

in energy sector
he country's power supply woes may soon
ease as President Ferdinand R. Marcos Jr. has vowed to further improve the bureaucratic processes, particularly in the energy sector, to attract more investors.

While we already have Republic Act 11032 (Ease of Doing Business Act of 2018), a law that cuts bureaucratic red tape and is serving as an incentive to investors, President Marcos has promised to further ease the process for the energy sector in a bid to address the perennial power supply problem confronting the country.

The chief executive gave this commitment at the inauguration of the 24.9-megawatt Lake Mainit Hydro Power Plant (LMHPP) in Jabonga, Agusan del Norte on July 12, 2023

By further easing the bureaucratic processes, President Marcos is hopeful this would attract more businessmen, both local and foreign, to invest in the country's energy sector.

"Let this inauguration serve as an encouragement to potential investors to invest in the country, especially in the power generation and the renewable energy sector. I call once again on our private sector partners to join us as we realize our goal of advancing affordable, reliable, and clean energy for the benefit of our people," President Marcos, who has been espousing the use of renewable energy, said at the LMHPP inauguration.

If the country—by further easing bureaucratic processes—succeeds in attracting companies to invest in the power sector, particularly renewable energy, President Marcos would be hitting two birds with one stone. He would be easing, if not solving, the power problem and at the same time help in conserving the environment through clean energy



With climate change now a global problem, it is necessary to encourage the shift to sustainable or renewable energy to prevent its catastrophic effect.

According to the United Nations, clean sources of energy, such as wind and solar, help address not only climate change but also air pollution and health. In 2018, air pollution from fossil fuels caused \$2.9 trillion in health and economic costs, about \$8 billion a day.

As a Canadian-American actress and social activist

puts it, "Clean energy is about offering people the opportunity to do what's right for themselves and the people they love. It's about reducing the pollution that makes people sick. It's about helping low-income families struggling to pay their gas and electricity bills."

Let's do it right for our future. We express hope that the honorable men and women of Congress will fully support President Marcos' objective of further easing bureaucratic processes to attract investors in renewable energy.

Sipag at Sigasig Farmer's Association participates in Bamboo Propagation Training Bamboo is a common plant found in all parts of the country. In order to promote its uses, the

Department of Science and Technology (DOST)-Laguna, in cooperation with the Department of Environment and Natural Resources-Ecosystems Research and Development Bureau (DENR-ERDB), conducted a training on Bamboo Propagation and its benefits for the members of the Sipag at Sigasig Farmer's Association last July 6, 2023, at Brgy. San Mateo, San Pablo, Laguna.

Mr. Angelito B. Exconde, the resource speaker, works as a Board Director at the ERDB Multi-purpose Cooperative and a Supervisor at the Los **Baños Experiment Station** (LBES) of ERDB. He has various work experiences in the National Greening Program of DENR and is a Master of Science in Forestry specializing in economics, agroforestry, and social forestry.

Mr. Exconde discussed predominant challenges faced by the bamboo industry in the Philippines. One challenge he discussed was the need for more bamboo planting materials and that onenode and branch cuttings are the current methods widely used in the country

"The one-node cutting is expensive because the whole is cut to obtain onenode propagules and the number of propagules that can be obtained from a pole is rather limited," Mr. Exconde stated. He added that tissue culture is the most efficient method, but our country is still in its pilot testing stage.

As a guide for the



bamboo farmers on bamboo's proper growth and development stages, Mr. Exconde then showed a list of indicators to know if the bamboo is growing healthy and the step-bystep process of the onenode cutting method and traditional tools used in

bamboo propagation such as chainsaw, handsaw, scythe, and pruning shear.

Mr. Exconde remarked, "May mga bagay tayong hindi pinapansin sa paligid na hindi natin alam ay napakarami palang kagamitan sa ating buhay." He encouraged all

participants to explore the different programs DOST offers to help them improve their respective farming business and lives. DOST-Laguna staff then gave the speaker a certificate of appreciation. (By: Jherome L. Lusterio)

The President said former Public Works and Highways secretary Rogelio Singson will also assist the government in addressing the problem.

According to the President, Singson, a water management expert, will help the government in coming up with a contingency plan for El Niño and in crafting an overall plan for the Philippines.

The country has to convert its water usage from ground water or wells and aquifers to surface water, Marcos pointed out.

"Because we have enough surface water. It's just a question of protecting it. We are designing now a system of catchment basins not only for flood control. The original plan was only for flood control.

But now, we have said we have to... that flood control always now includes irrigation and sometimes even power, if we can do it," Marcos said.

In terms of water supply for agricultural use, the President said the National Irrigation Administration (NIA) has a design for existing dams to ensure

The President also said the hot and humid weather being felt today is not vet the onset of El Niño.

"We haven't felt people think that this is El Niño but we haven't felt the effects of the El Niño. In some areas pero sa ngayon hindi pa talaga 'yan," Marcos said. "We have a plan. So we are making sure that we will be ready when that time comes."

The President said previously that the government was relying on a newly-created Office of Water Management in addressing the impact of a prolonged dry spell or El Niño. | **PND**



enhancing the physical and well-being of all court officials and employees and reinforce ethical responsibility.

In the SPJI, it that underscores Innovation would include introduction of new paradigms and concepts, like the first-ever regionalized and digitalized conduct of the bar examinations during the coronavirus pandemic and the bench books on family courts and commercial courts.

To achieve Access, the SC has continued its efforts to bring judicial services closer to the public.

Justices zones were created in many urban cities in Metro Manila, Davao Region, Western Visayas, Central Luzon and Calabarzon.

The has implemented a program of active coordination among the prosecution, the courts and the corrections system, in order to ensure a faster disposition of cases

Also, the SC has permitted the conduct of virtual conferencing of hearings of criminal cases to lessen congestion of cases in several courts.

In a report from the Office of the Court Administrator (OCA), it said that during the Covid-19 pandemic, some 27,000 courts in the country have conducted an estimated 170,000 hearings via teleconferencing

The OCA further reported that through virtual hearings, around 81,000 persons deprived of liberty (PDL) were released incarceration.

Electronic filing of complaints and petition for bail; e-payments of fees were permitted to speed up resolutions of pending cases which resulted to access to judicial processes.

In the SPJI, the use and adaption of digital transformation considered a factor in the target result of the strategic innovations by the highest court of the land.

The creation and development of a digital platform is envisioned to enable judges and court clerks to conduct research on a computerized database.

Likewise, a creation of a public information will surely enhance the public access to publication of cases in the court system.

In conclusion, the SPJI was launched to realize the goal of rendering equal access to justice in real time with efficiency and access to fair disposition of justice to all.

In the words of Chief Alexander Justice Gesmundo, the realization of the objectives of the SPJI is imperative in ensuring the attainment of the goal to "remold and transform the courts into consistently efficient and accountable havens for the disadvantaged, wronged, and the injured."
