

# eLGU and eReport: Harnessing tech to enhance local

**governance** epublic Act No. 7160, or the Local Government Code of 1991, has granted local government units (LGUs) the authority to govern their respective territories with legislative, executive, and fiscal autonomy, empowering them to enact ordinances, manage wealth and resources, and provide essential public services. As LGUs are often the first point of contact between citizens and the government for various permits, clearances, and taxes, there is a need for efficient and responsive local governance.

Recognizing the pivotal role of LGUs in driving meaningful change in the country, the Marcos administration has been committed to strengthening their capacities. The administration believes that no meaningful change will happen if it doesn't start from the bottom — no matter how intensive the national government's efforts are to uplift the lives of Filipinos, without the full support and cooperation from LGUs,

these initiatives risk becoming an exercise in futility. This is the reason why this administration is moving toward automation via two mobile apps that were launched early this week in Malacañang. Demonstrating seriousness and urgency, the President himself unveiled these two mobile apps: the Electronic Local Government Unit (eLGU) System and the People's Feedback Mechanism (eReport). These apps are meant to harness the power of technology to make public service better and make crime reporting easier.

"With the power of technology, we can break barriers and bridge gaps in ways that we have never been able to do before," the President said. Supported by officials from the Department of





Information and Communications Technology (DICT) headed by Secretary John Ivan Uy, and the Department of the Interior and Local Government (DILG) led by Secretary Benhur Abalos, the apps' launch signifies a "paradigm shift in delivering public service toward building a more efficient, transparent, and citizencentered governance system."

"The eLGU app is a step closer to realizing the vision of digitalization in the local governments while the eReport will serve as an avenue for people to report criminalities, fire incidents, and emergencies," Abalos said.

The eLGU "covers a wide range of local government services such as business permit licensing, notice of violations, notification system, community tax, health certificates, local civil registry, business tax and real property tax." The eReport, on the other hand, is "interoperable and linked with the Philippine National Police's (PNP) iReport, which is a Crime Response Management System and the Bureau of Fire Protection's (BFP) Fire Response Management System. This allows citizens to voice real-time reports through their mobile devices."

"In line with the priority of President Marcos on the realization of government processes to enhance economic competitiveness, we see the eLGU and eReport System as among the complete steps in realizing the strategies laid out in the Philippine Development Plan," Abalos said. "By taking advantage of new technologies, we open doors to boundless possibilities, promote transparency, and engage our communities toward more opportunities and progress."

As we embrace the advantages of digital adaptation, looking back — or staying still — is no longer an option. Progress demands that we move forward, harnessing the best available technology, and ensuring its accessibility to all citizens. With the eLGU and eReport apps leading the way, we should expect a government that eases our lives, rather than one that further burdens us with more bureaucracy.

E-Nutribun has more micronutrients like iron and vitamin A. The texture is

There, they built villas, hospitals, tennis courts, swimming pools, postal offices and many other facilities, and established a deep bond with local residents.

Recently, Kuliang welcomed many old friends from the United States attending the "Bond with Kuliang: 2023 China-U.S. People-to-People Friendship Forum." Some of them spent their childhood in Kuliang with their parents, and some boast close relations with the Chinese small town through their families. Kuliang is like a bond that connects them with China.

Chinese President Xi Jinping sent а congratulatory letter to the forum. "I was very glad to hear from members of the Kuliang Friends, and to know from your letter more touching stories about your connection with Kuliang," said Xi in the letter.

In 1901, U.S. citizen Milton Gardner came to Fuzhou as an infant with his parents and stayed until his family moved back to the United States in 1911. Gardner had been longing for revisiting his childhood home, but had never been able to make his wish fulfilled before passing away.

He showed to People's Daily a photo album kept by his family, which records the deep bond between the Gardners and Kuliang. He said the album is the most valuable treasure of his family and would be presented to the Chinese people as a gift this time he came to Kuliang.

Gail Harris, who once lived in Kuliang as a child, said in Fuzhou dialect "I'm home" as she once again set foot on the land of

Kuliang for the forum. Her grandfather Harry Russell Caldwell was an expert on the ecological environment of Fujian province and compiled South China Birds, a book studying bird populations in Kuliang. It's one of the earliest modern scientific works recording China's bird species.

Harris noted that Caldwell loved China and the Chinese people, and now his grandchildren have also fallen in love with this country, adding that she very much misses and loves the time she spent in China.

This time, Harris met her childhood friend Li Yiying. They sat down and exchanged slowly, word by word, in Fuzhou dialect. The two friends greeted each other, with hands clasped together.

Harris said that she hopes the bond in Kuliang could be passed down from generation to generation, so that love and friendship will live on forever.

Octogenarian Priscilla Brewster Gill came to attend the forum accompanied by her granddaughter Katy Barber, recalling the old streets and alleys she remembered from her childhood. China is the hometown where her

Gill lived in China for 12 years and used to help her father take care of patients. She recalled her childhood when she fell down and got hurt, the local villagers would also help her with her wounds. She and the locals were like families, Gill said.

Elyn MacInnis, 72, is a senior advisor of the Kuliang tourism and culture research association. Her husband Peter MacInnis was born in Fuzhou, and her father-in-law Donald MacInnis was once a member of the Flying Tigers, a group of volunteer American volunteer pilots who came to China and stood shoulder to shoulder with the Chinese people to fight the Japanese invasion.

Over the years, the woman has been committed to spreading the Kuliang story. In 2016, she set up an English website

about Kuliang and its history and established the group "Kuliang Friends" in the United States. Today, the group Lee Gardner holds a photo album that an important force driving non-

governmental friendly exchanges between China and the United States.


Amity between the people holds the key to sound state-to-state relations. The Kuliang story is a great example of the people-to-people friendship between China and the United States.

Although the two countries are currently facing difficulties and challenges in their relations, they are in dire need of enhancing people-to-people exchanges.





# MALACAÑANG ANNOUNCES **BRAWNER AS NEXT AFP CHIEF**

Malacañang, through the Presidential Communications Office, announced on Wednesday that Lieutenant General Romeo Brawner will be the next Chief of Staff of the Armed Forces of the Philippines and will take the place of General Andres Centino who was re-appointed by President Ferdinand Marcos Jr. to the said post earlier this year.



Centino will be appointed as Presidential Adviser on the West Philippine Sea. LtGen Brawner is currently serving as Commanding General of the Philippine Army, which he assumed on December 10, 2021. He graduated number two (2) in the Philippine Military Academy "Makatao" Class of 1989 and has since served the military in various capacities for 34 years now.

Among his previous designations in the military were: Company Commander of the 6th Special Forces Company; Battalion Commander of the 2nd Special Forces Battalion; Operations Officer of the Special Forces Regiment (Airborne); Chief of Staff of the 6th Infantry "Kampilan" Division; Chief, Public Affairs of the Philippine Army; Spokesperson of the Armed Forces of the Philippines; Commander of the Civil-Military Operations Regiment; and, Brigade Commander of the 103rd Infantry Brigade during the aftermath of the Marawi Siege in 2017.

LtGen Brawner also previously served as the Commandant of the Cadets in the Philippine Military Academy, where he played an important role in the total eradication of hazing and maltreatment in the Cadet Corps. Later on, he served as the first Deputy Chief of Staff for Financial Management, J10, Armed Forces of the Philippines.

He also served as the Commander of the 4th Infantry "Diamond" Division, where he supervised the unit's combat operations that resulted to the decisive neutralization of Jorge Madlos or "Ka Oris," the Commander of the National Operations Command of the New People's Army.

He exemplified the highest levels of excellence in his military schoolings, topping his classes in the Special Forces Operations Course, Intelligence Officer Course, and the AFP Comptrollership Course.

LtGen Brawner has acquired three (3) Master's Degrees: Master's in Information Management from the Ateneo de Manila University; Master's in Business Administration from the Asian Institute of Technology in Thailand and from the European School of Management, Oxford, United Kingdom; and, Master's in Strategic Studies from the United States Army War College (USAWC).

Among the numerous awards and recognitions he received were: The Outstanding Philippine Soldiers (TOPS) in 2013 by the Metrobank Foundation and Rotary Club of Makati, and the Lapu-Lapu Award by President Rodrigo Roa Duterte for his valuable contributions in the neutralization of Abu Dar, the last of the original leaders of the Maute-ISIS faction.

In March this year, LtGen Brawner was inducted into the US Army War College (UASWC) International Fellows Hall of Fame in recognition of his service at the highest command position in the Philippine Army.
