even years after the Permanent Court of Arbitration in the Hague ruled in favor of the Philippines in its dispute with China on the West Philippine Sea, Filipinos were asked recently by OCTA Research on the top three measures they believe the administration of President Ferdinand R. Marcos, Jr. should prioritize in resolving conflicts in the disputed waters.

The top preference was diplomacy or other peaceful means, according to 70 percent of the 1,200 survey respondents. Yet, the second preference was for the country to assert its territorial rights by military action, which was cited by at least two-thirds of Filipinos, regardless of economic class. In fact, 71 percent, 69 percent, and 68 percent of those in the National Capital Region, Balance Luzon, and Visayas, respectively, also mentioned military action.

Finally – and this jives with the stated preference for military action – the third measure that most Filipinos want to take is increased defense spending that will enable the Armed Forces of the Philippines (AFP) and the Philippine Coast Guard (PCG) to capably

protect the country's territorial waters.

This comes on the heels of efforts to resupply the BRP Sierra Madre, grounded in Ayungin Shoal since 1999, that has served as an outpost manned by the Philippine Navy and Philippine Marines. The first recorded intervention by the Chinese Coast Guard on the resupply of this vessel was in March 2014, an action that was promptly protested by the Philippines'

Department of Foreign Affairs.

Video footage taken by the PCG showed the deployment of water cannons against one of its vessels assigned to resupply last Aug. 5

On the Chinese embassy's claim that there was a previous "agreement" by the Philippines to remove the BRP Sierra Madre, President Marcos, who as Chief Executive is the chief architect of the country's foreign policy, has declared that "if there does exist such an agreement, I rescind that agreement now.

Days before the recent water cannon incident, the Philippine Senate unanimously passed a Resolution that directs the DFA to undertake a series of diplomatic

actions to call attention to the harassment of Filipino fishermen in violation of the Hague Ruling and the United Nations Convention on the Law of the Sea. It also calls on the DFA to file a resolution with the UN General Assembly "to call for the cessation of all activities that harass Philippine vessels and violate the Philippines established rights in the West Philippine Sea."

Since The Hague arbitral tribunal ruled in favor of the Philippines in July 2016, more than 40 countries have "voiced support for the arbitral proceedings," acknowledging its findings as "legally binding," according to the Asia Maritime Transparency Initiative (AMTI). This includes the European Union and the top countries in the global transparency index.

Evidently, Filipinos support the principle that a self reliant defense capability complements the skillful use of rules-based diplomacy in dispute resolution.

MapX is a complete real property mapping and assessment solution that advanced geoinformatics technologies. Use of the system will enable LGU Oroquieta City, through its City Assessor's Office, to conveniently analyze and create maps of real property units (RPUs). The purpose of MapX is to improve tax mapping processes that could result in the increase in RPT collection thereby boosting the city's revenue.

The MapX also includes a web-based parcellary mapping, map overlays, patiai analysis tools, dashboard and visualization tools, and application programming interface. The project also covers training and technical support for the use of the system.

"The improvement of tax mapping operations through MapX is only the first project for Oroquieta City under DOST's Smart and Sustainable

Communities Program. Through this project, we are hopeful that this would help fuel the realization of the city's thrust of becoming an economically sustainable city. 

Throughout the project, MPTC and SMC will work closely with the Philippine government, local communities, and stakeholders to ensure a sustainable and responsible development that aligns with the country's infrastructure goals.

"Our shared commitment to nation-building has led us to this historic collaboration. Together, we aim to deliver world-class road networks that will serve as arteries of progress,

growth and development for our country and the Filipino people. This collaboration stands as a testament to what we can achieve when we are united in purpose," SMC President and CEO Ramon S. Ang said.

"Together with SMC, we envisage a future where our CBEX and NBEX can help pave the way for connectivity and economic growth in **ČALABARZON** region. Under the agreement, MPTC and SMC will jointly undertake the construction, operation and maintenance of the 88-kilometer-long

toll road projects. This will encompass two vital expressways: one is the 27.06-kilometer CBEX that will establish a crucial link connecting CALAX' Silang (Aguinaldo) Interchange to Nasugbu, Batangas, while the 60.90-kilometer NBEX will provide seamless connectivity from Nasugbu to Bauan, Batangas. The groundbreaking scheduled for 2024 and CBEX and NBEX are expected to be completed and open to the public in 2027.

The route will traverse the townships of Silang, Amadeo, Tagaytay, Indang, Mendez, and Alfonso in Cavite before crossing into Nasugbu and finally reaching Bauan, Batangas.

In 2018, MPTC presented a proposal for the 50.4-kilometer Cavite-Tagaytay-Batangas Expressway (CTBEX)

With this, starting midnight on August 21, 2023, CAVITEX motorists traveling from MIAA Exit to Longos, Bacoor (and vice versa) would be charged the following VAT-inclusive rates per vehicle class at the Parañaque Toll Plaza: Php 35.00 for Class 1, Php 70.00 for Class 2, and Php 104.00 for Class 3. Meanwhile, motorists traversing Longos, Bacoor to Kawit (and vice versa) would be charged at the Kawit Toll Plaza with Php

73.00 for Class 1, Php

146.00 for Class 2, and

Php 219.00 for Class 3. Through the years, CIC and PRA remain dedicated enhancing maintaining the CAVITEX, continuously striving to provide a seamless and safe travel experience for all motorists. literacy and mobile x-ray were also made available as part of the celebration.

DOH Assistant Secretary Dr. Beverly Lorraine C. Ho said the DOH continues to promote the health and wellness of Filipinos by giving them information and knowledge on healthrelated issues to achieve a "Maligayang Body for every Filipino.'

"We continue to pursue the goal of ensuring that all Filipinos have access to timely and relevant health



CAVITEX TO IMPLEMENT NEW TOLL RATES EFFECTIVE AUGUST 21

The Toll Regulatory Board (TRB), the government agency that regulates all toll roads in the Philippines has recently approved the 2017 periodic toll petition of joint venture partners Cavitex Infrastructure Corporation (CIC) and Philippine Reclamation Authority (PRA), for the toll rate adjustments in the 14-kilometer Manila-Cavite Expressway (CAVITEX).



Under the Toll Operation Agreement between the TRB, CIC, and PRA, the CAVITEX toll rates are allowed to be periodically adjusted every three (3) years. Exercising their right, CIC and PRA filed their Petition for Approval of Periodic Toll Rate Adjustment for R-1 Expressway (Seaside to Zapote) and R-1 Expressway Extension, Segment 4 (Zapote to Kawit) before the TRB in 2017.

Upon careful consideration and diligent review of the submissions, the TRB issued its Resolution granting the Petition and allowing the implementation of the provisionally approved toll rates.
