s public schools reopened last week, the Department of Education (DepEd) unveiled a redesigned Kindergarten to Grade 10 (K to 10) basic education curriculum that focuses on five learning competencies to strengthen the young learners' foundational skills in Language, Reading and Literacy, Math, Makabansa, and Good Manners and

The new curriculum will be piloted this school year 2023-2024, then implemented in three phases from 2024 to 2027.

Also last week, the DepEd told the House of Representatives that there is a shortage of 165,000 classrooms and at the current annual rate – less than 20,000 was budgeted for construction – it would take over 20 years for this shortage to be covered

In mid-2021, while coronavirus pandemic raged on, the Philippine Institute for Development Studies identified "five problems that result in poor learning outcomes that need to be urgently addressed: a) implementation inefficiencies; b) malnutrition; c) lack of textbooks; d) school connectivity; and e) teacher quality."

Given these adverse realities, it is not surprising that in a recent Pulse Asia survey commissioned by the chairperson of the Senate committee on education, it was revealed that there was an almost equal number of respondents – 42 percent dissatisfied, 41 percent satisfied - with contradictory assessments of their experience with senior high school. A DepED task force will start tackling the senior highschool curriculum

Amid this rather uninspiring scenario, the Philippine News Agency (PNA) reports that at the recent 64th International Mathématical Olympiad (IMO) held in Chiba, Japan, six Filipino students won three silver medals and three bronze medals. Earlier this year, 19 young Filipinos clinched gold medals at the World International Mathematical Olympiad (WIMO) in Bangkok, Thailand. These exceptional achievements demonstrate that, properly trained and guided, young Filipinos could match and even outperform their peers.

Despite this proverbial silver lining, it is imperative that decisive steps are taken to address these serious

problems affecting the education, health and . development of the Filipino youth.

A multi-sectoral Children's First One Thousand Days Coalition (CFDC) has been launched in determined efforts to stem the tide of malnutrition and stunting, described vividly by UNICEF: "Every day, 95 children in the Philippines die from malnutrition. Twenty-seven out of 1,000 Filipino children do not get past their fifth birthday. A third of Filipino children are stunted, or short for their age. Stunting after two years of age can be permanent, irreversible, and even fatal."

The Department of Social Work and Community Development is at the nexus of continuing efforts to address these problems that are deeply rooted in poverty and social inequality through the Philippine Multi-Sectoral Nutrition Project (PMNP), Food Stamp Program (FSP) and Pantawid Pamilyang Pilipino Program (4Ps).

To fully recover from the massive declines caused by

the pandemic, the government must take decisive action to fast-track the clearing of the classroom backlog, hire and train qualified teachers, provide needed textbooks

and install digital connectivity. Political will is extremely important. If this is demonstrated convincingly, the people will certainly rally behind their government, declaring "Yes, we can!"

Led by Department of Science and Technology (DOST) Secretary Renato U. Solidum Jr., the DOST welcomed the opportunity to collaborate with the private sector in Science, Technology, and Innovation (STI). This strategic alignment is expected to bring many benefits, such as knowledge exchanges, technological breakthroughs, and finding innovative solutions that can improve the STI efforts of the country.

For DOST, research and development projects on

OneLab Network, SETUP (Small Enterprise Technology Upgrading Program) and CEST (Community Empowerment through Science and Technology), alongside the areas of cooperation outlined in the MOU are envisioned to be continued.

Association President Lilian Macalood said that they support the decision of President Marcos to implement the mandated price ceilings on rice as they hope that the prices of rice will remain consistent.

"Sumusuporta ako sa desisyon ng ating Pangulo na hanggang doon lang 'yung price ceiling at sana ay hindi na tumaas dahil sa sobrang taas na halos hindi na makaagapay ang ating mga mamamayan at lalong-lalo naman na ang mga nagtatanim ng palay o magsasaka," Macalood said.

Macalood added that they are greatly affected by the surge of prices of rice in the market.

"Kaya sana 'yang tinakdang presyo ng ating Pangulo ang masunod at hindi itatago ng mga retailer o nag-seller nang huwag nang taasan 'yan kasi hindi na talaga makaagapay ang mga mamayan sa sobrang Bakit nagkakaganoon?" she quipped.

ARC Palawan Cooperative Federation General Manager Reymundo Imaysay also expressed his support for the implementation of the mandated rice price caps in the market as he sees the good intention of the executive order, especially successfully enforced.

Reymundo believes that

President Marcos' order will eliminate the unhealthy competition among rice traders who are taking advantage of the situation and will also get rid of the abusive cartels who are playing big in the price manipulation of rice.

"Magiging outcome nun ay makabenepisyo 'yung ating mga magsasaka at the same time kung ang presyo ng 'yung price ceiling na 'yan ay hanggang doon lang, so ibig sabihin makabenepisyo rin 'yung ating mga mamimili, makabili sila ng murang mga produkto o bigas na ibebenta ng ating mga kooperatiba o kaya mga magsasaka," Reymundo

Carolina Pacheco Joson, member of the Malsada Pisco farmers' group in Leyte, echoed sentiments of Macalood and Reymundo as she thanked President Marcos for coming up with the executive order since consumers will now be able to buy their products at a reasonable price.

"Malipayon na an mga parag-uma tungod kay aadi na ha amon mapalit an mga consumers ha amon han bugas didi ha Malsada Pisco.

Damu nga salamat hini nga higayon nga guin hatag ni President ngadi han mga parag-uma. (The farmers are now happy because the rice consumers will now buy

our products in Malsada Pisco.

Thank you very much to President Marcos for the opportunity you have given us, farmers)," Joson said in the vernacular.

Other members of farmer groups such as the San Ísidro Organic Farmers Association of Brgy. San Isidro Sta. Fe, Leyte, the Yabong Kabuhayan ng Gatud (Yakag) DARPO-Oriental Mindoro of Gatud, Calapan City, Oriental Mindoro, the Genero ARB MPC of DAR-Occidental Mindoro and the Dubduban Farmers and Fisherfolks have also expressed their support for the new order.

"Kami nasuporta han mandated price ceiling han bugas kay daku ini nga bulig ha amon nga mga parag-uma.

Damu ng salamat President Marcos han imo bulig ha amon. (We support the mandated price ceilings on rice because this is a big help for us farmers.

Before departing for Jakarta, Indonesia on Monday to participate in the 43rd ASEAN Summit and Related Summits, President Marcos has committed to provide aid for rice retailers who would be adversely affected by the imposed price ceiling on rice. / PND

RESOLUTION

Before this Court is the Ex-Parte Motion to Publish Judgment dated 3 April 2023, filed by plaintiff Luzviminda Sapiter, represented by counsel, Atty. Erwin Bryan S. Kanapi

The counsel of the plaintiff stated that the summons to the defendant was serve via publication. The defendant failed to file his answer and to appear in court. Thereafter, the Court rendered a Decision dated 10 March 2023 in favor of the plaintiff and against defendant Emmanuel T. Ramirez and persons deriving possession through him.

The issue for this Court's Resolution is whether or not the Exparte Motion to Publish Judgment should be granted.

This Court finds that the Ex-Parte Motion to Publish Judgment filed by the plaintiff is meritorious. Section 13 of Rule 13 of the Amended Rules of Civil Procedure, ¹ provides that:

Section 13. Service of Judgment, Final Orders or Resolution-Judgments, final orders. or resolutions shall be served either personally or by registered mail. Upon ex-parte motion of any party in the case, a copy of the judgment, final order, or resolution may be delivered by accredited courier at the expense of such party. When a party summoned by publication has failed to appear in the action, judgement, final orders or resolutions against him or her shall also be served upon him by means of publication at the expense of the prevailing party.

WHEREFORE, prescinding from the foregoing, the Ex-Parte Motion to Publish Judgement is hereby GRANTED. Let the Decision dated 10 March 2023 be published in a newspaper of general circulation at the expense of the plaintiff.

JUDGMENT

This is verified complaint for Unlawful Detainer with Damages filed by Luzviminda A. Sapiter (plaintiff Sapiter, for brevity) against Emmanuel T. Ramirez (defendant Ramirez, for brevity) and all persons deriving possession thru him.

FACTUALANTECEDENTS

Culled from the complaint, plaintiff Sapiter is married, of legal age, and with residence and postal address at 193 Barangay Pasong Buaya 1, Imus City, Cavite. Defendant Ramirez on the other hand is a resident of 9033 Door G, 2nd Floor, Palanas Street, Anabu 1-A, Imus City, Cavite.

Plaintiff alleged that she is the registered owner of a lot situated at Barangay Pasong Buaya, Imus City, Cavite (subject property), and a covered by Transfer Certificate of Title No. 057-2017065178¹ and Tax Declaration No. 239-0018-23992. ²

Plaintiff narrated that she and defendant Ramirez entered into a Contract of Lease dated 20 August 2018 ³ wherein the latter shall lease the subject property for a period of ten (10) years starting 3 April 2018 until 3 April 2028. As per contract, the defendant shall pay the monthly rental of Twenty Thousand Pesos (Php20,000.00). Unfortunately, starting November 2019 until January 2021, defendant failed to pay his monthly rentals in the total amount of Two Hundred Sixty-Six Thousand Pesos (Php266,000.00).

The attempt to settle before the barangay proved futile for failure of the defendant to appear. Thus, Katunayan upang Makadulog sa Hukuman? was issued to plaintiff Sapiter.

In her complaint, plaintiff Sapiter alleged that a Demand Letter to vacate and to pay the balance dated 12 January 2021 was sent to the defendant. In the affidavit of Service? prepared by Teodorico Manigo, ? said demand letter was returned to him by the defendant's representative/security guard-on-duty for defendant's refusal to receive the same. Attached to the complaint is the picture? showing that the demand letter was actually handed over the defendant. Despite such notice, defendant still failed to pay the balance and to vacate the premises.

Plaintiff prayed that after due notice and hearing, a judgment be rendered in her favor ordering the defendant and all the other persons holding possession of plaintiff's property to:

- 1. Vacate the subject property;
- 2. Order the defendant to pay the plaintiff the amount of Two Hundred Sixty-Six Thousand Pesos (Php266,000.00) plus interest from the date of formal demand and until said defendant and all persons deriving possession thru him shall have vacated the subject property;
- 3. Pay actual expenses and attorney's fees of Thirty Thousand Pesos (Php30,000.00) plus Two Thousand Five Hundred Pesos (Php2,500.00) for every appearance in court;
 - 4. Pay the costs of suits; and
- 5. Such other relief which the Honorable Court may deem just and equitable under the circumstances.

The Sheriff's return dated 14 December 2021 shows that the summons was unserved. The barangay secretary of the premises informed the sheriff that defendant Ramirez used to lease the premises but has already left a long time ago. The Barangay Hall of Anabu 1-A has issued a certificate that defendant has moved out and is no longer a resident of their barangay.

The Court issued an Order dated 24 January 2022 authorizing the plaintiff to serve the summons to the defendant. In the plaintiff's return dated 25 April 2022, the summons still remained unserved.

The request for the issuance of alias summon was granted by the Court in an order dated 27 April 2022. In the Sheriff's return dated 5 May 2022, the summons was likewise unserved.

For failure to serve the summons to the person of the defendant, the plaintiff filed a motion to issue summons by publication which was granted in an Order dated 14 June 2022.

In the plaintiff's Manifestation/Compliance dated 23 January 2023, he submitted the copy of the clippings and Affidavit of Publication of the Resolution and the complaint against the defendant, issued by Cavite Digest dated 5 and 12 December 2022

However, despite the lapse of the reglementary period after publication, the defendant failed to file his response. Hence, the case was submitted for decision in an Order dated 23 February 2023

ISSUES

Stripped down to its very essence, the main question to be revolved in this case, who between the plaintiff and the defendant has the better right to possess the subject property.

RULING

At the outset, the Rule on Summary Procedure provides for the consequences should defendant fail to file an Answer despite the Summons having duly served, albeit through publication in this case, thus:

"Section 6. Effect of failure to answer.- Should the defendant fail to answer the complaint within the period above provided, the court, motu proprio, or on motion of the plaintiff, shall render judgment as may be warranted by the facts alleged in the complaint and limited to what is prayed for therein: Provided, however, that the court may in its discretion reduce the amount of damages and attorney's fees claimed for being excessive or otherwise unconscionable. This is without prejudice to the applicability of section 4, Rule 15 of the Rules of Court, if there are two or more

Hence, this Decision.

The Supreme Court held in the case of Zaragosa vs. Iloilo Santos Truckers, Inc, ? the Court discussed the requisites of an unlawful detainer suit in instances where there exists a subsisting lease contract between the plaintiff-lessor and defendant-lessee, to wit:

For the purpose of bringing an unlawful detainer suit, two requisites must concur: (1) there must be failure to pay rent or comply with the conditions of the lease, and (2) there must be demand both to pay or to comply and vacate. The first requisite refers to the existence of the cause of action for unlawful detainer, while the second refers to the jurisdictional requirement of demand in order that said cause of action may be pursued. Implied in the

first requisite, which is needed to establish the cause of action of the plaintiff in an unlawful detainer suit, is the presentation of the contract of lease entered into by the plaintiff and defendant, the same being needed to establish the lease conditions alleged to have been violated. Thus, in Bachrach Corporation v. Court of Appeals [(357 Phil. 483,492 [1998])], the Court held that the evidence needed to establish the cause of action in an unlawful detainer case is (1) a lease contract and (2) the violation of that lease by the defendant. 1?

Thus, the plaintiff in an unlawful detainer case must established the following: "first, initially, the defendant-lessee legally possessed the leased premises by virtue of a subsisting lease contract; second, such possession eventually become illegal either due to the latter's violation of the provisions of the said lease contract or the termination thereof; third, the defendant-lessee remained in possession of the leased premises, thus, effectively depriving the plaintiff-lessor enjoyment thereof; and fourth, there must be a demand both to pay or to comply and vacate and that the suit is brought within one (1) year from the last demand. "11

After a careful and thorough evaluation, and examination of the records of this case, this Court finds that plaintiff Sapiter was able to satisfactorily prove by preponderance of evidence the existence of all the elements of unlawful detainer.

First, the possession of defendant Ramirez is by virtue of a Contract of Lease dated 20 August 2018 between plaintiff Sapiter as a lessor and defendant Ramirez as the lessee.

Second, the defendant's failure to pay the monthly rentals from November 2019 up to the filing of this case constitutes a violation of the terms and agreement of the lease contract and consequently, the defendant's possession of the subject property become illegal.

Third, despite receipt of the notice to pay and to vacate, the defendant failed and refused to vacate the subject property thus depriving the plaintiff of possession and enjoyment of the property.

Lastly, the summary case for unlawful detainer against the defendant was filed by the plaintiff on 19 November 2021 which is within one (1) year from 20 January 2021, the date when the demand to vacate and to pay was sent to the defendant evidenced by an Affidavit of Proof of Service.

Through the demand letter was refused to received by defendant Ramirez and was returned by his representative/ guard-on duty, it should be noted that the absence of personal service of notice to vacate in this case could only be attributed to petitioner's unexplainable refusal to receive the same. In Co Keng Kian v. Intermediate Appellate Court, 12 it was held that "[t]he Court cannot countenance an unfair situation where the plaintiff in an eviction case suffers further injustice by the unwarranted delay resulting from the obstinate refusal of the defendant to acknowledge the existence of a valid demand.

As the complaint contains a valid cause of action for Unlawful Detainer, a judgement can now be rendered. The failure of the defendant to timely file his answer despite the lapse of the reglementary period after publication of the summons constitutes his acquiescence to every allegation stated in the complaint. Logically, there is nothing to be done in this situation except to render judgment as may be warranted by the facts alleged in the complaint.

WHEREFORE, premises considered, Judgment is hereby rendered in favor of plaintiff Luzviminda A. Sapiter as follows:

- 1. ORDERING defendant EMMANUEL T. RAMIREZ and all persons deriving possessions thru him to peacefully VACATE and DELIVER the immediate and full possession of the subject property located at Pasong Bambang, Pasong Buaya 1, Imus City, Cavite, to plaintiff Luzviminda A. Sapiter;
- 2. PAY the plaintiff the amount of Two Hundred Sixty-Six Thousand Pesos (Php 266,000.00) as a compensation for the monthly rentals from November 2019 until January 2021;
- 3. PAY the monthly rental of Twenty Thousand Pesos (Php 20,000.00) per month from January 2021 until the defendant and all persons deriving possessions thru him shall have vacated the subject property;
- 4. PAY the amount of Thirty Thousand Pesos (Php 30,000.00) as and by way of attorney's fees; and
 - 5. PAY the cost of suit.


