A delegation of journalists from the Guangxi Radio and Television in China visited the Kaliwa Dam Project

delegation of journalists from the Guangxi Radio and Television in China recently visited the construction site of the Kaliwa Dam Project, a high-quality project undertaken by China in the Philippines under the Belt and Road Initiative.

The Kaliwa Dam Project is an important cooperation project between China and the Philippines are well as

project between China and the Philippines, as well as a crucial part of the Philippines' New Centennial Water Source Project (NCWSP)

It is reported that the Kaliwa Dam Project is a concrete gravity dam, with a designed height of 73 meters and a 247-meter crest. A 21.9-kilometer water diversion tunnel is currently underway, which plays a significant role in controlling the project.

Ryan James Eisen, the representative of the Philippine owner unit of the Kaliwa Dam Project, said that China Energy Engineering Group Co., Ltd. (CEEC) has brought advanced engineering technology and mature construction experience to the Philippines, providing crucial support for the smooth and high-quality construction of

the dam, tunnel, and water supply system.
As of July 31, 22.37 percent of the project had been completed, and the excavation of the tunnel outlet had reached nearly 1.3 kilometers.

According to reports, the Kaliwa Dam Project is located in a geologically complex area. To ensure the smooth progress of the project, CEEC has custom-designed the "Sampaguita" dual-shield hard rock tunnel boring machine specifically for the Kaliwa Dam Project. This machine, independently developed by China, is capable of traversing fault zones and fractured zones, and excavate at a speed of 20-30 meters per day.

Upon completion of the project, it is expected to set a record for the longest single-head excavation distance by a dual-shield hard rock tunnel boring machine in all overseas tunnel projects undertaken by Chinese enterprises.

Once the dam is completed, it will supply 600 million liters of clean drinking water to the Manila area on a daily basis, which will meet the demands of nearly 6 million people and significantly alleviate water scarcity in the region.

Moreover, the project will greatly strengthen local



transportation, generate a substantial number of employment opportunities, and contribute to the overall improvement of residents' living standard.

The Kaliwa Dam Project exemplifies the immense

potential for cooperation between China and the Philippines in the field of infrastructure, in which China offers advanced construction technology and management expertise, while the Philippines provides ample support in terms of manpower and material supply

Through this project, the Philippines' infrastructure development is further enhanced, and it also promotes broader cooperation between China and the Philippines in various fields.



participants in the forums are the local government units from various parts of Northern Mindanao and neighboring regions, media practitioners, academe, volunteer organizations, and private sectors in Mindanao.

The Mindanao leg of the HANDA Pilipinas expo will give a spotlight on bamboo as a strategy for DRR and Climate Change Adaptation (CCA). Bamboo is widely known for its very high carbon sequestration capacity thus reducing greenhouse gas, its good soil and water holding capacity thus preventing soil erosion and flooding. It is also an effective windbreaker. The exhibit viewers will learn more about bamboo in this including expo opportunities for livelihood and business.

At the same venue, DOST-PAGASA will set up an inflatable mobile planetarium for learning scientific concepts of the Universe to the general public, and to elementary and high school students. This concept includes the size and content of the observed universe, its creation, history, and possible future, and the development of the solar system. Each batch includes lecture and film showing stargazing sessions.

Other than the forums and the exposition, a DOST DRR-CCA quiz bowl and TikTok contest will also be conducted at the atrium. The general public is invited to participate in the 3-day event. The exhibit will be open to everyone for free viewing October 4-6, 10:30 AM - 7PM

The HANDA Pilipinas: Innovations in Disaster Risk Reduction Management Exposition 2023 is a nationwide event. The Luzon leg was held at the World Trade Center, Pasay City, from July 27-30 with the theme "Megacities at Risk". The Visayas leg will be conducted from November 8-10, during the 10th year anniversary of Super Typhoon Yolanda with the theme "STY remembered: Understanding risks and preventing disasters."

The title "HANDA Pilipinas" means two things: "HANDA" as a call to action; and "HANDA" as an end-state. Given the compounding risks that the country is exposed to, the HANDA Pilipinas is an intensified information and advocacy platform to prevent hazards from becoming disasters and to enhance resilience.

This Expo is organized by DOST agencies and offices: the Technology Application and Promotion Institute (DOST-TAPI), Science and Technology Information Institute (DOST-STII), Philippine Atmospheric, Geophysical, Astronomical Services

Administration (DOST-PAGASA), Philippine Institute of Volcanology Seismology and (PHIVOLCS), the three DOST regional offices of NCR, Eastern Visayas and Northern Mindanao, the Office the Undersecretary for Regional Operations (OUSecRO) and the DRR-CCA unit of the Office of the DOST Secretary.

The HANDA Pilipinas DRR Expo activities are conceptualized consideration of the four priorities of the SENDAI Framework for DRR 2015-2030, which are: (1) Understanding disaster risk, (2) Strengthening disaster risk governance to manage disaster risk, (3) Investing in DRR for resilience and technologies, and (4) Enhancing disaster preparedness for effective response and to "Build Back Better" in recovery, rehabilitation reconstruction.

This initiative is aimed to address the Sustainable Development Goals 11 and 13 particularly indicator 11.5, which is, by 2030, significantly reduce the number of deaths and the number of people affected and substantially decrease the direct economic losses relative to the global gross domestic product caused by disasters, including water-related disasters, with a focus on protecting the poor and people in vulnerable situations. RESOLUTION

Before this Court is the Ex-Parte Motion to Publish Judgment dated 3 April 2023, filed by plaintiff Luzviminda Sapiter, represented by counsel, Atty. Erwin Bryan S. Kanapi

The counsel of the plaintiff stated that the summons to the defendant was serve via publication. The defendant failed to file his answer and to appear in court. Thereafter, the Court rendered a Decision dated 10 March 2023 in favor of the plaintiff and against defendant Emmanuel T. Ramirez and persons deriving possession through him.

The issue for this Court's Resolution is whether or not the Exparte Motion to Publish Judgment should be granted.

This Court finds that the Ex-Parte Motion to Publish Judgment filed by the plaintiff is meritorious. Section 13 of Rule 13 of the Amended Rules of Civil Procedure, ¹ provides that:

Section 13. Service of Judgment, Final Orders or Resolution-Judgments, final orders. or resolutions shall be served either personally or by registered mail. Upon ex-parte motion of any party in the case, a copy of the judgment, final order, or resolution may be delivered by accredited courier at the expense of such party. When a party summoned by publication has failed to appear in the action, judgement, final orders or resolutions against him or her shall also be served upon him by means of publication at the expense of the prevailing party.

WHEREFORE, prescinding from the foregoing, the Ex-Parte Motion to Publish Judgement is hereby GRANTED. Let the Decision dated 10 March 2023 be published in a newspaper of general circulation at the expense of the plaintiff.

JUDGMENT

This is verified complaint for Unlawful Detainer with Damages filed by Luzviminda A. Sapiter (plaintiff Sapiter, for brevity) against Emmanuel T. Ramirez (defendant Ramirez, for brevity) and all persons deriving possession thru him.

FACTUALANTECEDENTS

Culled from the complaint, plaintiff Sapiter is married, of legal age, and with residence and postal address at 193 Barangay Pasong Buaya 1, Imus City, Cavite. Defendant Ramirez on the other hand is a resident of 9033 Door G, 2nd Floor, Palanas Street, Anabu 1-A, Imus City, Cavite.

Plaintiff alleged that she is the registered owner of a lot situated at Barangay Pasong Buaya, Imus City, Cavite (subject property), and a covered by Transfer Certificate of Title No. 057-2017065178¹ and Tax Declaration No. 239-0018-23992. ²

Plaintiff narrated that she and defendant Ramirez entered into a Contract of Lease dated 20 August 2018 ³ wherein the latter shall lease the subject property for a period of ten (10) years starting 3 April 2018 until 3 April 2028. As per contract, the defendant shall pay the monthly rental of Twenty Thousand Pesos (Php20,000.00). Unfortunately, starting November 2019 until January 2021, defendant failed to pay his monthly rentals in the total amount of Two Hundred Sixty-Six Thousand Pesos (Php266,000.00).

The attempt to settle before the barangay proved futile for failure of the defendant to appear. Thus, Katunayan upang Makadulog sa Hukuman? was issued to plaintiff Sapiter.

In her complaint, plaintiff Sapiter alleged that a Demand Letter to vacate and to pay the balance dated 12 January 2021 was sent to the defendant. In the affidavit of Service? prepared by Teodorico Manigo, ? said demand letter was returned to him by the defendant's representative/security guard-on-duty for defendant's refusal to receive the same. Attached to the complaint is the picture? showing that the demand letter was actually handed over the defendant. Despite such notice, defendant still failed to pay the balance and to vacate the premises.

Plaintiff prayed that after due notice and hearing, a judgment be rendered in her favor ordering the defendant and all the other persons holding possession of plaintiff's property to:

- 1. Vacate the subject property;
- 2. Order the defendant to pay the plaintiff the amount of Two Hundred Sixty-Six Thousand Pesos (Php266,000.00) plus interest from the date of formal demand and until said defendant and all persons deriving possession thru him shall have vacated the subject property;
- 3. Pay actual expenses and attorney's fees of Thirty Thousand Pesos (Php30,000.00) plus Two Thousand Five Hundred Pesos (Php2,500.00) for every appearance in court;
 - 4. Pay the costs of suits; and
- 5. Such other relief which the Honorable Court may deem just and equitable under the circumstances.

The Sheriff's return dated 14 December 2021 shows that the summons was unserved. The barangay secretary of the premises informed the sheriff that defendant Ramirez used to lease the premises but has already left a long time ago. The Barangay Hall of Anabu 1-A has issued a certificate that defendant has moved out and is no longer a resident of their barangay.

The Court issued an Order dated 24 January 2022 authorizing the plaintiff to serve the summons to the defendant. In the plaintiff's return dated 25 April 2022, the summons still remained unserved.

The request for the issuance of alias summon was granted by the Court in an order dated 27 April 2022. In the Sheriff's return dated 5 May 2022, the summons was likewise unserved.

For failure to serve the summons to the person of the defendant, the plaintiff filed a motion to issue summons by publication which was granted in an Order dated 14 June 2022.

In the plaintiff's Manifestation/Compliance dated 23 January 2023, he submitted the copy of the clippings and Affidavit of Publication of the Resolution and the complaint against the defendant, issued by Cavite Digest dated 5 and 12 December 2022.

However, despite the lapse of the reglementary period after publication, the defendant failed to file his response. Hence, the case was submitted for decision in an Order dated 23 February 2023.

ISSUES

Stripped down to its very essence, the main question to be revolved in this case, who between the plaintiff and the defendant has the better right to possess the subject property.

RULING

At the outset, the Rule on Summary Procedure provides for the consequences should defendant fail to file an Answer despite the Summons having duly served, albeit through publication in this case, thus:

"Section 6. Effect of failure to answer.- Should the defendant fail to answer the complaint within the period above provided, the court, motu proprio, or on motion of the plaintiff, shall render judgment as may be warranted by the facts alleged in the complaint and limited to what is prayed for therein: Provided, however, that the court may in its discretion reduce the amount of damages and attorney's fees claimed for being excessive or otherwise unconscionable. This is without prejudice to the applicability of section 4, Rule 15 of the Rules of Court, if there are two or more

Hence, this Decision.

The Supreme Court held in the case of Zaragosa vs. Iloilo Santos Truckers, Inc, ? the Court discussed the requisites of an unlawful detainer suit in instances where there exists a subsisting lease contract between the plaintiff-lessor and defendant-lessee, to wit:

For the purpose of bringing an unlawful detainer suit, two requisites must concur: (1) there must be failure to pay rent or comply with the conditions of the lease, and (2) there must be demand both to pay or to comply and vacate. The first requisite refers to the existence of the cause of action for unlawful detainer, while the second refers to the jurisdictional requirement of demand in order that said cause of action may be pursued. Implied in the

first requisite, which is needed to establish the cause of action of the plaintiff in an unlawful detainer suit, is the presentation of the contract of lease entered into by the plaintiff and defendant, the same being needed to establish the lease conditions alleged to have been violated. Thus, in Bachrach Corporation v. Court of Appeals [(357 Phil. 483,492 [1998])], the Court held that the evidence needed to establish the cause of action in an unlawful detainer case is (1) a lease contract and (2) the violation of that lease by the defendant. 1?

Thus, the plaintiff in an unlawful detainer case must established the following: "first, initially, the defendant-lessee legally possessed the leased premises by virtue of a subsisting lease contract; second, such possession eventually become illegal either due to the latter's violation of the provisions of the said lease contract or the termination thereof; third, the defendant-lessee remained in possession of the leased premises, thus, effectively depriving the plaintiff-lessor enjoyment thereof; and fourth, there must be a demand both to pay or to comply and vacate and that the suit is brought within one (1) year from the last demand. "11

After a careful and thorough evaluation, and examination of the records of this case, this Court finds that plaintiff Sapiter was able to satisfactorily prove by preponderance of evidence the existence of all the elements of unlawful detainer.

First, the possession of defendant Ramirez is by virtue of a Contract of Lease dated 20 August 2018 between plaintiff Sapiter as a lessor and defendant Ramirez as the lessee.

Second, the defendant's failure to pay the monthly rentals from November 2019 up to the filing of this case constitutes a violation of the terms and agreement of the lease contract and consequently, the defendant's possession of the subject property become illegal.

Third, despite receipt of the notice to pay and to vacate, the defendant failed and refused to vacate the subject property thus depriving the plaintiff of possession and enjoyment of the property.

Lastly, the summary case for unlawful detainer against the defendant was filed by the plaintiff on 19 November 2021 which is within one (1) year from 20 January 2021, the date when the demand to vacate and to pay was sent to the defendant evidenced by an Affidavit of Proof of Service.

Through the demand letter was refused to received by defendant Ramirez and was returned by his representative/ guard-on duty, it should be noted that the absence of personal service of notice to vacate in this case could only be attributed to petitioner's unexplainable refusal to receive the same. In Co Keng Kian v. Intermediate Appellate Court, 12 it was held that "[t]he Court cannot countenance an unfair situation where the plaintiff in an eviction case suffers further injustice by the unwarranted delay resulting from the obstinate refusal of the defendant to acknowledge the existence of a valid demand.

As the complaint contains a valid cause of action for Unlawful Detainer, a judgement can now be rendered. The failure of the defendant to timely file his answer despite the lapse of the reglementary period after publication of the summons constitutes his acquiescence to every allegation stated in the complaint. Logically, there is nothing to be done in this situation except to render judgment as may be warranted by the facts alleged in the complaint.

WHEREFORE, premises considered, Judgment is hereby rendered in favor of plaintiff Luzviminda A. Sapiter as follows:

- 1. ORDERING defendant EMMANUEL T. RAMIREZ and all persons deriving possessions thru him to peacefully VACATE and DELIVER the immediate and full possession of the subject property located at Pasong Bambang, Pasong Buaya 1, Imus City, Cavite, to plaintiff Luzviminda A. Sapiter;
- 2. PAY the plaintiff the amount of Two Hundred Sixty-Six Thousand Pesos (Php 266,000.00) as a compensation for the monthly rentals from November 2019 until January 2021;
- 3. PAY the monthly rental of Twenty Thousand Pesos (Php 20,000.00) per month from January 2021 until the defendant and all persons deriving possessions thru him shall have vacated the subject property;
- 4. PAY the amount of Thirty Thousand Pesos (Php 30,000.00) as and by way of attorney's fees; and
 - 5. PAY the cost of suit.
