The delegation paid a courtesy call to Cavite Governor Jonvic Remulla. The meeting was marked by a candid exchange of ideas on educational policies, the challenges faced by both regions, and the shared commitment to fostering excellence in education.

Highlights of the visit was the inspection of computer laboratories of the 2023 Korean e-Learning Improvement Cooperation Program (KLIC) trainees. These state-of-the-art facilities underscore the commitment to equipping students with the skills needed for the digital age.

Another notable event included the Local Training for the KLIC Program, which took place at Tanza National Trade

School. This training session followed the 12-day KLIC training that 20 ICT teachers from Cavite had undergone in South Korea from August 28 to September 8, 2023.

They also had the opportunity to observe ICT classes at the Cavite Computer Center Tanza Satellite Office and various public schools which include Dasmariñas East Integrated School, Juanito R. Remulla Senior High School, Tanza National Trade School, Malainin Bago Integrated School and Pangil National High School. This firsthand experience allowed them to gain valuable insights into the teaching and learning process in the field of ICT, as well as witness the dedication of Filipino

educators.

To date, a total of 269 teachers and educators from public elementary and secondary schools have benefited from Korean Learning Improvement Cooperation training program. The experience has enriched their teaching methods and enhanced the quality of ICT education. Likewise, the training has also provided 1,691 computer sets to different elementary and secondary schools in the province.

During the pandemic, the partnership continued through the online Korean Learning Improvement Cooperation (KLIC) training program wherein 83 public elementary and secondary teachers participated and granted a total of 53 Samsung tablets and 61 computers. **(OPIO)**

A beginning for Calamba Cancer Center. We can continue improving our center so we can do more for the people of Calamba and nearby cities. We reiterate our thanks to PhilHealth for approving our Z Benefits Package so that we can serve our countrymen better."

Dr. Ronnie C. Lanzas of the Calamba City Health Office stressed that the MOA is an affirmation of the commitment of all involved stakeholders to improving the lives of individuals battling these critical illnesses. "This collaboration represents a union of our shared vision and dedication to enhancing health care services for those facing these challenging conditions.

Together, we aim to ensure that every patient receives the highest quality

of care, support, and resources they need on their journey for recovery."

Understanding the plight of both the patients and their caregivers, CMC-Cancer Center Medical Director Dr. Salvador Villanueva emphasized the significance of this collaboration between PhilHealth and CMC-Cancer Center "in their journey in dealing with cancer". He further stressed that the Z Benefit Package will provide "accessible, specialized, cost-effective, and modern cancer care available for patients".

Case Type Z conditions are catastrophic illnesses that usually require prolonged hospitalization and poor outcome if early intervention is not done. The package is called Z benefit since if ranking all illnesses from A to Z those illnesses that push patients into prolonged hospitalization and very expensive treatments would be the Z illnesses. These illnesses are what the Z Benefits package will

be addressing.

The Z Benefit package rate for breast cancer stage 0 to III-A is P100,000. Meanwhile, there are two Z Benefits packages that cover complete course of treatment for cervical cancer for stages IA1, IA2-IIA1 where it pays P120,000 for Chemoradiation with Cobalt and Brachytherapy (low dose), and P175,000 for Chemoradiation with Linear Accelerator and Brachytherapy (high dose).

These benefits may be availed at any PhilHealth contracted facility. Contracted facilities for the Z Benefits are any level 3 and 4 hospitals that have signed the performance commitment and contract to provide total quality care for the Type Z conditions.

With the Z Benefit Package, PhilHealth is committed towards the realization of the UHC law that all Filipinos will have access to the full range of quality health services they need, when and where they need them, without financial hardship. **(SMOC)**

To kick off the orientation, Ms. Dianne Digma, Community Facilitator from DOLE-Cavite Provincial Office, provided applicants with an in-depth understanding of the program's overview and objectives. She ensured that all participants comprehended the crucial information outlined in the internship agreement forms.

During the orientation, Provincial Administrator for Community Affairs Alvin S. Mojica delivered an inspirational message, acknowledging the significance of DOLE's pioneering GIP project in the Provincial Government of Cavite. He emphasized the service-oriented nature of government

work, with a commitment to prioritizing the welfare of constituents.

In addition to the GIP orientation, the interns received an informative session on PGC's human resource policies. Ms. Maria Fe Satsatin, head of the Office of the Provincial Human Resource and Management Officer, covered the history of PGC, its vision, mission, and values statement, and highlighted salient features of Republic Act 6713, also known as the Code of Conduct and Ethical Standards for Public Officials and Employees.

The Government Internship Program is an integral component of the Department of Labor and Employment's KABATAAN 2000 program. It is designed to provide opportunities for young workers aged 18 to 30 to engage in meaningful work at both the national and local government levels, with a focus on serving the public.

Interns will undergo a minimum of three months to a maximum of six months of internship, during which they will receive a daily salary of P520. **(OPIO)**

Bauertek Corporation is the country's premier international standard toll manufacturing company. More than 60 countries allow the use of medical cannabis while the Philippines stands to earn P40-billion in yearly taxes when the use of the plant is legalized.

Based on latest survey of Bauertek Corporation, 63 percent of Filipinos support the legalization of medical cannabis.

The company's general manager, a scientist and an inventor, Dr. Richard Nixon Gomez, said that legalization of medical cannabis may no longer take long. "Ilang hakbang

na lang po at matitikman na natin ang medical cannabis (as medicine) in the Philippines po," Gomez announced in the forum.

He said a more intense media campaign is necessary. "Nasa last leg na po tayo ng pakikipaglaban," Gomez added.

Meanwhile, Forbes said his reason for joining the advocacy group is his 3-year-old daughter who is suffering from stroke and cerebral palsy seizures, since she was one-year-old. He claimed to have used "synthetic medicine but the seizure was still there."

Forbes recalled that his daughter fell into a coma for a day in January this year and since then, seizures have been frequent. He lamented that medical cannabis has been proven to cure various illnesses including seizures yet the Philippines

seems to ignore this reality while other countries are already into it.

Despite the claim of other groups that the Philippines has no capability of producing medicines from medical cannabis, Gomez declared the opposite. The country is more than ready and Bauertek has cultivation plant in partnership with the government, he explained.

Cunanan on the other hand, was grateful to Gomez for spearheading the information campaign on the benefits of medical cannabis and more people are now enlightened. Cannahopefuls is optimistic that in the future, Filipinos will be living in a happy community, and open to use medical cannabis as medicine without fear of being arrested or treated as addict.





PBBM EXTENDS CONDOLENCES, SYMPATHIES TO WIFE OF FILIPINO WHO DIED IN ISRAEL; ORDERS PH AMBASSADOR TO PROVIDE ALL ASSISTANCE



President Ferdinand R. Marcos Jr. personally extended his condolences and sympathies to the wife of the 42-year-old Filipino who was killed on Saturday in the ongoing conflict between Israeli forces and the Palestinian militant group Hamas.

In a telephone call on Wednesday evening, President Marcos assured the wife that the Philippine government will provide all the necessary assistance to them and give him a decent burial once the Israel-Hamas situation subsides.

"Gusto ko rin na kausapin ka para makiramay ... Napakalaking gulo talaga 'yung nangyari. Wala namang may akala na ganun ang magiging giyera diyan sa Israel," President Marcos told the widow.

"Magsabi sa amin kung ano kailangan mo. Nandito ang gobyerno para tulungan ka ... gusto ko lang makausap ka para alam mo naman inaalala ka namin at nakikiramay hindi lamang ako, buong pamilya ko, lahat ng Pilipinas ay nakikiramay sa iyo," he added.

President Marcos has already instructed Philippine Ambassador to Israel, Pedro "Junie" Laylo Jr., to closely coordinate with the families of the two victims and provide them with all the necessary assistance amid these trying times.

The President told the widow that Ambassador Laylo is their contact in Israel.

"Sabihin mo lang sa kaniya. Ready kami para tumulong para sa lahat ng kailangan niyo ... gagawin namin lahat ng kailangang gawin," President Marcos said.

"Yung government ay nandiyan. Nandiyan si Ambassador Laylo, naco-contact naman. Makakaprovide kami ng lahat ng financial assistance na kailangan ninyo at asahan ninyo na titignan namin lahat ng puwedeng gawin para makauwi ... basta susubukan namin lahat ng aming gagawin," the President added. ► **PBBM • 4**
