The first leg of the hearing on October 9 was presided by Vice Governor Athena Tolentino with Board Member Maurito Sison who delivered the opening remarks. Proposed expenditure programs of offices under the Social Services cluster of the PGC including the provincial hospital, Cavite Center for Mental Health and other satellite hospitals were presented and reviewed as well as those of the Office of the Provincial Social Welfare and Development Officer, and the Office of the Provincial Population Officer.

On the second day of the hearing, Governor Jonvic Remulla joined the provincial board and the heads of the different departments of the PGC in the review of the proposed local expenditure program for the General Public Services and Economic Services sectors.

After thorough rounds of presentation of the accomplishments, plans and budget of all the offices, the program successfully concluded with a closing

message delivered by Board Member Reyniel Ambion. The two-day hearing highlighted the transparent and prudent use of provincial government's resources aimed at delivering effective and efficient public service for all Caviteños. *(OPIO)*


## DOST 3 LAUNCHES 3DAY RSTW IN ZAMBALES

### Marcoleta launches "Mura at Masarap na Bigas Para sa Masa"



ONGRESSMAN Rodante Marcoleta of Sagip Party list has launched a nationwide campaign to rescue all rice farmers by forming a formula that may prevent hoarders and smugglers -

believed to be behind the continuous price hikes.

During the launch held in Barangay Cristo Rey, Capas, Tarlac, Marcoleta offered a fixed price of P35 per kilo of well-milled denorado rice to local consumers, 17 pesos lower than the prevailing market price.

Hundreds of locals have lined up, hoping to buy at least 5 kilos which they said is enough for two days consumption. The limit aimed to avoid panic buying and hoarding in order to spread its supply to more consumers

The program is in collaboration with President Ferdinand Bongbong Marcos' agenda, that is to achieve food sufficiency and security eventually. "And to realize that, we need to amalgamate all patriotic businessmen in the country who can invest in the program even without profit in the process because that is the only way to help out our farmers and consumers as well as

our national government," Marcoleta said in vernacular.
"Gumagawa ng paraan ang ating Pangulo pero kailangan natin siyang tulungan. Hindi puwedeng lagi na lang ang gobyerno ang humahanap ng interes para sa bayan," the Sagip Party list, stressed.

The project for farmers is dubbed "Ikiskiss Mo Beybi! Adopt a Farmer Program."

Heeding the call for the program was local businessman Tony Marfori and members of the Pampanga Chamber of Commerce, who bought palay yields directly from the farmers, three pesos higher than the 19 pesos buying price of the National Food Authority (NFA). The product then dried, properly-milled and sold to consumers to a break-even price.

The launching venue was personally chosen by the congressman because he desired to pay homage first to his home province of Tarlac before their massive propagation nationwide in the coming days.

Also in attendance during the event were former Capas mayor TJ Rodriguez, Provincial Board Member League of the Philippines, Barangay officials, among others. (Nelson Santos)

### A DOTING PA'S APPEAL TO CONGRESS: 'LEGALIZE USE OF MEDICAL CANNABIS'

A doting father has emotionally appealed to Congress to now approve the use of medical cannabis or marijuana as medicine, for the sake of his only son and other patients.



Romeo Ballesteros, a member Cannahopefuls, Inc. – an advocacy group for the legalization on the use of medical cannabis, was teary-eyed when he appeared before the weekly Media Health Forum of Bauertek, Inc. last Monday. "Ang masakit ay 'yong makita mo ang anak mo na nangingisay sa harapan mo at wala kang magawa. Hindi mo mapigilan 'yon," Ballesteros said.

He came to the forum with his now 16-years-old

son, Sachi, who has been suffering from seizure disorder since he was five months old. Studies. research and clinical trials show that medical cannabis can cure epilepsy and other ailments. It has also been clinically proven for pain, chronic chemotherapy associated nausea vomiting, multiple sclerosis, among others

Medical cannabis' use is legal in 60 countries and counting. The Philippine Senate and House of Representatives have yet

the approve legalization of its use.

Dr. Gem Marq Mutia, an adult medicine specialist and founder of Philippine Society of Cannabinoid Medicine, is a regular forum panelist. He said that patients and parents from overseas who gave testimonies on the benefits of medical cannabis, are the reason why local patients have as well, appealed to legalize its use.

Meanwhile, Dr. Richard Nixon Gomez, an inventor, a scientist and general manager of Bauertek, Inc.

said that they are looking forward for Congress' approval before the end of

The elder Ballesteros said that his son is currently taking five antiepileptic drugs but these have side effect on the boy's immune system and caused other medical problems "that affect his quality of life." This is also the reason, they can't send him to a regular school.

Dr. Mutia explained that CBD or Cannabidiol is a compound found in marijuana which is not impairing, meaning it does not cause a "high." This causes seizure to stop. "Mas safe po ito sa mga organs at definitely mas bawas ang side effects. Hindi kagaya ng ibang synthetic anti-seizure drugs."

Mutia has called on Congress and leaderships of other medical groups not to make it difficult to patients and their parents who want to try and "possibly, it's a very effective option."

He said, it's also hard

to acquire compassionate special permit to avail of imported drugs made from medical cannabis. It was only in 2016 when CBD use was approved by Drug Food and Administration (FDA) because there were those who tried to get it via "underground" but found the compound to be effective.


