PRESIDENT Ferdinand "Bongbong" R. Marcos Jr. graced the "Handa Pilipinas" Visayas Leg – a celebration commemorating the 10th anniversary of the catastrophic super typhoon "Yolanda" on Nov. 8, 2013 in Tacloban City.

The exposition led by the Dept. of Science and Technology (DOST) held in Summit Hotel, from Nov. 8-10 tackled "Innovations in Disaster Risk Reduction and Management Exposition."

The president said what happened 10 years ago "underscores the importance of disaster risk reduction and management." The Filipinos' spirit is incredible, he added. "Our ability to come together to

support one another, to rebuild during such adversity is always an inspiration."

The event is an annual exposition of innovations in Disaster Risk Reduction and Management (DRRM). This year's theme is "STY Yolanda remembered: understanding Risks and Preventing Future Disasters."

Ayala-led group's second data center breaks ground in Cavite

MANILA -The Ayala Group is spending about \$78 million to build a second data center in Cavite as it beef up its portfolio of facilities storing critical servers and enabling the flow of data in the advent of artificial intelligence (AI) and digitalization.

On Monday, Ayala-led ST Telemedia Global Data Centers (STT GDC) Philippines held groundbreaking ceremony for STT Cavite 2.

The 6-megawatt (MW) data center is a two-story building with a gross floor area of over 4,500 square-meters.

The data hub is



targeted to be opened by mid-2025. By that time, the Cavite portfolio will

have about 11-MW capacity in total.

DOST: EARTHQUAKE DEATHS, DESTRUCTION ARE PREVENTABLE

WE should bear in mind that deaths and destruction due to earthquake are preventable, according to Secretary Renato U. Solidum Jr. of the Dept. of Science and Technology (DOST). Of all natural hazards also, earthquake is the deadliest disaster



accounting to 58% of total disaster deaths between 2000-2019, according to the United Nations Office for Disaster Risk Reduction (UNDRR) report as announced by Solidum, during the Ceremonial Pressing of the Button for earthquake drill in Tacloban City last Thursday, Nov. 9.

"By now, Filipinos must already know and appreciate what an earthquake disaster means. It is highly likely that we know someone, if not ourselves who experienced impacts of devastating earthquakes in the Philippines in the last two decades," the Science chief said.



One strong ground breaking, he added, "does not kill" but the collapsed houses, buildings and infrastructures. Often, the cause of the collapse is bad construction practices. It could be that the old or even new buildings do not meet today's standards.

Solidum said that tools of science should be known and understood "to assist in making earthquake resilient communities to prevent destruction and death."

DOST has developed tools or apps that are readily usable from PCs, laptops and mobile devices. Some of these are: FaultFinder –tells how far away is the house, workplace or school from earthquake source; Hazard Hunter – tells what are the natural hazards that can affect the neighborhood; GeoanalyticsPH – shows in maps and figures the hazards assessment of the neighborhood and PlanSmart- gives national and local planners the necessary information needed for their development planning needs.

Tacloban City Mayor Alfred Romualdez for his part said that a lot can be learnt from DOST. "I urge everyone, know where you live, surroundings ninyo pag-aralan ninyo para pagdating ng disasters nakahanda kayo," he told those present in the event.

Dir. Lord Byron Torrecarion, regional director from the Office of the Civil Defense VIII, thanked everyone for their participation in the simulation exercise. "For doing this drill, we hope to be better prepared and to keep us right on track to evaluate our shortcomings and to help us prepare for any future eventualities," he said in his closing remarks. **(Nelson Santos PAPI)**

NUTRIDENSE'S JOURNEY TO SUCCESS

WAYBACK in 2011, an entrepreneur sat in a four-cornered room, was listening, and passionately processing the talk of Engr. Rosemarie Garcia of the DOST-Food and Nutrition Research Institute (FNRI) on complimentary.



This happened during a food in a technology forum hosted by the Department of Science and Technology Regional Office 1 (DOST 1). Later, that forum would catalyze a long-term relationship with the DOST toward achieving a common goal -- to alleviate the malnutrition problem among Filipino children.

That entrepreneur was Mr. Racky Doctor. Behind his appearance lies a purposeful advocacy instrumental to his success in entrepreneurship.

In more than a decade-long partnership with DOST 1, this guy successfully established Nutridense Food Manufacturing Corporation, which soon became one of the country's leading licensed

food manufacturers of healthy, nutritious, and research-based food products.

Early beginnings:

Doctor's first company, Long Live Pharma, initially ventured on Hyposol or "Waterine" solution that serves as a drinking water disinfectant. It was in 2009 when he first availed of the Small Enterprise Technology Upgrading Program (SETUP) assistance, which helped them acquire equipment to increase productivity and improve packaging.

SETUP is DOST's flagship program to address the needs and requirements of various enterprises through the provision and upgrading of technology and equipment, fortifying their innovation capability, increasing productivity,

and producing quality products that further the attainment of sustainable and inclusive growth in the country.

Eventually, Doctor established Nutridense Food Manufacturing Corporation, a subsidiary of Long Live Pharma (LLP).

His passion for producing new products and his burning desire to uplift nutrition problems, are both instrumental in the birth of Nutridense.

With the help of the DOST-FNRI and SETUP, Nutridense gradually permeated the food manufacturing industry. It also contributed to address the nutrition problem among Filipino children.

Advocacy-driven Nutridense came to light when the DOST-FNRI

offered Doctor the technology and formula to produce complementary food for children as part of the department's science and technology-based intervention program to address malnutrition.

Doctor immediately grabbed the opportunity, as he recognized the significant role of entrepreneurs in solving the problem.

In realizing the aim to alleviate malnutrition, Nutridense produced different food products specifically formulated to reduce the malnourishment rate in the country. These products include RIMO Curls, a rice-mongo curls snack, RIMO Blends, rice-mongo instant baby cereals, Momsie, a rich-nutty chocolate complementary food, brown rice bar, enhanced Nutribun, and Go and Grow, a micronutrient powder mix, among others.

With their nutritional benefits, some of these food products are currently used in the Department of Education and Department of Social Welfare and Development's (DSWD) supplementary feeding programs.

Nutridense also took significant steps in addressing anemia among Filipinos in 2016. The promotion and consumption of iron-fortified rice in La Union is one of Nutridense's answers to the said problem.

Doctor said Iron-Fortified Rice (IFR) is a well-milled rice mixed with mineral iron in rice kernel form. It is like ordinary rice but contains more iron which prevents Iron Deficiency Anemia among the people.

To this day, Nutridense continues to produce

these goods. The mission to realize their advocacies continues to roll on.

Starting a new business is challenging. Even if Doctor had a prior business with LLP, buying the equipment needed to produce food products was quite a handful. Then the DOST-FNRI and SETUP supported him in acquiring the technologies and equipment needed to operate the business.

Some of the FNRI-developed technologies are the IFR and RIMO blends. The FNRI was instrumental in the early development of the firm, as it assisted in the supervision of equipment test runs and trial productions.

In 2015, SETUP provided the equipment like two-screw kernel extruders and blending machine, to commercialize the technologies.

SETUP's intervention and FNRI's food formulas were vital in the significant increase of gross sales and volume production of Nutridense.

The former attendee of a forum is now an established entrepreneur, who received recognitions and spoke on different forums and events for his advocacy-driven enterprise.

His previous awards include FNRI-DOST's Scaling-up Rice Fortification and Kabalikat Award. Doctor also served as a speaker on nutrition during emergencies, malnutrition reduction and complementary feeding, among others.

He was also one of the Science, Technology, and Innovation (STI) Ambassadors of this year's Regional Science, Technology, and Innovation Week (RSTW) in Laoag City, Ilocos Norte from October 16 to 18.

"As one of the chosen science ambassadors, together with our esteemed ambassadors awarded today, I commit to support STI programs and activities in Region 1 and personally join to bring science to everyone," Doctor said in his short speech as an STI ambassador during the opening of RSTW 2023 on October 16.

With Nutridense's accomplishments and effective adoption of DOST's technological intervention, the DOST-1 also recognized him as the Regional Winner of the 2023 Most Industry 4.0-Ready (I-Ready) Award in the Pinna-SciGLAT Awards of the recently concluded RSTW. "Your continuous assistance in mentoring us and our co-MSMEs, through your programs, has elevated a lot of lives, families, and communities. This I-Ready award ignites another opportunity for Nutridense and a reminder to be always better in serving our customers," Karl Doctor, the elder Doctor's son, said in his acceptance speech.

Today, the businessman serves as an inspiration to every aspiring entrepreneur in founding a company with a cause. While there are risks in establishing enterprises, DOST's programs, like SETUP and research institutions, such as FNRI, are more than willing to lend a hand for the betterment of Filipinos' lives.

In the case of Nutridense, Doctor successfully grew the business by fusing flavors towards the cause of alleviating nutrition problems among Filipino children with the help of DOST. (Patrick R. Balanon)

CHIZ SAYS HE WILL SCRUTINIZE 2024 BUDGET TO ENSURE ITS PRO-PEOPLE

Senator Chiz Escudero vowed to scrutinize the proposed ₱5.768 trillion 2024 General Appropriations Bill (GAB) once it is taken up at the plenary to ensure that next year's national budget truly supports the needs of the people.

In a media interview yesterday morning, Escudero disclosed he will give special attention to the three sectors that he has been championing since entering government service, namely, the local government units (LGUs), education and agriculture.

"Tatlong bagay ang prioridad na tututukan ko kaugnay sa ating 2024 budget," the veteran legislator said, three days after Senate President Miguel Zubiri received from House Speaker Martin Romualdez the GAB on Saturday. It was sponsored by Sen. Sonny Angara at yesterday's plenary session.

Escudero's three-point priority will be to bring back the concept of "parametric insurance" to facilitate the payment and release of

funds to affected local governments in times of disasters; make sure payments are made to the State Colleges and Universities (SUCs) for the extra amount they spent in 2022 and 2023 in the implementation of the Universal Access to Quality Tertiary Education Act (UAQTEA); and craft a budget for the Department of Agriculture (DA) that will support the priority programs of the new secretary.

"I would like to bring back the parametric insurance in so far as providing insurance coverage to often calamity-stricken areas, particularly the eastern seaboard of the country," Escudero said. "Parametric insurance is based on how strong the typhoon signal

was. Kung signal number 1 iyan, ganito lang ang bayad, signal number 2 ganito naman, etc. Total payout na 'yun. Hindi na kailangan ang inspection at madaling mare-release ang pera."

The senator said it was the practice until Congress removed it in 2019 and he hopes to bring the system back in the 2024 national budget.

"It will be under the Calamity Fund (CF). We did that before and we intend to do that again. We initially allocated only P1 billion to pay for the premiums," he pointed out, adding that the insurer will be the Government Service Insurance System (GSIS).

"Maliit lang premium pero malaki ang payout. Can you imagine, P1 billion

lang inalocate natin to pay for premiums in 2018, and what we got was P7 billion. So, the government can do well to do this again and charging it against the Calamity Fund thereby multiplying the potential benefits the CF can give to the affected areas," he said.

As chairman of the Senate Committee on Higher, Technical and Vocational Education, Escudero said he is bound to correct the deficiencies "not only in the basic education sector but in the higher education sector, too."

"Given that we have unpaid fees in the Free Tertiary Education Act to about 80 SUCs, we would seek to correct that in the

2024 budget," Escudero said.

On the DA budget and support to the agriculture sector, the Bicolano senator said he will help the newly-appointed Agriculture Secretary Francis Tiu Laurel realign available funds in order for him to do his job well.

"Again, for reference purposes, the flood control item in the DPWH budget is P215 billion while the budget for the entire agriculture sector is only P181 billion. Hindi naman tama at makatarungan iyon," he stressed.

"Secretary Tiu Laurel can still realign the budget for agriculture for 2024 to suit his priorities and his programs. Tandaan n'yo, ang nag-prepare naman ng budget na ito, hindi siya. So, baka yun mga priority and programs



diyan, hindi aligned sa pinag-usapan nila ni Pangulong Marcos. So tamang-tama lang ito, ma-adjust pa 'yung budget so he could actually perform and do what he intends to do and give him the support he needs on the part of congress," Escudero said.

The Phase 1 of the LRT1 Cavite Extension Project covers the first five additional stations spanning 6.7 kilometers within the city of Parañaque, namely Redemptorist, MIA, PITX Asia World, Ninoy Aquino, and Dr. Santos.

In a statement on Friday, LRM said the Phase 1 of the project was at an overall progress rate of 94.1% for its civil and system works as of end-September 2023.

"We are optimistic that in less than a year, we are to begin the commercial operations of the LRT1 Cavite Extension Phase 1 Project. The overall progress rate is a good signal to usher the country into an era of modern railway experience where

passengers can take advantage of world-class amenities, user-friendly and PWD-friendly facilities, high standards of safety and security, and value-added services," said LRM president and CEO Juan Alfonso.

The construction of the first five stations of the LRT1 Cavite Extension Project are in various stages of development.

LRM said the Redemptorist Station, which will be the next station after the existing Baclaran station, registered an 86.3% completion rate.

The MIA Station, which will be the closest station to the airport, was at 86.9% completion; while the Asia World Station, which will be connected to

the Paranaque Integrated Terminal Exchange (PITX), was at 72.9%.

Meanwhile, the Ninoy Aquino Station registered a completion rate of 81.5%.

The last station of the phase, Dr. Santos, which will have an interconnection to the nearby SM City Sucat, was at a 90.5% completion rate.

As to the Cavite leg of the project, the company earlier said that delays in the delivery of right-of-way are hampering the start of ground works.

The segment covers the last three stations of LRT1 Cavite Extension Project, namely Las Piñas, Zapote, and Niog.

LRM had said right-of-way delivery for the three stations should be "100%" before it can start construction.—AOL, GMA Integrated News

STT GDC Philippines president and CEO Carlo Malana said this digital infrastructure was capital-intensive, requiring them to earmark about \$13 million per megawatt.

Starting its second major data center project this year is in line with the goal of STT GDC Philippines—a joint venture among Globe Telecom Inc., Ayala Corp. and Singapore-based STT GDC—to increase data center capacity to 150 MW in the coming years.

"As the Philippines sets

its sights on a digital future and rapidly expands its digital capabilities, this forward momentum makes the need for robust digital infrastructure and rich network connectivity even more critical," Malana said.

Globe CEO Ernest Cu noted that AI is among the demand drivers for data centers in the country given the modern technology's massive data storage requirement.

In May, the joint venture company held a groundbreaking ceremony for its 124-MW data center

in Fairview, Quezon City. It will be spending about \$1 billion to construct the facility sprawling over 83,000 square-meters of gross floor area across four buildings.

Construction for the first phase of the project, comprising 28 MW, has started. It is set to go live by early 2025.

Last month, it also completed the construction of a 1.2-MW data hall in Makati.

"With the right critical infrastructure in place, businesses can thrive in the digital realm and citizens can reap the benefits of a digital society," Malana said.

Leyte Governor Carlos Jericho Petilla said that "we can't really prepare enough" referring to the forthcoming disasters, but preparation should be to the maximum. "We have to see disaster as a science and a solution as a science," the governor told the even attendees. "I wish we can eliminate disasters but we can only do reduction."

In the afternoon, during the presentation of the Disaster Preparedness Technologies forum, DOST presented projects such as abaca-fiber reinforced composites for transport; collapsible toilet bowls; upgraded emergency disinfection system; rainwater collection system; and emergency food reserve.

It has been over a decade when advocates and medical cannabis supporters have been pushing for the legalization of its use as medicines. "It is more important to demystify and allow people to form their own opinions, to make their own control rather than to make external controls," Ayala explained in support of the move to legalize marijuana use as medicines for epilepsy, chronic pain, nausea and vomiting and multiple sclerosis, age wasting syndrome, among other ailments.

Ayala was one of the panelists in this week's Media Health Forum of Bauertek Corporation with Dr. Richard Nixon Gomez as its general manager. Other regular panelist was Dr. Gem Marq Mutia, a specialist in adult medicine and founder of Philippine Cannabinoid Medicine, who said that the use of marijuana as medicine started centuries ago. "Wala ng mas tradisyonal pa sa marijuana" he said and when it comes to mainstream medicines or western conventional medicines, the plant has also undergone clinical trials and proven to be effective.

It is disheartening to note however, that only one patient was granted a compassionate special permit to buy the imported marijuana oil but nobody has availed yet because of additional processes to purchase the medicine.

Mutia mentioned national hero Dr. Jose Rizal who was able to buy marijuana medicine from a pharmacy in 1879.

Ayala said he prefers to use marijuana if he's looking for "something relaxing." Its use is not as bad as soft drinks, alcohol, coffee, he said.

Gomez said that anxiety and depression can also be cured by marijuana medicine. "Medical cannabis immediately matutulungan ka sa anxiety, depression," he said rather than waiting for doctors for appointment and who charged exorbitant fees.

Mutia meanwhile explained that our body has endo cannabinoid system and known as stress-management professionals.

Ayala on the other hand, explained that he doesn't use marijuana for his performance but as muscle relaxant. He is well known for his style of music that combines the sounds of Filipino ethnic instruments with modern pop music.

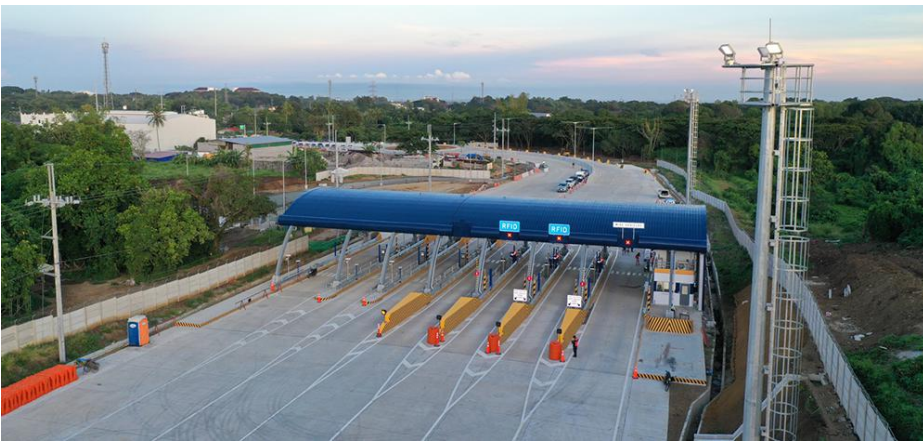
