# A big step in the quest for climate justice

HE United Nations General Assembly has adopted by consensus a resolution introduced by Vanuatu to request the International Court of Justice to define the "legal consequences" for states which "have caused significant harm to the

for states which "have caused significant harm to the climate system and other parts of the environment."

The resolution, co-sponsored by more than 130 member-states, has been hailed as a giant step in determining the legal responsibility countries have for the changing climate and its impacts.

The resolution reflected the frustration not only of Vanuatu but other vulnerable countries over the huge disparity between the rhetoric and action on climate change.

The climate summit in Glasgow in 2021 had held out a lot of promise for a global effort to finally limit warming to manageable levels. That goal eventually proved to be overambitious. Unable to reach a consensus, the participants settled for a watered-down agreement to submit a more viable plan the following year to cut emissions in 2030, and pledged faster reductions in coal use and fossil fuel subsidies.

The summit also dodged the sensitive issue of making rich polluters pay reparations to countries that sustain heavy losses from extreme weather events.

The plan was for developed countries to pay poorer ones \$100 billion a year for climate change mitigation by 2023. That amount turned out to be paltry, after studies showed the costs of climate change running into the trillions.

The unfulfilled pledges only fueled the disillusionment in island nations like Vanuatu, which is threatened by sea-level increase by as much as a meter.

Adding to Vanuatu's woes are two cyclones that devastated the country earlier this month and affected

80 percent of its population.

The inconvenient truth is that the most climatevulnerable countries contributed the least greenhouse emissions that cause climate change and yet suffer the very worst of its impacts.

And economic giants like the United States and China, the two biggest emitters of greenhouse gases, go scotfree.

The Vanuatu resolution has been worded in such a way that it does not implicate anyone. It instead requests the court's opinion on "what are the obligations of states... to ensure the protection of the climate system and other parts of present and future generations" based on international treaties and principles of international law.

It also asks: "What are the legal consequences under these obligations for states which, by their acts and omissions, have caused significant harm to the climate system and other parts of the environment?" According to the lead counsel for Vanuatu, the


According to the lead counsel for Vanuatu, the resolution "strikes a careful balance between a climate justice-focused dimension and a forward-looking dimension. It recognizes that we must draw lessons from the past to build a just and sustainable future and that international law has a role to play in correcting our current trajectory."

The International Court of Justice will have two years to come up with an opinion. It will be nonbinding, but Jorge Viñuales, a law professor who helped draft the resolution, believes "it's going to shape the discourse" on assigning accountability for climate change. For Harjeet Singh of Climate Action Network, an international NGO, the ruling "will serve as an important accountability tool," and sees it as "potentially one of the biggest climate diplomacy and multilateral successes in the recent past."

Vanuatu's ambassador to the UN is urging the global community to act now. "Extreme weather events are becoming the new normal in our country as a result of climate change. For low-lying countries, it's an existential threat," he said.

Jotham Napat, Vanuatu's minister of foreign affairs, international cooperation and external trade, looks at international law as "a vital tool in establishing and delivering climate justice. In the most vulnerable parts of the world, it is often all that stands between climate resilience and catastrophe, between prosperity and destitution."

Approving the resolution may be "history-making," as UN Secretary-General Antonio Guterres jubilantly described it. But no one should be lulled into believing that the task ahead will be an easy one.

# Batangas City buri leaf weavers underwent a training on indigenous fibers Batangas City buri leaf weavers underwent a training on indigenous fibers dyeing technology to streamline their dyeing processes and improve the quality of their products, held at the Research Training Center, Office of the City Veterinary and Agriculture, Bolbok, Batangas City, March 07-08.



The Department of Science and Technology (DOST)-Batangas and the DOST Philippine Textile Research Institute (DOST-PTRI) conducted the twoday training in response to the call for science and technology-based intervention of the Batangas City Agriculture Office, to improve the

existing dyeing practices of buri leaf weavers who are also members of the Batangas City Rural Improvement Club Marketing Cooperative.

The participants were trained to conduct pretreatment processes on raw materials and dye indigenous fibers using synthetic dyes. An


overview of the steps involved in making textiles, including how dyeing procedures may be integrated, was given to the participants. According to DOST-PTRI experts, the dyeing process can be combined with other processes, such as spinning, weaving, and finishing, to create a more

use of equipment, and chemical formulation, as well as other aspects of the pretreatment process, were described and demonstrated to the participants. Before dyeing, the raw materials were put through the neutralization process. The participants were provided a computation of the chemical formulation to be used during the neutralization process.

Scouring, bleaching,

The training also covered discussions on the types and differences of synthetic dyes and the method of computing and





measuring the amount of chemicals needed to dye indigenous fibers. Participants underwent a hands-on exercise on dyeing buri leaves and rattan. Precautionary measures on handling chemicals and the use of equipment were observed during the training.

Characteristics of buri, including its economic and industrial importance, were explained to the participants. As the largest native palm species in the Philippines, buri reaches a height of 20 meters, with trunks attaining a diameter of about 1 meter. In Batangas City alone, the abundance of buri led to the production of handicrafts such as bags, baskets, and mats, all from buri leaves.

lechnical experts from the DOST-PTRI facilitated the technology training. Ms. Mylene S. Dacuya, Science Research Specialist II, was the lead resource person, while Mr. Samilo Garcia, Science Aide, was the training assistant. Engr. Charmaine Pearl Aquino and Ms. Charmaine P. Valdez, also from DOST-PTRI, served as training facilitators.

San Juan, Ternate, Cavite, the original and actual possessor of Lot No. 497, CAD-617-D, Extn., Ternate Cadastre, with area of 11, 728 Square Meters, in Brgy. San Juan-1, Ternate, Cavite. Luisa Diones-Caparros was first to occupy the land since time immemorial, her occupation had always been open, peaceful, public and notorious and in the concept of an owner;

2. Petitioner Nioda has this lot surveyed, approved by the then Director of Lands (now LMB), Dir. Ramon Casanova which was subsequently endorsed to District Land Office (DLO), Rosario, Cavite;

3. To Petitioner's surprise, the District Land Officer (DLO) Jose Apostol who gave us the survey authority in 1975, then he was also the same Officer gave another survey authority to Respondent Benjamin Puzon a resident of 6 Ifugao St., La Vista, Quezon City, Metro Manila, that they never occupied nor possessed the lot claimed by them;

4. In September, 1976, Benjamin L Puzon, Et. Al. came to our property claiming that they owned a Patent Titles and on December, 1976 he came back with men poking guns and destroy our old house and all crops, ccoconut trees and mangoes fruit trees,

without a court order;

5. The record of Petitioner's mother Tax Declaration over the said lot was among burned on June 7, 1959 old Cavite Capitol Bldg. burning;

6. What is highly irregular was that a person not in actual possession of the property cannot apply for free patent over the same much less a corporation, by virtue of the fact that under the law, the legal re- quirement in Free Patent Application is the actual occupation and residence by the applicant. Respondent's Felisa S. Puzon was issued a spurious patent title, even she is a stranger, without the origin and actual possession nor she never set foot over Lot No. 543, PSC-21 with an area of 11, 747 Square Meters. It is a crystal clear of fraud, injustice resulting to damage and prejudice not only of the herein petitioners but also on the interest of the government in general, copy of which is hereto attached as Annex "A";

7. The Free Patent issued to Felisa S. Puzon has no approved plan and the OCT No. P-501 was issued on June 15,1976 has no signature of Atty. Milagros S. Santiago, the then Register of Deeds for the Province of Cavite. Based of the Tie Line, the location of the lot claimed by herein respondent is at Labac, Naic, Cavite and not the property of Elenisa C. Nioda, copy of which is hereto attached as Annex "A-1, and "A-2";

### B. TEODORICO G. VELASCO:

1. Petitioner Teodorico G. Velasco is the son of the late Casimero Velasco, a native settler of San Juan-1, Ternate, Cavite the first and actual occupant in the concept of an owner since American regime of Lot No. 498, CAD-616-D, Extn., Ternate Cadastre with an area of 17,426 Square Meters, in San Juan, Ternate, Cavite;

2. In 1975, the subject land was surveyed under the authority of Director Ramon Casanova of the Bureau of Lands (now LMB) as well as the District Land Office in Rosario, Cavite which gave the survey authority and conducted actual inspection of the said lot;

3. In 1976 Respondents, with use of force entered and destroyed our old house, etc. and drove us away therefrom with help of their armed men, without a court order and they are violated in our Bill of Rights, Article-111, Section-1, the Philippine Contitution;

6. The actual location of the property claimed by Benjamin L Puzon Is located at Brgy. Labac, Naic, Cavite based of their Tie Line, Tie Point, which is outside the property of Teodorico G. Velasco;

### C. SOLEDAD VELASCO-ARAZA:

1. Petitioner Soledad Velasco-Araza is the daughter of the late Nieves Glorioso-Velasco who was the original- actual occupant of her property since time of immemorial denominated as Lot No. 499, CAD7-D, Extn., Ternate Cadastre, Cavite with an area of 37, 771 Square Meters, located at San Juan-1, Ternate, Cavite;

2. Like what happened to the other properties, Respondents were able to drive away the Petitioner with the assistance of their armed goons and was able to secure a Free Patent No. (1V-4) 1438, OCT P-2537, Lot No. 607, Psc-21, Ternate Cadastre, with an area 31, 909 Square Meters, despite the fact that he was not the actual occupant of the property claimed by him, copy of the said OCT Title is hereto attached as Annex "C";

Petitioner Alegria Velasco-Selverio is the daughter of the late Eugenio Velasco, a native settler of San Juan, Ternate, Cavite the first and actual occupant/possessor of lot No. 511, CAD-617- D, Extn., Ternate Cadastre, with an area of 23,497 Square Meters, located at Brgy. San Juan-1, Ternate, Cavite however The Tax Declaration of Eugenio Velasco was among those destroyed by fire incident onJune 7, 1959;

2. In 1976, Respondents forcibly ejected the petitioner, destroyed their old houses,

ccoconut trees, old mangoes trees, etc., and sequested all that Petitioners have raised without a court order. Subsequently a Free Patent was applied by Evangelin L. Puzon a resident of 6 Ifugao St., La Vista, Quezon City, Metro Manila;

3. Hence, Free Patent No. 14668, OCT No. P-2805, Lot No: 541-B, Cad-9720 issued to Evangeline L. Puzon and later on transferred to TCT No. 209838 was simulated and a fraud. She was not qualified to be issued a Free Patent. Further, the lot claimed by her is outside the property of the petitioner, copy of the title is hereto attached as Annex "H".

#### III CONCLUSION

It is crystal clear that Petitioners are entitled to the reconveyance of the properties they originally occupied. The Free Patents issued to the Respondents were null and void as well as their derivative titles.

> IV PRAYER

WHEREFORE, premises considered, Petitioners respectfully pray that:

1. An Investigation be conducted on the properties acquired by the Respondents through force and fraud;

2. The applications for Free Patent be declared null and void the titles and their derivatives be cancelled and declared fictitious;

3. The properties originally occupied and possessed by them be reconveyed to the petitioners.

Other reliefs just and equitable in the premises are likewise prayed for.


