Misamis Oriental receives an award from the Department of Science and Technology as the agency's most industry 4.0-ready assisted MSME. This national-level recognition, dubbed as the iREADY award, was received by AJIS Dive and Aqua Sports Inc. on November 22, at the National Science and Technology Week celebration opening ceremony

The iREADY award is a nationwide award by DOST that aims to recognize MSMEs that are poised to adopt Industry 4.0 technologies in their operations. The readiness index was determined based on the following readiness pillars: organization, data, hardware, software, and people. A cash reward of Php 100,000.00 was awarded to the firm.

As the pioneer fiberglass speed boat manufacturer in Northern Mindanao, AJIS has been using various technologies in their daily operations to produce quality boats that are now being sold in various parts of the country, such as Manila, Cebu, Palawan, Tawi-tai, and more. Among these technologies are sensor technology, real-time location systems, and machineto-machine communication.

In their production facility in Opol, Misamis Oriental, the firm uses an established process in their data collection as part of their data quality practices and follows an IT security protocol for data protection. AJIS also utilizes a production planning software integrated with other softwares for more efficient and systematic operations.

The firm also aims to use Radio Frequency Identification, 3D scanners and more advanced technologies in the next five years.

The firm received its first DOST assistance in 2019 through the Small Enterprise Technology Upgrading Program (SETUP), to which they acquired a 2-Axis CNC Router with Rhino 3D Software - a computercontrolled cutting machine for different types of surfaces. The CNC Router machine enabled the firm to significantly improve the quality of their boats, especially for 17 and 36-footer speed boats and

The firm noted an increase in their gross sales and



their manpower since the DOST assistance, which contributed to their growth from micro to a small enterprise.

The use of technology is part of the daily operations of the firm, as confirmed by president, Mr. Allan Sagrado. In an interview, he said that the firm is willing and ready to adopt systems and technologies for a more productive company. He also expressed his thanks to DOST. "Thank you DOST for helping us build our dream boats. We will never stop dreaming," he said.

Safety: DOST-CALABARZON facilitates FST Training of Trainers (By Clarenz Polo B. Ocampo)

The Department of Science and Technology (DOST)-CALABARZON conducted its Food Safety Team (FST) Training of Trainers at Monte Vista Resort, Calamba City, Laguna from 7-10 November.

Staff from the different Provincial Science and Technology Offices (PSTOs) of DOST-CALABARZON, Laguna Polytechnic University (LSPU)-San Pablo City Campus, Southern Luzon State University (SLSU)-Lucena Campus, Department of Trade and Industry (DTI)-Rizal, and the Department of Labor and Employment (DOLE)-Rizal has attended in order to further support, monitor, and enhance the Micro, Small, and Medium Enterprises (MSMEs) in the region.

The 4-day training was spearheaded by the members of the DOST-CALABARZON Food Safety Unit (FSU), Ms. Diane Z. Ulan, Science Research Specialist II; Ms. Amiel G. Lacdan, Project Technical Assistant I; and Maria Ramiella E. Morales, Technical Project Assistant I.

On the first training day, Mr. Mhark Ellgine A. Libao, Research Science Specialist II, and Mr. John Maico M. Hernandez Science,

Specialist I of PSTO-Batangas then presented a lecture on Basic Food Hygiene. Ms. Niña Sherylle Giron, Science Research Specialist II of PSTO-Rizal conducted the workshop. On the second day, Ms. Wilma G. del Rosario Science Research Specialist II of PSTO-Laguna, and Ms. Maria Teresa A. Pamplona, Science Research Specialist I of the DOST-CALABARZON Regional Office (RO) discussed Food Safety Hazards. Meanwhile, Ms. Anna Marie Sisante-Daigan, Research Science Specialist II of PSTO-Cavite, and Mr. John Michael A. Florendo, Science Research Specialist II of PSTO-Quezon discussed Good Manufacturing Practices on the third day.

In the last session of the Research training, Ms. Marfil M. De

Food-Drug Regulation Officer III of the Center for Food Regulation and Research (CFRR)-Licensing Section, and Ms. Pia M. Flora Food-Drug Regulation Officer II of the CFRR-Registration Section of the Food and Drug Administration (FDA) lent their expertise to the topics of FDA - License-to-Operate (LTO) and

Certificate of Product Registration Application Process.

Ms. Emelita P. Bagsit, Regional Director and Engr. Francisco R. Barquilla III, Assistant Regional Director for Technical Operations of DOST-CALABARZON capped off the FST Training of Trainers with a Pledge of Commitment in order to uphold the duty of the new members of the FST for a stronger and safer CALABARZON. "Taking this pledge, I recognize that our role extends far beyond job our descriptions. I am an ambassador of food safety, an advocate for our local food MSMEs, and a steward community's well-being."



Public participation sought for sea turtle protection

In an effort to promote and strengthen turtle conservation efforts in the country, seven Biology students from Polytechnic University of the Philippines (PUP) - Manila launched an environmental conservation organization called, 'One Pawikan'.

Established in April 2021, the group routinely conducts series webinars and joins online dialogues to stress the importance environmental and sea turtle conservation in the Philippines.

In an interview with the Philippine Information Agency IV-A, founder Mark David De Guzman said they partner with the Department **Environment and Natural** Resources (DENR), local government units and people's other organizations in managing and protecting sea turtle hatcheries in different parts of the country, including Barangay Labac,

Naic, Cavite, Barangay La San Narciso, Zambales, and in Barangay Pag-Asa in Bagac, Bataan.

During the annual turtle nesting season, One Pawikan holds Pawikan Patroller for a Day, an immersion project participated by youth, students, and professionals who want to experience the work of a 'Pawikan Patroller', and aims to teach them about the biology and proper conservation of sea

Last January 15, 2023, the Pawikan Patrollers from Barangay Labac, Naic, Cavite together with selected students from Pamantasang Lungsod ng Maynila, Universidad de Manila, and University of the East - Manila released the first batch of Olive Ridley hatchlings. (CO/One Pawikan/FACEBOOK)

"When we catch a nesting sea turtle, we will teach them how to retrieve the turtle eggs, at the same time, we will measure and weigh them and tag them before returning them to the ocean. Early in the morning, we will release the turtle hatchlings," De Guzman explains.

But the work doesn't end there. According to De Guzman, in 1,000 sea turtles released into the wild, only 1% has the chance to survive and

reach their adulthood stage due to ocean pollution and appeals to the public for active involvement in case reporting.

"Therefore, I encourage everyone to stay vigilant, especially in communities near the sea where there are sea turtles, and immediately report to the LGU or néarest DENR Office."

How can the public, especially the youth, contribute to the preservation of sea turtles? De Guzman said that discipline and involvement to the cause are important.

The group's founder said: "The proper disposal of waste in its designated area is important; the avoidance of single-use plastics which we know contribute to the loss of some of our marine resources, including sea turtles, the support for a

zero-waste lifestyle which promotes the use of reusable products to reduce waste generation in our community; and the adherence environmental laws and ordinances in their respective areas."

Volunteering in various

environmental activities such as tree-planting and coastal clean-up events, and donating environmental groups can also help to amplify and sustain the advocacy for marine ecosystems, De Guzman believes. (CO,CH/ PIA-4A)

The President also commended the US chairmanship and hosting of APEC 2023, which he said has provided them with a forum to \overline{do} important works in the past two days.


While in Los Angeles, Marcos will meet the Filipino community there as well as business leaders and other entities.


