# COMELEC JUNKS LAST 'DO'' CASE VS BONGBONG MARCOS

PRESIDENTIAL frontrunner, former Senator Ferdinand 'Bongbong' Marcos Jr., said his party Partido Federal ng Pilipinas (PFP) is very happy that the disqualification (DQ) case lodged by a group of Ilocano, was junked by the Commission on Elections (Comelec) on Wednesday (April 20).

"It's a welcome development... we are happy that it happned before we came up with the actual elections," said Marcos who is also known for his monicker, 'BBM'.

The Comelec dismissed the DQ plea filed by the group Pudno nga Ilokano, for "lack of merit."

In an interview, BBM's spokesman Atty. Victor Rodriguez said that the junking of the last DQ case also ruled that Marcos "possesses all the qualifications needed to aspire for, campaign and serve as president of the Republic of the Philippines."

Rodriguez in a statement to media said: "As advocated, elections are settled through the ballots on election day - not through the abuse of our judicial processes like the filing of nuisance petitions for disqualification."





**WHEREAS**, presented to the Honorable Members of the Sangguniang Panlalawigan, for review and consideration, is a letter from Hon. Juanito Victor C. Remulla, Provincial Governor;

**WHEREAS**, the curfew hours currently implemented in the Province of Cavite is from 10:00 PM to 4:00 AM the following day, as per Provincial Ordinance No. 342-2022, which amended Provincial Ordinance No. 268-2020;

WHEREAS, since 01 March 2022, the Province of Cavite is under Alert Level 1, the least strict among the alert level classifications for COVID-19 restrictions in the country, as it is already one of the areas in the country with low risk status for COVID-19;

WHEREAS, there is a continuing decrease in confirmed and active COVID-19 cases in the Province of Cavite and in the Philippines as a whole;

WHEREAS, in view of the lighter restrictions and downward trend of confirmed COVID-19 cases, it is deemed appropriate that curfew hours be temporarily suspended;

**NOW**, **THEREFORE**, on motion of Hon. Ambion, duly seconded by Hon. Gawaran and unanimously approved by the members present, be it enacted by the Sangguniang Panlalawigan of Cavite in a session duly assembled that:

**Section 1.** The effectivity of Provincial Ordinance No. 268-2020, "Curfew Hours for the Province of Cavite due to COVID-19", as amended, is hereby suspended in view of the continuously decreasing number of COVID-19 cases in the province.

Section 2. This ordinance shall take effect immediately after its approval.

# STCIERD explores DOST-CALABARZON-developed online database for R&D programs and projects in the region

Last 7 April 2022, DOST-CALABARZON, through the Human Resources Committee of the Southern Tagalog Consortium for Industry and Energy Research and Development (STCIERD), hosted a virtual orientation on the Exchange of Probes, Learnings, and Outputs of Researchers (EXPLORE), from 9AM to 12NN via Zoom platform. EXPLORE is a database that aims to be the central repository of research programs or projects of government agencies and academic institutions in the region.

With the goal of sharing R&D information between and among researchers and organizations, EXPLORE hopes to encourage more projects, R&D publications, generate intellectual more properties, and further strengthen linkages and collaborations in the research community.

Dr. Tirso A. Ronquillo, Chair of STCIERD, gave the Opening Remarks and encouraged the consortium to enrich the said repository as part of its key performance indicator

"The end goal, really, is to see each other?---that to me is the immediate goal of EXPLORE?-to know what each other is doing, to know what each other have found recently so we can incorporate and align them [studies] or use them as a source of information for future researches," Dr. Ronquillo said.

He continued, "After this webinar, I hope that all of us who are attending will further explore this with other researchers?-our students and faculty, even."

Engr. Francisco R. Barquilla III, Assistant Regional Director for Technical Operations, led the discussion and walked the member agencies through EXPLORE's objectives, key features, status, users and contributing agencies in the region.

He said that while the EXPLORE was developed by DOST-CALABARZON, the said information system is owned by the Regional Research and Innovation Committee (RRIC) of the Regional Development Council (RDC) - CALABARZON.

Urging his fellow agencies to share their research projects, Engr. Barquilla mentioned the importance of the EXPLORE in exhibiting the current Science, Technology, and Innovation (STI) environment of CALABARZON.

"If that will be the part of the report of RIIC sa napakaganda RDC, niyang data," Engr. Barquilla remarked, "Kung mas maraming research at mas maraming project na nainput dito [EXPLORE], it means very healthy and very active ang ating STI dito sa CALABARZON."

In CALABARZON, there are currently 66 users and 30 agencies and institutions enrolled in the system. A total of 508 R&D projects are also stored.

Furthermore, EXPLORE had also been adopted by DOST-VIII's Regional Research, Development and Innovation Committee.

After the lecture, an open forum was



conducted to address the participants' concerns regarding the system. Dr. Lorcelie Taclan, STCIERD Director, delivered the

closing remarks. Dr. Taclan thanked the participants and said, "I

1. Petitioner MARIA TERESA B. YI is of legal age. Filipino, married, and a resident of Block 2, Lot 3, Diamond St., Goldenville II, Sabang, Dasmariñas City, Cavite. She may be served with summons and other legal processes at the undersigned counsel's address herein below indicated

2 . Respondent JANG GEUN YI is likewise of legal age, Korean, married, and whose residence is unknown. He may be served with summons and other legal processes by publication as may be ordered by this Honorable Court.

#### THE ANTECEDENT FACTS

1. Petitioner and respondent crossed paths sometime in 1995 at Rizal Stadium, Quezon City in an event organized by the Holy Spirit Association Unification World Christianity (HAS-UWC) called Matching/Blessing wherein Filipino women were being matched with male Korean nationals

2. Considering that petitioner was an old member of the church organization having joined the organization in 1987, her presence was requested in the ceremony in which she was asked to wear a white dress and hold a photo of a man. After the event, petitioner was then informed by the leaders of HAS-UWC that her wedding with said man in the photo was pre-arranged by the organization and that the holding of the man's photo was a form of committing herself to the latter. Because of this, petitioner found it hard to renege the plan.

3. Persuaded by the church leaders and moved by her child-like conscience, petitioner married the respondent on June 25, 1996 at Branch 77 of the Regional Trial Court of Parañaque City. Copy of the Certificate of Marriage of the Philippine Statistics Authority is hereto attached as Annex "A" and forms an integral part hereof.

4. After the wedding, petitioner realized that love is not a bed of roses. What she thought of as a harmonious and peaceful union turned out to be the opposite. Respondent unveiled his true colors since the first day that they lived with each other as husband and wife where he demonstrated arrogance, negligence, cruelty and insensitivity. That humble, kind and generous man existed only in her dreams.

5. At the inception of their marriage, petitioner felt that she was molested and used by the respondent to satisfy his sexual pleasure. Respondent would force petitioner to drink and if she did not submit to him, he would beat her up.

6. Petitioner took a leave from work to attend to the needs of the respondent. She cooked for him, massaged him and washed his clothes but instead of being appreciative, respondent paid her back with heartache and physical pains. Petitioner never felt that she was a wife as respondent always made her feel that she was just his slave

7. Not only is the respondent a habitual drunkard, he is also a chronic gambler and every time he went home, he would engage in mentally-torturing fights with the petitioner. Much as the latter wanted to fight and evade from respondent's brutality, the latter would attack her heartlessly. Despite her delicate pregnancy with their first-born son, Kimiel B. Yi, respondent still exploited petitioner to suit his sexual urge.

8. After a month, respondent left for Korea and promised to provide financial aid for petitioner's delivery but he did not send a single centavo. After petitioner gave birth, she did not hear anything from the respondent until sometime in 1997 when the latter returned to the Philippines. Petitioner thought that respondent wanted to make amends with her but, on the contrary, the latter became more violent when the former did not yield to his demands.

9. After a week, petitioner again departed the Philippines without a word as to his whereabouts until he showed up again in 1999. The vicious cycle recurred and left the petitioner not only with scars but with so much fear for her safety and that of her child.

10. Soon after respondent left, petitioner found out that she was pregnant with their second son, Gio B. Yi. She tried to communicate with the respondent but all her efforts were rendered futile.

11. As years passed, petitioner no longer heard anything from the respondent. She learned to accept the fact that respondent will not come back anymore and instead of dwelling in her dark past, she worked hard to raise and send their two sons to school. Copies of their Certificate of Live Birth are hereto attached as Annexes "B" and "C."

12. Sometime in 2002, petitioner received a phone call from a woman who introduced herself as respondent's stepmother and told her that the respondent committed suicide and that he was already dead.

13. This unconfirmed news prompted petitioner to seek the assistance of the Public Attorney's Office to request from the Embassy of South Korea in the Philippines in verifying his whereabouts. To her surprise and dismay, the embassy did not provide information as to his whereabouts. What was issued was a Certification dated April 25, 2014, of the Acting Chief of Certification and Clearance Section of the Bureau of Immigration stating that the Bureau does not have any record in their database of the arrival or departure from January 1, 1999 to April 22, 2014 of a certain Jang Geun Yi Copy of the Certification is hereto attached as Annex "D."

14. Just recently, the Public Attorney's Office of Paranaque City wrote a follow-up letter addressed to the Bureau of Immigration on the whereabouts of respondent. There was likewise no information as to his whereabouts. Petitioner was issued a Certified List of Travel Records dated August 7, 2018 in which the respondent appeared to have arrived and departed from the Philippines on June 5, 1996 and June 27, 1996 and on November 24, 1997 and November 26, 1997. No other records of his departure and arrival were shown in their data base. However, petitioner is very sure that respondent arrived in the Philippines in 1999. Copy of the said certification is hereto attached as Annex "E."

15. Petitioner no longer wishes to wait in vain for respondent only to experience the same ordeal. Hence, she filed the instant petition.

#### DISCUSSION

1. The petitioner has engaged the services of Ms. Sheila Marie O. Montefalcon, MP, RPsy, RPm, a Clinical Psychologist, for the psychological evaluation of the petitioner, who will be presented as an expert witness in support of the instant petition.

2. Petitioner has undergone a series of clinical interviews and battery of psychological tests on July 7 and 17, 2018. A letter of invitation to undergo the same psychological assessment was no longer sent to the respondent whose whereabouts are unknown

3. The psychological tests administered by Ms. Montefalcon on the petitioner were: Bender Visual Motor Gestalt Test, Draw a Person Test, Sach's Sentence Completion Test, The Minnesota Multiphasic Personality Inventory, MD5 Intelligence Test, Personal Style Inventory and Hand Test.

4. Also interviewed by Ms. Montefalcon was the sister of the petitioner, Sandra Banogon-Pempil.

5. The findings of Ms. Montefalcon based on the results of the clinical interview and psychological tests on the petitioner and the corroborative witness as well as the background data and marital history of the parties are reproduced in the succeeding paragraphs below, culled from her Psychological Evaluation Report attached as ANNEX "F" hereof.

6. The reported behavioral manifestations of the respondent satisfy the criteria of a certain personality disorder which is clinically known as ANTISOCIAL PERSONALITY DISORDER characterized by the following:

a. Failure to conform to social norms with respect to lawful behaviors, as indicated by repeatedly performing acts that are grounds for arrest. His verbal (showering her with threats, insults and degrading words), emotional (making her believe in his lies, manipulating her), and physical (hitting, punching, spanking and throwing various things on her) abuse towards Petitioner clearly shows acts that were ground for arrest. He failed to fulfill his moral and financial obligation to his family because of his selfish whims and excessive laziness.

b. Deceitfulness, as indicated by repeated lying, uses of aliases or conning others for personal profit or pleasure. He was fond of deceiving Petitioner in order to achieve his ends.

c. Impulsivity or failure to plan ahead. He has no longer range plan for himself and his family, his main concern is on how he could gratify his infantile needs as indicated by his unstoppable happy-go-lucky way of living and inability to spend his money wisely.

d. Irritability and aggressiveness. Even in slight issues, Respondent displayed extreme anger and annoyance. x x x He was also inflicting domestic violence towards her

e. Reckless disregard for safety of self and others. Respondent did not show concern for his wife and children. x x x Petitioner experienced being verbally and physically assaulted by Respondent for so many times.

f. Consistent irresponsible. Respondent failed to honor his financial obligation to his wife and children despite being gainfully employed.

g. Lack of remorse. x x x He unendingly misbehaved and treated Petitioner with so much hostility because he does not feel any guilt from repeatedly doing the same pattern of abuse.

7. Ms. Montefalcon has concluded that respondent's personality disorders speak of ANTECEDENCE as it has an early onset and developmental in origin. She observed that:

ххх

It can be noted that being in a hostile being in a hostile environment and seeing his mother and siblings' vices, lifestyle, and dispositions brought deep impact to Respondent. He witnessed them indulging in unhealthy and illicit habits and later on, he displayed the same acts.

Also, he grew up pampered by his parents. His failure to receive appropriate guidance and discipline from them allowed his faulty attitudes and behaviors to continue until he became a man.

Because he became used to be followed, pleased and understood, he found it hard to handle mature and strong interpersonal relationships.

8. Ms. Montefalcon likewise described the psychological incapacity of the respondent as GRAVE as he was not able to carry out the normative and ordinary duties of marriage and family, shouldered by any married man, existing in ordinary circumstances His personality disorder is permanent, chronic and pervasive affecting many aspects of his life such as social and occupational functioning and closes relationships including the marriage.

9. She also emphasized that the personality disorder as INCURABLE as there are no medications and laboratory examinations available for such kind of condition, ASPD (Antisocial Personality Disorder). Also, no amount of therapy can give

permanent cure since his maladaptive traits are already deeply ingrained in his personal structure.

10. Mr. Montefalcon thus recommends that the marriage between the parties be declared null and void on account of Respondent's psychological incapacity pursuant to Article 36 of the Family Code.

#### PRAYER

WHEREFORE, premises considered, it is most respectfully prayed that the marriage of Jang Geun Yi and Maria Teresa Banogon – Yi be declared null and void from the beginning under Article 36 of the Family Code.

#### BEHAVIORAL OBSERVATIONS

Petitioner is an adult female appeared to be of her stated age of 51, came to the office of the undersigned and presented herself well for all the sessions. She has a petite body physique and has a light brown complexion. She was wearing purple blouse and straight cut jeans partnered with a pair of open toe sandals during her first schedule. On her second session, she was in a striped polo shirt, blue skinny jeans and doll shoes. She was wearing a pink blouse, knee-level shorts and flat sandals on her final session. Petitioner was observed to be well-groomed and neatly combed.

Throughout the interview, Petitioner was cooperative and respectful though there were moments when discomfort feelings were presented. It was noticed that she was anxious and tensed in the beginning, looking at her surroundings every now and then but went calm and conversational when all her inquiries had been answered. Her mood was within normal range with appropriate affect. Also, her speech was clear and spontaneous. She talked coherently, relevantly, and was consistent with her written and verbal productions.

Petitioner was noted to have fitting facial and emotional expressions that are appropriate to the mood of the conversation such as appearing positive when the

Conversation was about happy moments. She exhibited normal emotions regarding personal matters, even about the history of her failed marriage. She had a good eye contact with the examiner and at times and was asking follow-up questions, asignofher attentive listening.

Petitioner was not noticed to have bizarre thoughts, words, and actions. She was said to be in contact with the reality.

#### BACKGROUND DATA OF THE PETITIONER

(Information provided by Petitioner and Corroborative Witnesses)

Maria Teresa Banogon - Yi or 'Tess' as she was fondly called, is the second to the youngest child of Mr. Pio P. Banogon, died at his 70's due to stroke, and Mrs. Camila P. Banogon, died at the age of 50 due to breast cancer. She has five siblingsnamely Narita (62), Filomena (62), Linda (59), Sandra (58), and Danilo (49).

Petitioner grew up in a simple but happy family. They blessed with stable financial resources but she never felt that she was deprived of something because she learned to be contented and grateful for whatever was given to her. Petitioner treasures her family because it molded her to be a better person. Though she was considered the youngest daughter, she was taught the virtue of diligence and hardwork. She was trained to be a disciplined, responsible, and caring daughter to her parents and an obedient sister to her older siblings.

She described her father as kind, industrious, and sacrificial. He only reached high school but it did not hinder him to provide the needs of their household. He worked as a janitor almost all his life just to make ends meet. Petitioner was very close to him because his father was fond of telling her his stories and past experiences. She was also often brought by her father on his errands or whenever he would visit their other relatives. Petitioner appreciated him so

much because he was the one who taught her to be strong amidst the problems in life. He became a role model of a noble parent whose toppriority is his family.

Likewise, she established a strong bond with her mother who was noted for being kind-hearted, patient, and supportive. She was described as Petitioner's wind beneath her wings, hero, and bestfriend. Her mother was very nurturing and dedicated all of her days on taking good care of her own family. However, despite her loving-kindness, she was still able to discipline her children, Petitioner also noted that her mother was strict

Especially in her studies. She was always monitored on her academic performance as she wanted her to earn her degree and grab a good job. Her closeness to her mother got deeper when she became an adult and got aware of the real hardship of parenting. She owed her so much because of her sacrifices she'd done for her own family unit.

Petitioner and her siblings were raised as responsible individuals. When they were young, they were trained to help one another even in simplest things. The older would be assigned to take charge of preparing for the meals, doing the laundry, and looking after the little ones while the younger would do the other tasks and errands such as washing the plates. None of them complained for their respective tasks because it was instilled to them thattheir parents were working hard outside home to give them a better life. Also, they knew how to appreciate their sacrifices and efforts.

Petitioner graduated at Baclaran Elementary School in 1979 and at Centro Escolar University in 1983. With the course of Bachelor of Science in Elementary Education, she studied at Foundation University and successfully earned her college degree in 1991. She worked as a Pre-School Teacher at Golden Values School for two years before officially starting her career as a Elementary Teacher in a public school in 1994. Petitioner is still in the same profession up to present.

#### BACKGROUND DATA OF THE RESPONDENT

(Information provided by Petitioner and Corroborative Witnesses)

Jang Geun Ji is the eldest child of Mr. Hung Tae Yi and Mrs. Yun Ki Kim. Respondent has two siblings namely: Jae Geun Ji and Myung Sook Ji. His basic personal details as well as of his family's were gathered through the Family Census Registry provided by the Chuncheon Law and Notary Office based in South Korea. Their present whereabouts however, remain unknown to Petitioner.

Petitioner was able to know some data about Respondent's background through his narrations whenever he was drunk. His fellow Korean Nationals also confirmed his stories and also disclosed other information about him.

Respondent came from an intact but dysfunctional family. They always had frequent fights inside their house and they were divided as siblings because his parents failed to guide them while growing up. Unfortunately, due to lack of discipline, Respondent and his two siblings were all led astray. They got indulged in various vices including alcohol drinking and gambling.

His father was described as a very kind and patient husband and father. He was the sole provider of their family and among them all, he was the only who had no vices and caprices. However, brought by his too much generosity and permissiveness, he became a great enabler of his children, especially of Respondent, the apple of his eye. Respondent was given excessive affection and endearment by him at the cost of depriving him of necessary discipline. He became used to get anything right away as his father thought that it would make him better. He failed to learn the value of delayed gratification that established his belief that he could easily and quickly sustain his earthly pleasures. Verily, his father played a very tolerating and permissive way of upbringing that at the very early stage of Respondent's life, he already received freedom and independence which unfortunately led him astray. He acquired a dependent, parasitic, and O happy-go-lucky lifestyle.

His mother, on the other hand, was the one who influenced Respondent to dwell in many vices because she, herself, was a binge-drinker and a gambler. She was noted for being boastful, domineering, fault-finder, and irresponsible. She always had someone aggravated because of her bad habits of having unpaid debts and spreading rumors in their place. His mother was always out of their house because she was with the company of her friends who, like her, loved to gamble and binge-drink early in the morning until late at night. Respondent was not raised by her mother as she remained living like an unmarried woman. Thus, seeking attention and acceptance, he became indulged in delinquent peers.

Respondent's academic and employment history was not clearly divulged to Petitioner. From what she had heard, he graduated in college and was running a small business in Korea.

#### CASE HISTORY

In 1987, Petitioner Maria Teresa became involved in a religious organization named Holy Spirit Association Unification World Christianity (HAS-UWC) in the university where she was studying. She was persuaded by a friend to join the group and upon receiving their warm welcome, she began to attend its services and gathering Petitioner enjoyed the company of her fellow churchmates that she continued to be one of its active members even after she graduated in college.

Sometime in 1995 at Rizal Stadium, Quezon City, they had an event called 'Matching / Blessing' wherein Filipino women were being partnered to male Korean Nationals. Since Petitioner was already an old member of the organization, she was asked to take part in the ceremony but little did she know that it was already a Mass Wedding as she was just asked to wear a white dress and hold a photo of a man. Someone took a picture of her on that certain pose and after that, nothing had really changed. Petitioner thought that it was just a sort of ritual not until the following year and she personally met the man in the photo.

Respondent Jang Geun Yi arrived in the Philippines in 1996

and it was the only time that she became knowledgeable that she was indeed matched to him. Back then, she was informed that their wedding was already arranged by their religious organization and because of that, she found it difficult to back-out with the plan. She felt that everything was too quick but she had no other choice since she was told that her act of holding Respondent's picture during the ceremony a year before was already a form of securing their relationship and committing herself to him. Swayed by the words that she heard from their church leaders and moved by her child-like conscience, Petitioner agreed to marry him on June 25, 1996 at the Regional Trial Court Branch 77, Paranaque, Metro Manila.

Unfortunately, what she thought as a peaceful and harmonious union was really the opposite of it. Respondent already unveiled his true colors since the first day that they lived together as husband and wife. He displayed his arrogance, negligence, cruelty, and insensitivity from then on as he knew that Petitioner had no more chance to revoke her decision of tying the knot with him. The once kind, humble, and generous man to her suddenly turned into the worst nightmare she had ever imagined.

A day after their wedding, Petitioner brought him in her place in Baclaran where her relatives were residing. She was excited to introduced him to her loved ones but upon seeing that their house was not conducive, he unceasingly complained and did not even face her relatives. Petitioner was embarrassed by his misconduct but because she did not want to totally lose their day, she ended up complying to what he wanted. They then transferred in a transient house in Villa Carolina, Paranaque City. It became their abode for a month that was like a year-long suffering for Petitioner

She never felt that she was her wife because he made her feel that she was only his slave. Respondent's brutality continued with an increasing level of severity each passing day. Petitioner did not escape from being verbally, emotionally, and physically

Abused by him whether he was influenced by alcohols or not. She did her best to speak up and fight but in all her attempts Respondent would attack her even more.

Petitioner regrettably recalled how she was being forced by Respondent to drink rice wine. If she did not obey his command, he would surely slap her face many times followed by totally beating her up. It was his way to make her drunk and subsequently use her for his sexual pleasures. Respondent had no care for her feelings and emotions as long as he was satisfying himself. At times, when Petitioner was still conscious enough, she would feel the pain of having carnal knowledge with him because she knew that they were doing it not out of love. Indeed, since the very beginning she felt being molested and treated as a mere prostitute by him.

During that very short period of time, Petitioner already experienced deep sufferings caused by him. She got quickly pregnant but despite her condition, Respondent remained wicked He never cared for her nor did he assist her on her check-ups Instead, he turned more heedless of what she was going through. He did not spare her from having some rest as right after cleaning the whole house and providing the best service that she could; that is - cooking for him, massaging him, and the like - Respondent would still use her to ease his sexual urge. He always offered his deaf ears to her pleas and begs and not satisfied by that, he would also enact his domestic violence.

Aside from being an alcoholic, Respondent was also a chronic gambler. Everyday, he would go out with other foreigners whom he became friends with during his stay in the country. He would only return home later at night or in the wee hours wherein he would still kindle nonsense and mentally-torturing fights with Respondent. Petitioner took a leave from her work just to give him adequate time and attention but he just paid her back with so much heartaches and physical pains. He never supported her in any way, even in form of finances knowing that she was not receiving her salary then

After spending a month in the Philippines, he went back to Korea. He promised to send her financial aid for her upcoming delivery but not even a centavo was remitted to her Additionally, Respondent turned unreachable. It was a tormenting period for Petitioner because she felt that she was just abandoned that easily. She did not hear anything from him until she gave birth to their first-borne, Kimiel B. Yi on December 22, 1996

Surprisingly, Respondent returned to be with her in 1997. He only had a week to spend with her and their son and unfortunately, that limited period of time had still be

Endured by Petitioner. She felt and experienced hell during the couple days that they lived in one roof because Respondent turned more aggressive and destructive than before. She was very disappointed then because she expected that the presence of their child would bring out the good in him, but such wish was far way unrealistic.

Petitioner could still vividly remember his acts of abuse towards her during his second vacation in the country. He became fond of hitting her head with a slipper and there was an instance when he threw her a hollow block while insisting that she must follow whatever he says. In short, Respondent only came back to inflict more injuries and miseries to Petitioner apparently showing his absence of remorse.

For two years, Respondent did not send her a letter or a phonecall. He hid himself again and just showed up in 1999. Like before, their union only lasted for a week because he chose to spend the rest of his vacation days with his Korean and Japanese friends in Cebu City. The same vicious cycle resurfaced and left her not only wounds and bruises, but also nightmares. Petitioner was traumatized by being repeatedly treated as a sex slave and serving as a recipient of his inhumane behaviors

During that time, Petitioner learned to just keep silent because of dread to receive another beating up session from him. She hated tolerating and permitting his negative acts and ill vices but for her own safety, as well as for their son's, she had no choice but

to avoid meddling anymore. When Respondent left them, Petitioner learned that she was pregnant again. She tried hard to communicate with him but all her efforts were just put in vain. On August 18, 2000, their younger child, *Gio B. Yi* was born.

Petitioner did no longer expect and hope that he would come back again. Years passed by and she learned to accept the reality that she had to be strong for their two children. Until one day in 2002, she received a phone call from a relative of him, allegedly his stepmother, telling her that Respondent committed suice and was already dead. Petitioner's concern for him was awakened by that incident that she made every effort to gain more information about it. However, no one could give her more details, even the religious group that she was once involved.

In April 2014, Petitioner sought the help of the Public Attorney's Office (PAO) to request for assistance from the Embassy of Korea in the Philippines in verifying the whereabouts of Respondent and if he is still alive of have already passed away. She was given a certification from Bureau of Immigration stating that Respondent's name does not appear in their available computer database file of the passengers who arrived or

Departed from January 01, 1999 to April 22, 2014. Petitioner, with the help of the PAO, asked for a follow-up of their request to the Embassy of Korea in the Philippines just this May 2018.

Given the failed status of their marriage, the parties have nothing more to expect from their marriage. Severing their marital ties is the only solution due to the psychological incapacity of the Respondent, thus preventing him from satisfying his marital and interpersonal obligations.

#### CORROBORATIVE WITNESSES CONFERRED

Petitioner presented an informant, Sandra Banogon – Pempil (sister of Petitioner), 58 years old, married, and presently residing at 411 2nd Street, 7th Avenue, Caloocan City. She was interviewed at the office of the undersigned on August 01, 2018.

The informant noted pertinent information about the case presented.  $% \label{eq:case-star}$ 

"Sa pagkakaalam ko, sila ay nagkakilala lamang sa pamamagitan ng isang religious organization na kinabilangan ng aking kapatid since noong college siya. Doon kasi sa grupo na sinalihan niya, marami siyang nakikilala na mga foreign nationals, malimit ay mga Koreans, pero ang iba ay through pictures lang. Sa totoo lang, walang pagliligawan at pagiging magboyfriend-girlfriend na naganap. Yung nangyari kay Tess ay kakaiba sa lahat sapagkat lingid sa kanyang kaalaman na siya pala ay ipinartner na. Nung pinakwento ko sa aking kapatid ang buong pangyayari, ang tanging alam lang niya ay nagkaroon ng isang activity sa kanilang simbahan na kung tawagin ay 'matching' at noong oras ding yun, pinasuot siya ng putting bistida na parang wedding dress na din. Pinicturan siya na hawak hawak ang litrato ngisang lalakina nang lumaon ay napagalaman niyang si Jang Geun Yi, ang kaniyang asawa.

Noong sumunod na taon pagkatapos ng event na yun, nameet na Tesssa personal si Jang at isa naming mabilisang proseso ang nangyari. Naitakda na pala silang ikasal sa huwes at ito ay matagal nang pinaghandaan ng kanilang religious organization. Wala na ding nagawa ang kapatid ko. Bilang isang probinsyana na walang kamalay-malay, pumayag siya sapagkat ang sabi sa kaniya ay responsibilities ito matapos niyang magpakuha ng litrato nong nakaraang taon na hawak ang picture ni Jang. Sa kanila daw kasi, kapag ganun ay parang engaged na kayo.

Nameet ko si Jang noong nagpunta sila ni Tess sa bahay ko sa Caloocan City matapos ang kanilang kasal. Talagang nagulat ako sa mga nangyari pero wala na akong magawa. Hindi ko naman naiintindihan ang salita ni Jang kaya't hindi ko siya nakausap talaga pero base sa mga nakita kong pagkilos niya noon, mukha talagang may ibang ugali. Pasigaw siyang magsalita ng koreano sa harap ni Tess at kitang-kita sa mga expressions niya yung pagkainis at pagkairitable. Saglit lang tuloy sila at umalis na din. Nakakausap ko na lang ang kapatid ko noon sa telepono dahil doon na sila sa Paranaque City nagtigil.

Bilang ate kay Tess, lubha akong nalungkot noong nalaman ko na minamaltrato siya ng kanyang asawa. Kapag magkausap kami ay naririnig ko siyang nanginginig ang boses na tila nagpipigil ng pag-iyak. Inamin na din sa akin ng kapatid ko na palagi siyang sinasaktan ni Jang lalo na't lasing ito o kaya'y mainit ang ulo dahil talo sa sugal. Si Tess ay maliit at payat lang na babae pero hindi na naawa si Jang dito, kahit na noong nalaman nilang nabuntis agad siya. Pinagsabihan ko na nga ang kapatid ko na hiwalayan na lang siya pero natatakot siya dito at nahihiya din sa sasabihin ng ibang tao. Alam kong ginawa ni Tess ang lahat ng kaniyang makakaya para kay Jang. Pinilit niya itong mahalin at tanggapin sa kabila ng mga pananakit nito hindi lamang sa kanyang damdamin, kundi pati sa kanyang pisikal na pangangatawan.

After one month, umalis na ulit si Jang at hindi nagparamdam. Bumalik ito matapos ang ilang buwan at ganun pa din ang nagging pakikitungo niya kay Tess. Pinagpatuloy niya ang lahat ng kademonyohan niya sa aking kapatid at katulad noon, umalis ulit siya at naglaho nang parang bula. Si Tess ang nagsikap para sa kanyang sarili at sa kanilang anak dahil ni singko ay wala siyang natatangap kay Jang. Napaka irresponsable talaga niyang asawa at ama; talagang walang pakialam sa pamilya niya. Noong bumalik sa Pilipinas si Jang taong 1999 ay nabuntis muli si Tess ngunit nalaman th niya ang kanyang kondisyon noong wala na ang kanyang asawa. Saglit lang kasi ito at tre. Parang bumisita lang sa kaniya para gamiting siya (sekswal) at mag-iwan ng mga sugat char at pasa sa kanyang katawan.

Simula noon ay wala na talaga kaming narinig direkta mula kay Jang. May tumawag sa kapatid ko noong 2002 na nagsasabing nagpakamatay daw ito pero hanggang ngayon ay hindi din naming makumpirma kung totoo ang balitang ito. Si Tess ay humingi din ng tulong sa Bureau of Immigration at sa embassy ng bansang Korea dito sa Pilipinas upang malaman kung ano na nga ba talaga ang nangyari kay Jang."

#### TEST RESULTS AND EVALUATION

**Cognitive Functioning** – *Average Classification* – Petitioner has good intellectual resources and reality testing. She is likely to do particularly well in tasks requiring her to understand social norms and follow the meaning of nonverbal social situations.

**Emotional Functioning** – Petitioner did not display any intrapersonal discomfort associated with her painful experiences on her failed marriage. She is having mild anxiety but has a strong disposition despite the unlikely facets induced by the social and physical environment.

**Interpersonal Functioning** – Test results revealed that she is able to form good and healthy relationship with other people. When provided with adequate support and nurturing, she will be able to overcome her past painful experiences as well as those to come.

**Behavioral Functioning** – Petitioner did not exhibit significant behavioral concerns. She is responding positively to her surroundings and is adaptive to changes.

Overall, no pathology in mood and thought, but manifesting **Posttraumatic Stress Disorder (PTSD) DSM 5 309.81** (**F43.10**) is evident on her based on her reported symptoms of emotional discomfort and some flashbacks of psychological and verbal abuses he had experienced in the past. This rooted from her prolonged marital ordeals she encountered from her husband. The symptoms and feelings associated with **PTSD** typically last from a few days to a few months, gradually fading as she processes the trauma. But even when she is feeling better, she could be troubled from time to time by painful memories or emotions especially in response to triggers such as the presence of the stimulus or situation that reminds her of the traumatic experience

#### REMARKS:

Based on the interviews, case history data, test results, and collateral information, Petitioner MARIA TERESA BANOGON – YI maintained a *balance ego integration and healthy psychological state* that connotes an individual who is capable of fulfilling her roles as a responsible adult and obligations expected of her as a wife despite the presence of her PTSD (*Posttraumatic Stress Disorder*). Therefore, she is capable of providing suitable responses to environmental stimulations and best equipped to maintain a healthy interpersonal relationship. However, should the marriage continue, she could live in tremendous fear that the emotional and physical discomforts she experienced has the tendency to recur.

On the other hand, the manner by which JANG GEUN YI portrayed his role as an adult and as a married man, as illustrated by the Petitioner and the corroborative witness clearly demonstrate that he is psychologically incapacitated to comply with the essential marital obligations. Clinically, he is found to be suffering from a distinct form of personality disorder, which hampered his normal functioning. He exhibited pathological behavior classified as 301.7 (F60.2) Antisocial Personality Disorder. It is a condition characterized by pervasive and excessive disregard for and violation of the rights of others occurring since adolescence, as indicated by three (or more) of the following clinical features: (The highlighted and italicized ones were manifested by the Respondent with its overt behavioral manifestations.)

1. Failure to conform to social norms with respect to lawful behaviors, as indicated by repeatedly performing acts that are ground for arrest; His verbal (showering her with threats, insults, and degrading words), emotional (making her believe in his lies, manipulating her), and physical (hitting, punching, spanking, and throwing various things on her) abuse towards Petitioner clearly shows acts that were ground for arrest. He failed to fulfill his moral and financial obligation to his family because of his selfish whims and excessive laziness.

2. Deceitfulness, as indicated by repeated lying, uses of aliases, or conning others for personal profit or pleasure; He was fond of deceiving Petitioner in order to achieve his ends. He was insincere in his actions and frequently gave unacceptable reasons or explanations when confronted about his vices and whereabouts. Also, he initially showed kindness and caring acts to Petitioner but the moment they lived together, he already achieved his real motives to her and eventually unveiled his real self – an irresponsible, abusive, and violent man. He consistently lied to Petitioner and exploited her by letting her alone meet the needs of their household while he engaged in his earthly pleasures.

3. **Impulsivity or failure to plan ahead**; He has no long range plan for himself and his family, his main concern is on how he could gratify his infantile needs as indicated by his unstoppable happy-go-lucky way of living and inability to spend his money wisely and accordingly. He never showed efforts to make their lives comfortable and just used his earning for himself instead of sparing it for his family.

4. **Irritability and aggressiveness**; Even in slight issues, Respondent displayed extreme anger and annoyance. He became used to shout vile words at the top of his lungs without minding his wife's feelings. He was also inflicting domestic violence towards her. Intensified by his anger problem and alcohol drinking habits, Respondent's violent behaviors were coming unstoppable.

5. **Reckless disregard for safety of self and others**; *Respondent did not show concern for his wife and children. Instead of loving them and protecting them from harm, he became detrimental to their safety because of his aggressiveness and destructiveness. Petitioner experienced being verbally and physically assaulted by Respondent for so many times.* 

6. **Consistent irresponsible**; Respondent failed to honor his financial obligation to his wife and children despite being gainfully employed. He did not consistently give moral, emotional, and financial support to them because of his vices and other childish and selfish whims. He could not be relied on in doing household chores because of his extreme laziness.

Lack of remorse; As indicated by being indifferent, unloving and unconcerned with Petitioner. From the start until they finally separated, Respondent let alone Petitioner takes the responsibilities for their household while he enjoys his life free from any worries. He unendingly misbehaved and treated Petitioner with so much hostility because he does not feel any guilt from repeatedly doing the same pattern of abuse.

The personality disorder speaks of **ANTECEDENCE** as it has an early onset, with an enduring pattern and behavior that deviates markedly from the expectations of the individual's culture. In other words, the root cause of Respondent's defective personality pattern can be attributed to dysfunctional factors involved in childhood milieu. His familial constellation, unreliable parenting style from significant figures around him, and unfavorable childhood experiences (training and modeling) have greatly affected his perceptions of himself and his environment in general. Respondent did not grow up mature enough to cope with his obligations and responsibilities as an adult.

#### Historical Antecedence of RESPONDENT that Contributed in the Development of his Personality Disorder

According to **Social Cognitive Theory** of **Dr. Albert Bandura**, people learn from one another via imitation and modeling. He contended that behavior is acquired through observation of others, direct experiences with positive and negative reinforcements, training, or instruction, and bizarre beliefs. It can be noted that being in a hostile environment and seeing his mother and siblings' vices, lifestyle, and disposition brought deep impact to Respondent. He witnessed them indulging in unhealthy and illicit habits and later on, he displayed the same acts.

Also, he grew up pampered by his parents. His failure to receive appropriate guidance and discipline from them allowed his faulty attitudes and behaviors to continue until he became a man. He was indulged with so much material possessions and though they were loving and caring guardians to Respondent, he ended up spoiled as he was treated with so much kindness at the cost of losing the proper disciplinary action to change his wrongdoings.

Because he became used to be followed, pleased and understood, he found it hard to handle mature and strong interpersonal relationships. He assumed that others would always be there to help him up so he was choosing to not do things on his own even if he

Had the capability which as time went by, gave birth to his care-free, happy-go-lucky and irresponsible lifestyle.

His psychological incapacity speaks of **GRAVITY** as he was not able to carry out the normative and ordinary duties of marriage and family, shouldered by any married man, existing in ordinary circumstances (Bacareza). His personality disorder is <u>permanent</u>, <u>chronic and pervasive</u> affecting many aspects of his life such as social and occupational functioning; and closes relationships including the marriage.

His gross irresponsibility as indicated by his neglectful behavior, and failure to honor his financial obligation; his gross unloving and uncaring attitudes, vices and the absence of concern to the needs of his wife and child, made their marriage union unbearable and dysfunctional. In the process, Respondent was unable to assume his marital duties and responsibilities to his family. He failed to render mutual love, respect, help, support, and fidelity (Article 68, FC).

Additionally, it also speaks of **INCURABILITY**, as Respondent has no psychological insight that he has a character problem. He would not acknowledge the pain he caused to people around him. There are no medications and laboratory examinations available for such kind of condition, **ASPD (Antisocial Personality Disorder).** Also, no amount of therapy can give permanent cure since his maladaptive traits are already deeply ingrained in his personality structure.

#### **RECOMMENDATION:**

With due consideration to the above findings and since reconciliation would only cause mental and emotional distress on the Petitioner, it is then recommended that the marriage between Petitioner and Respondent be declared null and void on the account of Respondent's psychological incapacity pursuant to *Article 36 of the Family Code* that is grave, severe, permanent and incurable, as well as deeply ingrained in his personality structure.
