PNR LUCENA-SAN PABLO LINE REOPENING SET BEFORE JUNE 30: The Philippine National Railways (PNR) Lucena-San Pablo line is set to reopen before the Duterte administration steps down in June, the Department of Transportation (DOTr) announced. In a statement, Tuesday, May 10, DOTr said that PNR Lucena-San Pablo line is vital in restoring the PNR Bicol Express, which will link Metro Manila and the provinces in Southern Luzon, including Laguna, Quezon, Camarines Sur and Sorsogon. Through the PNR Lucena-San Pablo commuter line, travel time between San Pablo to Lucena will be shortened to one hour and 30 minutes. The railway line will also unlocking the economic potential of Southern Luzon, stimulating commerce in the economic corridors of the provinces of Laguna, Quezon and nearby areas. Aside from being a passenger commuter service, the PNR Lucena-San Pablo route can also be converted into a commercial or cargo freight service.

His mother had registered sometime at the beginning of this year but did not receive a confirmation for a despite schedule expecting to be prioritized because she had to physically be present for her work. In order to avoid waiting as long as their mother did, Raniel and his sister decided to go to a walkin vaccination clinic immediately the day after their registration. Soon after filling up forms and scanning his QR code, Raniel was able to get vaccinated.

"Mabilis at madali lang ang pag-fill out ng forms [ng UBE]," said Raniel, "Ang maliit na problema lamang ay ang hindi nila pag sagot agad para sa petsa na nakatalaga sa mga tao. Sa pangkalahatan, maayos ang serbisyo nila dahil mas madali malaman kung ano ang classification ng bawat mamamayan sa isang lugar." (Filling out the forms was quick and easy. A small problem, however, was the lack of response to questions regarding vaccination schedules. Overall, the service was organized because it was easy to know which classification one belonged to.)

UBE Express was launched with the help of Bert Lina Group of Companies and the Philippine Red Cross (PRC). It was a point-topoint transport system, or P2P, before being turned into a mobile vaccination clinic when the pandemic started.

Aside from COVID-19 vaccines, the PRC also utilized this in order to schedule a vaccination of
