

Bacoor to celebrate 10th tyhood annivers



All is set for the much awaited traditional parades, civic and marching band for Bacoor's 10th Cityhood Anniversary celebration this June 23.

City Mayor Lani Mercado revealed that President-elect Ferdinand "Bongbong" Marcos Jr. will be the special guest of honor tomorrow, for the upcoming celebration which will be held at the Bacoor Elementary School Oval Track and Field in Barangay Alima at 8:30 in the morning.

In her FB Page, Mayor Revilla said the city government will start their Civic and Marching Band at 7:30 am from the corner of Barangays Maliksi and Panapaan 3 all the way to Bacoor Elementary School in Brgy. Alima where our Oval Track and Field is located.

"We have not been able to launch this traditional parade along the stretch of Evangelista road for more than two years, so we are lucky that this time we will be with our next President who is one of those who pushed for Bacoor to become a City," Mayor Revilla said.

Mayor Revilla also urged fellow Bacooreños to attend and join the parade, as a token of our gratitude for a decade of collaboration for development.

"Let's meet on June 23, 730AM, at Evangelista Road and 8:30AM at Bacoor

Elementary School with President Bongbong Marcos," Mayor Revilla added.

The City of Bacoor is a first class component city in the province and according to 2020 census, it has a population of 664,625 people, making it the 15th most populous city in the Philippines and the second fargest city in the province of after Dasmariñas. Four DOST CWWTL staff pass DOH Certification Course for



Four laboratory staff of the DOST Cavite Water and Wastewater Testing Laboratory (CWWTL) completed the Certification Course for Drinking Water Sampler last 2 June 2022, facilitated online via the Zoom platform.

The Department of Health – National Reference Laboratory (DOH-NRL)

conducted the one-day training covering lectures on standards for drinking-water quality, water sampling and evaluation results, and operational standards for water testing laboratories. DOH-NRL likewise tackled the Philippine National Standard for Drinking Water (PNSDW), consistent with the World Health Organization (WHO) frameworks for drinking-water safety. The DOST CWWTL is one of the government water testing laboratories compliant to the policy.

All four staff from the DOST CWWTL namely Ms. Verjo Angelie M. Sisante (Registered Chemist and Laboratory Head), Ms. Joan Mae B. Acacio (Registered Medical Technologists and Laboratory Analyst for Microbiological Testing), Ms. Thea Mary Joyce M. Diloy (Registered Chemical Technician and Laboratory Analyst for Physico-Chemical Testing) and Mr. Herbert Salas (Laboratory Staff) passed the post-lecture written examination, and were awarded with a Certificate of Proficiency by the DOH-NRL.

DOST CWWTL will continuously demonstrate its commitment in providing highest quality services in microbiological and chemical testing, and maintain its accreditation under PNS-ISO/IEC 17025:2005. (By: Gilda de Jesus)

Botika on Wheels rolls out again in Dasmariñas



The Cavite provincial government through the Office of the Governor-Extension recently rolled out its Botika on Wheels program on June 17.

Around 1,199 senior citizens and 1,395 children in Paliparan, Crossing, Tabing Ilog, Carissa Homes Subdivision, Camit Compound, Square Subdivision, Picache Compound, Tiera Bonita, Beberino Compound, Dimaranan Compound, Terra Aita Homes, Nia Road, Nasta Jie, Vina Compound, Sarita, DRV, Kanluran, Martinez and Tondo benefitted from the door-to-door distribution of free medical supplies including essential medicines, maintenance medicines, vitamins and insect repellant in Barangay Paliparan I.

The Botika on Wheels team was accompanied by barangay health workers and police in going around the community to deliver the basic medical supplies to the recipients

Regroup, recharge, and rebuild to help revive PH tourism

udging by the data generated by global travel analytics firm ForwardKeys last weekend, the Philippines is leading in the tourism revival in Southeast Asia when it comes to visitors from the US.

"The destinations which are recovering most strongly are the Philippines and Singapore. Summer flight bookings for the Philippines are currently at 70 percent of pre-pandemic levels," according to ForwardKeys. It noted that the positive trend is contributed also by people returning to our country to visit friends and relatives, whereas travel to other destinations in Southeast Asia is more for work and

One of the pertinent findings from the firm is that destinations that relaxed travel restrictions earlier, such as the Philippines and Singapore, have recovered more strongly. Looking back, the IATF's decision to ease entry of vaccinated foreigners proved to be an astute decision, which helped the local tourism industry get back on its feet during the summer

Though travel to the region is just currently 18 percent of pre-pandemic levels, tourism experts have set rosy forecasts, as flight bookings in the coming months are expected to hit around 43 percent. The current slump is also due to the fact that China, which used to be Southeast Asia's largest source of tourists, is still experiencing Covid-related travel restrictions and outbound travel is not encouraged. This is also the same with Japan and India, major travel markets that are cautiously opening their borders to outbound leisure travelers

At this point, this is the best time for "regrouping." The new administration has 10 days left before it



secretary for the Department of Tourism (DOT) Christina Frasco to start laying out a post-pandemic recovery plan

This early, Frasco was lauded for her performance in making Liloan, Cebu, where she is mayor, into a tourist attraction amid the challenges posed by the pandemic. In an interview, Frasco sees Cebu's tourism governance "as a good model for other destinations in the country, and that coordination among tourism stakeholders and development of lesser-known destinations, which are parts of Cebu's model... could help in the revival of the

"Being well versed in the challenges that are faced from the grassroots and on the ground can help our DOT come up with sustainable, innovative, medium, and long-term solutions to the challenges that our tourism frontliners, tourism stakeholders, and partners continue to have as a result of the difficulties of the pandemic," Frasco said. "I bring with me the experience of being a local chief executive, whose main challenge is to face and try to solve crisis after crisis."

Now is also a time to "recharge"—for hospitality workers to undergo retraining, for hotels and resorts to undergo minor renovations, and for tourism

organizations and related businesses to rekindle ties for the upliftment of the industry. Sooner or later, once new cases of Covid could be contained or controlled with better vaccines and boosters, the local tourism industry will experience a massive revival—a Renaissance never seen in recent memory that will see skyrocketing demand for flights, accommodations, food, transport, and events and leisure services. This forebodes well for an industry that has suffered the worst of the pandemic slump. And our country should be ready when that time comes, instead of being overwhelmed and caught off guard, like a fool who has missed the gravy train.

The "ruins" of the pandemic can be rebuilt. But, like Rome, we can't rebuild something grand and great in a day. To rebuild means constant communication between industry players and business owners, coordination between the national government and the LGUs, and conversation between tourism leaders and hospitality frontliners. We hope that the incoming tourism secretary will forge a bridge of understanding and start regrouping as soon as day one of the new administration arrives because it is "now or never" when it comes to our tourism recovery.



spearheading the Local Press Assembly 2022, a gathering of media executives, publishers, editors, and reporters to redefine the role of the press as information vehicle and revisit the community media's role in the national reportage.

Outside the tasks of leading various national press clubs, Dayang has been also into publishing, correspondence, and column-writing.

He was reporter of The Manila Chronicle and Evening News; publishercolumnist of Philippine Weekly Graphic; founding publisher of Headline Manila; and currently columnist of Tempo and Balita, sister publications of Manila Bulletin.

Early on, during his campus years, ne was editor-in-chief of The Students Forum, national vice president of the College Editors Guild of the Philippines (CEGP), and chairman of the Conference Delegates Association (CONDA), now defunct.

Non-journalistic stints

Dayang's decades-long journalistic exposure, professional tie-ups, and political links have also afforded him stints in state and non-government agencies, mostly as member of corporate and institutional boards. His involvement in this sphere includes position of director of the Philippine Charity Sweepstakes Office (PCSO) and the National Development Company (NDC).

He was appointed board member and secretary of the APO Production Unit, Inc., a government printing outfit; member of the Board of 'governors of the National **Book Development board** (NBDB); member of the Commission for the Culture and the Arts (NCCA); deputy executive director of the defunct Cottage Industries Development Enterprises (CIDE); and commissioner of the United Nations Educational, Scientific, and Cultural Organization (UNESCO).

Moreover, he was former OIC-mayor of Kalibo, Aklan; member of the Board of Governors of the Philippine National Red Cross; member of the Board of Trustees of the Archbishop Gabriel M. Reyes Foundation; and member of Kiwanis International, Makati City.

On the business side, he was former senior vice president of the ALC (Antonio L. Cabangon Group Chua) of board Companies; member and vice president of Boracay Foundation, Inc., and chairman of the Board of Trustees of Panay Technological College. Presently, he is a Board member of Fortune Life Insurance Company and Eternal Plan, Inc.

He also chairs the family-owned Casa Dayang Boracay.

Enduring advocacy

Underscoring Dayang's appetite and commitment to strengthen a thriving and truthful rural media is the conduct of 'twice a year' forums and conferences that bring together community journalists and publishers. These gatherings expose the challenges scribes face in a difficult countryside landscape and allow the provincial press to further enhance its advocacies.

In a recent column that appeared in Tempo and Balita, both national periodicals, Dayang underscored his

impressions and observations, especially the hurdles that come with an expanding press environment, that have made the quest for unfettered press freedom and journalistic liberalism even more thoughtprovoking and challenging, stating:

post-election 'The dynamics, amid the threat of disinformation and fake news in social media, are expected to redefine the way the media pursues its critical role as a social catalyst. Suffering from pessimisms, the authentic press, especially the rural media, is also confronted with a bigger challenge of making itself relevant in a badly disturbed democratic space.

'Against the malicious imputations labeling genuine journalists as paid hacks propagandists, the media struggling practitioners have also become victims of warped revisionisms and destructive falsehoods peddled by disparaging publicists. To address the issues, the media scribes, disturbed by the pitiful downhill trajectory of the Philippine press, are joining forces to sieve the facts from untruths, and to understand the options available to save the much-abused media from the impact of partisan distortions and fake news.

'On June 24, the Federation of Provincial Press Clubs of the Philippines, Inc (FPPCPI) will host the Local Press Assembly 2022 entitled 'The Role of the Community Press in the New Administration' to define the role of the press as a vehicle of information and to revisit the community media's role in the national reportage.

'Significantly, conference takes a hard look on how best to protect the working journalists from becoming social outcasts and understand the effect of the pandemic that has forced media outlets to downsize operations, retrench personnel, or even permanently shut down. Even outfits that have already earned the honor as pillars of Philippine journalism have not been spared.

'Outside the gargantuan task of braving the emergence of fake news and protecting press freedom, the survival of the working media is also an urgency. Foremost among the objects of the

assembly is the feasibility of creating a Local Press Council and establishment of a cooperative news agency whose implications extend to every rural media's occupational needs.

'With coercions from red-tagging, criminal libel cases, prostitution by pseudo-journalists, and the spooky influences politics has introduced, revisiting press freedom and introducing new cogent proposals, no matter how slight, should create a specter of hope among journalists who have always believed in the inviolability of honest and truthful reportage.

'For the rural press, tagged as second-class institutes, the greater role is to strengthen its resolve against negative challenges and to create a network that can feed the true media outlets in urban centers with reports that expose the inanities occurring in the way the bureaucracy is being run by scheming minds. It is a tall order, but the genuine press must not cower in dread.'

Whether it is a matter of dedication to the job or the passion for such calling, there are only a few people around, particularly in media, who fit the portrayal. In most cases, individuals accept a job for a recompense even when the passion for such vocation falls short of expectations.

For Juan Punzalan Dayang, one of the oldest active media practitioners today, dedication and passion are inseparable features of a thriving and at times provocative press. The same dynamism describes the pursuit in the realm of an all-encompassing public governance.

Dayang's lifetime of involvements cuts across many fields of discipline, from media to public service, including directorial stints in the academe, civic activities, insurance, and a brief stint in politics. What makes him an even more compelling media profile is the track record he carries as one of the noteworthy pillars of numerous high-profile press organizations.



Fondly called Johnny by peers and scribes, Dayang totes the honor as the first elected director of the National Press Club (NPC) to represent the rural media.

Over six decades of involvement in the quest for a dynamic and free press and the protection of press people, Dayang was former president of the Manila Overseas Press Club (MOPC) and now chairman emeritus of the Publishers Association of the Philippines, Inc. (PAPI); a trustee of the Philippine Press Institute (PPI); founder of Aklan Press Club, Inc. (APCI); trustee and secretary of the Catholic Mass Media Awards (CMMA) Foundation; and secretary-general and now chairman of the Federation of Provincial Press Clubs of the Philippines, Inc. Magparehistro sa PhilHealth KonSulTa Facility

Sa ilalim ng RA 11223 o Universal Health Care, ang PhilHealth ay dapat na magpatupad ng isang primary care benefit para sa lahat ng Filipino.

Kaya naman maigting ang pagsusulong ng primary care upang mabigyan ang bawat Filipino ng maayos at sapat na pangangalaga sa kalusugan dahil ito ang magisisilbing navigator, initial at continuing point of contact





para sa buong health care system delivery. Sa pamamagitan ng PhilHealth Konsulta, maagapan ang karamdaman ng pasyente at maiiwasan ang paglala ng karamdaman dahil may duktor na regular na susuri sa miyembro.

Kailangan na rehistrado sa PhilHealth upang maka-avail ng PhilHealth KonSulta. Para sa mga hindi pa reshistrado, kinakailangan lamang na magpatala at magsumite ng PhilHealth Member Registration Form (PMRF) sa pinakamalapit na PhilHealth Local Health Insurance Office para mabigyan ng PhilHealth Identification Number (PIN).

Gayundin, upang magamit ang PhilHealth Konsulta, kinakailangan na ang miyembro ay pupunta lamang sa isang Konsulta facility kung saan nakarehistro ang miyembro. Ang pagpaparehistro sa isang Konsulta facility ay alinsunod sa itinakda ng Universal Health Care (UHC) Law. Ito ang paraan ng gobyerno upang masiguro na ang bawat Filipino ay mayroong doktor na tutugon sa pangangailangang pangkalusugan; at magkaroon ng continuity of care sa pamamagitan ng referral na manggagaling sa Konsulta facility.
