Sustain the gains of EDSA People Power ifty seven million Filipinos — or slightly more

than half of the country's population — were born after the historic events at EDSA in 1986. It is understandable that many of them are unable to fully grasp the full significance of today's commemoration of the 36th anniversary of the triumph of People Power that restored democracy to our land after more than a decade of

martial law and dictatorship.
It was on Feb. 25, 1986 that President Corazon C. Aquino was sworn into office. This occurred after a tumultuous snap election and the "defection" of then Defense Secretary Juan Ponce Enrile and AFP Vice Chief of Staff Fidel Ramos supported by rebel AFP officers triggered a series of mass demonstrations by thousands of people on EDSA.

A new Constitution was affirmed by the people in a plebiscite and came into force on Feb. 11, 1987. This is the Constitution that has enabled a peaceful transition and installation of four Presidents: Fidel V. Ramos, Joseph Ejercito Estrada, Benigno S. Aquino III, and Rodrigo R. Duterte. President Gloria Macapagal Arroyo became President in the aftermath of a disrupted impeachment trial followed by another EDSA upheaval in January 2001. The Supreme Court affirmed her accession to power as being in accord with the Constitution. She served a full, six-year term after the 2004 elections. Hence, political stability is one of the important aspects of the EDSA legacy.

Economic recovery was also paved by the triumph of People Power at EDSA. Recall that the Philippines plunged into serious economic doldrums following

investigation Thursday, February 24, to help find solutions to the growing problem of Filipinos' addiction to esabong.

He said representatives of the Philippine Amusement and Gaming Corporation (PAGCOR) and the Philippine National Police (PNP) will be invited to the investigation to help solve the mystery behind the abduction of about 30 men amid reports that these disappearances were tied to e-sabong.

Cayetano said other incidents have occurred due to e-sabong including the case of Laguna patrolman Glenn Angoluan who was arrested on February 21, 2022 after robbing a gasoline station in Santo Tomas, Batangas to pay off his e-sabong debts.

He also pointed to the case of 19-year-old Erick John Suelto from Maco, Davao de Oro who was arrested in November 2021 for failing to pay off his debt from e-sabong.

'Wag nating hintayin na mas marami pa ang mawala at mabaon sa utang.

Let's protect our kababayans, especially our youth," Cayetano said.

He also said the revenue generated by the game is "not worth the lives of the youth and the destruction of our society's moral fiber."

During an ambush interview by Cavite local media men, Senator Villanueva signified his intent to push for the enactment of legislations such as the National Employment Recovery Strategy that would create two million jobs and putting into law the TUPAD Emergency Employment Program, and the Unemployment Insurance which will

benefit the workers/ employees in cases where they are displaced due to crisis such as the Covid-19 pandemic.

He also mentioned that his bill seeking to double the Senior Citizen's pension from P500.00 to P1,000.00 is already in the plenary for approval.

According to Senator Villanueva, with the establishment of the Department of Overseas Filipino Workers, the designation of undersecretary will give funding for department that will focus on the assistance to OFWs whether medical, legal, and repatriation.

"The government should be proactive in caring and protecting for the welfare of the OFWs," said Villanueva on the issue of OFWs in Hongkong who were evicted from their employer's homes due to Covid-19 infection.



On the other hand, Senator Migs Zubiri spoke on current issues and concerns in the country that needed to be addressed with the creation of legislations.

One such issue is the construction of Regional Specialty hospitals that will give access to medical services under particular specialization to more Filipinos all over the country.

Senator Zubiri shared his insight regarding the government's disaster response with

establishment of the Department of Disaster Resilience.

"We have to make sure that buildings and structures are typhoon and climate change resilient, then we have to focus on the training of each LGUs for the rescue, rehabilitation reconstruction response during and after disaster," Sen. Zubiri said.

Senator Migs also expounded on the Bayanihan 3 which he said is basically the government's pandemic

measure for the country's economic recovery. This will give additional funding for distressed industries to recover such as the MSMEs, and restaurants and hotels that had been shut down during the CoVid-19 pandemic.
