

# **Postmortem of Philippine Democracy** The communication: of an activism pedagogy is not a form of terrorism – it is based on one's political spectrum when taken into streets of the underserved.

Being able to start a conversation is an advantage. It takes a lot of courage to gather all your thoughts in a minute and discuss them openly with the people around you, which is why when the pandemic struck, it shifted the worldview of communication into something new, as if our digital self has been empowered by the cyberspace system. It massively changed one's line of communication from face-to-face to online and led us to devise our digital identity, and this has resulted in the loss of our communication skills, which some may misinterpret or be overwhelmed by what you have said because it is a plain chat with no emotions that can be heard as explained by John Suler. Listening, finding our middle ground, and embracing the confrontation are the key essentials in being a good communicator that we have lost over time because we have been so enamored with cyber systems and contrary to the popular myth, it can be indicted by one can turn "on" of being a good communicator; what we say, should be understood; and there is no need to prepare since we can improvise, because communication is a two-way process and it takes time to be understood, not just by a click of a hand.

Whether you say that you are knowledgeable on how to vocalize your thoughts, it only becomes incorrect when you dismal & misinform, and condemn the degradation of individuals. And there's no doubt that in this era, the escalation of fake news; the birth of "satirical clickbait"; and blind-fanaticism by all means, gets in the way. Remember the times of Philippine President Rodrigo Duterte with his countless reports of slurs, false claims, and profanity? Your colleagues who told you that you should "shut up" when you are talking about the candidate's wrongdoings and presented it with facts? And some Facebook replicate-pages of media companies like Bakkler of Rappler & Philippine Char of Philippine Star, that spreads disinformation? That is it.

By joining, bothering the comfortable, organizing a mobilization, and reflecting why there is a need to call out the wrongdoings -- activism takes a toll on the wide amplification of voices that are unheard and apprehending resistance as a duty when those who have power continue to take away our freedom in daily matter.

Hence, enough is enough; an end of fanaticism to politicians that, not often, is consciously seen as an invitation to satisfy the public's blind interest and to not act upon the vowed responsibility. We, Filipinos, should be responsible and vigilant enough to fact-check pieces of information we are inhaling, raise awareness in debunking/reporting clickbait propaganda that misleads, and take away the power of blind-fanaticism that thrives for one-sided and such fiascos. And one thing is for sure: communication is not just being grasped as something to be correct, it is to convey to catalyze.

May this glimmer of hope continue to burn, and may action prove, for this is our last chance to defend our rights through legal means. You were not just born. You are called; to shun the chance of a postmortem happening in Philippine democracy.


