

The Department of Health (DOH) Center for Health Development CALABARZON has recently released its data which indicates an increase in the reported dengue cases in the region.

According to the July 16 data of DOH IV-A, there are now 6,362 reported dengue cases in the region from January 1 to July 16, a 53% increase based on the same time frame in 2021 with only 4,151 total cases.

No more lockdowns - Pres Marcos In balancing PH economy with public health

QUEZON CITY, (PIA) -- One of the statements that marked the first State of the Nation Address (SONA) by President Ferdinand "Bongbong" Marcos Jr. on Monday was the end of lockdowns as part of the government's response against the COVID-19 pandemic.

According to the President, there must be a balance between the country's economy and the health and welfare of Filipinos.

"In our health situation, the threat of COVID-19 is still there, especially with the discovery of variants of the coronavirus, but we cannot afford another lockdown," President Marcos said.

We will not do any more lockdown. We must balance the health and welfare of our citizens on one hand and the economy on the other," the Chief Executive added.

President Marcos, who was recently hit by COVID-19, said he wanted to intensify the vaccination rollout of booster shots in the country.

He said this will ensure the safety of students amid the continuation of their face-toface classes.

The Chief Executive said the COVID-19 Alert Level System would remain for now, while he studies the reclassification of the restrictions, which he said would be more compatible or suited to the current milder strains of the coronavirus.



Remember the rules to keep dengue away

Te have been so focused on wearing a mask

washing our hands, keeping a social distance to prevent the spread of Covid. Many may have forgotten the other guidelines that should be followed at about this time of the year when the rains - and the mosquitoes carrying the dengue virus -come.

In the past weeks, the alarm over the rising cases of dengue around the country has been sounded by the Department of Health (DOH). From January to July 2, 2022, DOH recorded 65,190 dengue cases and 274 deaths. The more serious number though is that the 65,190 cases is an 83 percent increase from the dengue cases in the same period of 2021, which is 35,715.

Last July 12, the province of Antique declared a state of calamity due to dengue which was reported in all of its 18 municipalities, with a total of 1,575 cases, and six deaths from January to July 9. Again, the serious part of the record is that the number of cases is 556 percent higher than last year's, only 241 cases, with two deaths.

Dengue, a mosquito-borne viral disease endemic in the Philippines, is a familiar term among Filipinos. It is discussed in schools, work places, churches, and homes,

especially at the onset of the rainy season.

Perhaps because of living amid a pandemic, people have been more dedicated to following the health and safety protocols to prevent the spread of Covid. Programs to prevent dengue should be more eagerly initiated and implemented to get more support in the barangay level. Community effort to conduct regular clean-up activities in each neighborhood, for example, can do much to prevent the breeding of the Aedes aegypti and Aedes albopictus mosquitoes.

For example, is the 4 o'clock habit, which is part of a DOH campaign, still practiced? That's the cleaning of one's surroundings every 4 o'clock in the afternoon. Do households still put mosquito repellent gadgets or substances outside their house to keep the mosquitoes away?



The rules come under DOH's Enhanced 4-S program which outlines what each person can do to keep the dengue cases down. 4-S stands for "Search and destroy mosquitobreeding sites; "Secure self-protection measures (like wearing long sleeves and long pants in places where mosquitoes are); Seek early consultation, and Support fogging or spraying in hotspot areas."

Here are a few reminders about dengue: It is transmitted by the female Aedes aegypti and Aedes albopictus mosquitoes which bite during the daytime – about two hours after sunrise, and two hours before sunset. If bitten, one will experience the following symptoms: sudden onset of

fever which can go on for two to seven days. It comes with two of the following discomfort: headache, body weakness, joint and muscle pains, pain behind the eyes, loss of appetite, vomiting, diarrhea, and skin rashes, the DOH advisory said. Dengue fever can progress to a more severe form known as dengue hemorrhagic fever (DHF) which can be fatal if it is not recognized and treated promptly.

Today, Sunday, take a walk outside your house to check on the presence of containers which may contain stagnant water. Clean your surroundings. Cover your arms and legs. Check if your barangay has scheduled a fogging operation.


This is not new. The Ateneo shootings are a complete witness to what is the true State of the Nation.

"A moratorium will give the farmers the ability to channel their resources in developing their farms, maximizing their capacity to produce and propel the growth of our economy," Marcos Jr. said.

He urged Congress to pass a law to amend Section 26 of Republic Act No. 6657 to free the agrarian reform beneficiaries (ARBs) from their debts where loans of ARBs with unpaid amortization and interest will be condoned.

"The purpose of this law is to erase the unpaid debts of our farmers who are beneficiaries of the agrarian reform," he added.

Marcos Jr. also promised the ARBs who are still to receive their awarded lands under the Comprehensive Agrarian Reform Program (CARP) will no longer have to pay any amortization for their lands.

He said the proposed condonation will cover a total amount of P58.125 billion that would benefit 654,000 ARBs involving a total of 1.18 million hectares of awarded lands.

On Executive Order No. 75, Series of 2019, where all government agencies, agencies, bureaus, departments, and instrumentalities are required to turn over agricultural lands to qualified ARBs, Marcos Jr. said that at present, there are a total of 52,000 hectares of unused agricultural lands of the

government which can be distributed in accordance with Section 14 of RA 6657 as amended.

He said that priorities for distribution will be landless war veterans, landless surviving spouses or orphans of war veterans, landless retirees of the Armed Forces of the Philippines, and the Philippine National Police.

"Agricultural lands acquired under this program will be given to graduates of college degrees in agriculture who are landless," Marcos Jr. said.

He added that the country needs a new breed of farmers equipped with modern agricultural technology that is able to engage in sustained scientific farming to increase farm yields and are resilient in the face of climate change. (DAR)

In terms of cities and municipalities with the most cases, Antipolo City leads with 601 cases; followed by San Pablo City with 346; Calamba City at 313; Imus City at 215; and Candelaria at 181 cases.

Dengue is transmitted by the mosquitoes Aedes aegypti and Aedes albopictus, which commonly bite during the day, but may also bite at night. These mosquitoes lay eggs in clear and stagnant water (including water in flower vases, and clean rainwater collected in barrels, cans, or old rubber tires). Adult mosquitoes rest in dark places of the house. Mosquitoes can also become infected with the virus when they bite a person who has already been infected and can thus spread the infection to other people.

According to DOH Healthy Pilipinas, some of the symptoms of dengue include sudden onset of high fever which may last from 2 to 7 days; joint

and muscle pain, pain behind the eyes, and/or headache; feeling weak, skin rashes, nausea, and vomiting, decreased appetite, bleeding during hemorrhagic fever, which manifest can nosebleeding, bleeding, vomiting of coffee-colored matter, dark-colored stools, or even just abdominal pain (as a sign of internal bleeding).

The DOH continues to remind the public to follow the 4-S against Dengue or 1) Search and Destroy Mosquito Habitats (which include draining clear stagnant and accumulated water from tires and pails, and jars); 2) Self-Protect by wearing long pants and long-sleeved tops and by mosquito using repellants; 3) Seek Early Consultation consulting a physician immediately if fever persists after 2 days or any other symptoms appearing, and 4) Say Yes to Fogging when there is an impending outbreak. — (Christopher Hedreyda, PIA4A).


