Marcos remains committed to uphold right to free speech, press freedom PRESIDENT FERDINAND 'Bongbong' Marcos Jr., had ordered a probe on the killing of radiobroadcast journalist Percival, known better as 'Percy Lapid' as he assured the members of the media that personally he remains committed to

upholding the right to free speech and press freedom.

Lapid, a former director of the National Press Club was murdered on Monday evening, October 3 in Las Piñas City. Speaking with the members of the Manila Overseas Press Club (MOPC) during its President's Night in Pasay City, Marcos said he shared MOPC's "conviction in the importance of upholding the universal right of free speech and press freedom as well as giving and receiving accurate information."

The top officials of the Philippine National Police and the National Bureau of Investigation has started a probe to arrest the mastermind and killers of Lapid. Marcos said that under his lead, the national government "will support and protect the rights of the media as they efficiently perform their duty."

The Chief Executive added that the government is ready to lend an ear and listen to the media's concerns and is ready to answer all that the press people may want to know. In another development, businessman and lawyer Alex Lopez on Tuesday, Oct. 4 has offered P1 million reward to anyone who can provide vital information to the killing of Lapid.

Lopez, the son of former Manila Mayor Mel Lopez said Lapid's relenless passion for truth and justice has become an equilibrum for preserving good governance and real public service in the national and local

government.

Likewise, Lopez said the he trust President Marcos through the PNP remains committed to protecting human rights.



DSWD ready to implement solo parents law after IRR approval

THE Department of Social Welfare and Development (DSWD) is absolutely prepared to put into action the newly signed implementing Rules and Regulations (IRR) of the Expanded Solo Parents Welfare Act.

DSWD Secretary Erwin Tulfo, however, said they need a few days more before it becomes fully operational.

"We have to give like about 15 to 30 days dahil ipapublish pa ito sa mga pahayagan, sa media, bago ito maging fully operational, "Tulfo said. The secretary said that business establishments should

start complying with the mandates stated in the IRR entitling the solo parents to receive certain discounts from them once the law becomes operational.

Shining a spotlight on the significance of shelter

t is a fact of life that in order for humans to survive in this world, food and water are not enough. There should be a shelter over one's head, a protection against the harsh outdoor elements and the changing weather. Therefore, owning or living inside a decent shelter is deemed as a basic human right that everyone - regardless of color, gender, economic status, or educational attainment - must experience in his or her lifetime. The reality, however, is far from it.

The United Nations (UN), during the 58th Session of the UN Commission for Social Development in 2020, revealed that globally, "1.6 billion people live in inadequate housing conditions, with about 15 million forcefully evicted every year." It also noted that in the past decade, there was an alarming rise in homelessness, which it defined as a "serious violation of human dignity...affecting people of all ages from all walks of life." For Mary McAleese, former president of Ireland, she said during the forum that homelessness makes human society "diminished" and makes people "lose the gift of creativity, curiosity, and potential."

We don't have to look far as we are first-hand witnesses of the plight of homeless Filipinos once we step outside the comforts of our own home and take the road to go somewhere. It is not surprising as the Philippine Statistics Authority (PSA) revealed that in 2021, there were 4.5 million Filipinos who were homeless, most in urban centers such as Metro Manila.

Considering these data, it now becomes a tall order for the present administration to address the homelessness crisis, a perennial source of headache even for past presidents and former housing officials. The Marcos administration, through Department of Human Settlements and Urban Development





(DHSUD) Secretary Jose Rizalino Acuzar, unveiled its long-term housing program recently called "Pambansang Pabahay Para sa Filipino: Zero ISF 2028" in time for the observance of National Shelter Month this October.

Aside from the program, Acuzar also unveiled this year's theme "Abot-Kayang Pabahay Tungo sa Panatag na Buhay," which underscores the DHSUD's objective of "providing affordable and decent shelters to uplift the lives of Filipinos, particularly the informal settler families and those in the low-income bracket." To make its mission clear, the DHSUD aims to build one million housing units every year — or a total of six million housing units within the six years of the current administration. "This year's celebration encapsulates the goal of the DHSUD to provide affordable yet decent and sustainable shelters that will give Filipino families a sense of security," Acuzar said. With a foundation plan set in place and programs set to go, there is no room for error in the quest to convert informal settlers into legitimate homeowners.

Now, it is a fact that for Filipino families, owning one's home is the ultimate goal, a reason to work harder, even to risk one's security and comfort to work abroad.

Ask any working Filipino today and a majority will answer that they are sweating blood and tears just to put up a decent home for their family. We hope the government, through the DHSUD, will give these hardworking Filipinos a helping hand, not more hard times and paperworks ahead.

I thanked our Dear Almight Father in Heaven for this gift of long life and I can say, I am relatively health and still "bright" like a 50-year old guy (naks, yabang ko, huh! and continues to produce news, columns and literary pieces on my old HP laptop computer.

I continue to serve as Editorial Consultant to a number of Cavite weekly paper and an "attorney-out-of-law" to some colleague who were lucky to be charged with libel suits and other complaints, all of them were dismissed.

If ask by a friend or two to compose legal briefs and motions to judges, okay naman at nakapapasa, kaya ang tawag sa akin ay 'Atorni Loco.'

Last July 12, 2021, I underwent a protate surgery at the Burnaby General Hospital here in British Columbia, and fast recovering, according to Dr. David Telio, Dr. John

DOST inaugurates first MEDOWW Treatment System Technology in CALABARZON The Department of Science and Technology (DOST) - CALABARZON

inaugurated the first ever Modular Ecology-Friendly Domestic Wastewater (MEDOWW) Treatment System Technology in the region established at Brgy. Anilao Proper, Mabini, Batangas, Sept. 22.

The adoption of MEDOWW Treatment System technology is one of DOST-CALABĂŔZON's answers to the call of the Local Government Unit of Mabini (LGU-Mabini) for a science and technologybased solution to mitigate environmental the pollution brought about by untreated wastewater. Generally, the technology works to improve the wastewater management at the Municipal Tourism Office Building and Public Market, both located at Anilao Proper. The technology uses a flexible design for domestic wastewater treatment and establishes an effective combination of anaerobic and aerobic mechanisms. It is built with several chambers and operates with the application of Vigormin organominerals which hastens the decomposition of harmful bacteria that lodge in

septic tanks. The application of Vigormin helps in the bioremediation and at the same time in the settling of pollutants or pollution load.
