Editorial

Don't spread fake news

he spread of fake news is alarming. In Pulse Asia's recent survey, nine in 10 Filipinos believe fake news is a problem. And the belief

covers a large spectrum of the society.
"This is the prevailing sentiment at the national level (86 percent), as well as in each geographic area and socio-economic grouping (77 percent to 92 percent and 74 percent to 93 percent, respectively). Agreement with this opinion is more pronounced in Metro Manila and the rest of Luzon than in the Visayas and Mindanao (87 percent to 92 percent versus 77 percent to 81 percent) and in the better-off Classes ABC and D than the poorest Class E (87 percent to 93 percent versus 74 percent)," Pulse Asia said.

The same survey showed that internet or social media (68 percent) and television (67 percent) are the leading sources of fake news about government and politics. Other sources are: radio (32 percent), friends/acquaintances (28 percent), family/relatives (21 percent), community leaders (four percent), newspaper (three percent), and religious leader (one


Who are responsible in spreading fake news? The survey showed they are social media influencers (58 percent), journalists (40 percent), national-level politicians (37 percent), local politicians (30 percent), civic leaders (15 percent), businessmen (11 percent), and academics or teachers (four percent).

While some may blame digitalization for the advent of fake news, the problem is nothing new.

"The reality of deception is as old as [the Book of] Genesis," Christian writer and book author Randy Petersen said in his piece, "Fake news and the Bible."

So how can we address this age-old problem? Some suggest legislation, but this may end up as a violation of the Constitution.

Article III, Section 4 of the 1987 Constitution clearly states: "No law shall be passed abridging the



freedom of speech, of expression, or of the press, or the right of the people peaceably to assemble and petition the government for redress of grievances."

"I don't think legislation is necessary. The Constitution guarantees free speech, and it would be ironic if we regulate or restrict speech or other expression just because we have different opinions or views," Sen. Nancy Binay said, even if she believes fake news is an "uncontrolled virus."

With legislation a questionable option, solving the problem needs a whole-of-society approach. Everyone should contribute his or her share in battling fake news. And this should begin in us.

We must take note that in the Pulse Asia survey, friends and family also comprise a big chunk of those responsible in spreading fake news.

For friends and family members, we believe there is no conscious effort to spread fake news. The problem

lies in the eagerness to share information that pops out in our social media walls, without taking into account the veracity and consequences of the shared data. As they say, "read before you click."

Prophet Moses' warning in the Book of Exodus in the Holy Bible – "You shall not spread a false report" – should serve as a good guide for everyone to keep us from spreading fake information.

And we must also remember what's written in Proverbs 12:22: "The Lord detests lying lips, but he delights in people who are trustworthy."

Whether you are a social media influencer, a journalist, a politician, a civic leader, a businessman, or an academician, you have an important role to play combatting fake news.

Take these two Bible passages to heart and just be responsible in what you share - it must be the truth, the whole truth, and nothing but the truth.

Despite the blow he was dealt, he mustered the will and determination to move forward. Soon, Department of Environment and Natural Resources enlisted his help to plant Bakawan or mangrove

As the president of the Samahang Makakalikasan ng Pampanga, Inc. (SAMAPA), Mr. Canilao has been working tirelessly with the government and the private sector in the last decade to help build a coastal forest for the natural protection of their community in the municipality of Macabebe, to avoid pitfalls in the wake of another storm like Typhoon Glenda.

This year, he is delighted know that Foundation, the social good arm of SM and Fast Retailing Foundation, a general incorporated foundation in Japan, are providing extensive support by planting Bakawan trees in his coastal community under their joint 'Grow Trees Community' project. This reforestation initiative is set to introduce at least 100,000 mangrove trees of the Bakawan babae and lalaki species in Barangay Consuelo in the municipality of Macabebe, the second site after the project formally launched in Batangas last September 27.

"Malaking tulong itong mangroves para sa akin, para sa pamilya ko at sa aking mga kababaryo na magkaroon din po ng hanapbuhay. Sa darating na henerasyon, mga makakatulong ang mga bakawan sa dipensa sa malalakas na alon at hangin (Mangroves are a huge help not just to my family but to my fellow villagers, also in supporting livelihood. The bakawan will help the next generation gain protection against strong winds and waves)," Mr. Canilao said.

Aside from providing a natural coastal defense against storm surges, the Bakawan has been widely personified in Filipino fiction and many children's books for its role in nurturing biodiversity environment.

"As visitors, we often see the beauty of the mangrove thickets, but for communities, this is nature's shield that protects them from natural calamities and serves as breeding grounds for fishes and shellfishes," Cristie S. Angeles, SM Foundation Assistant Vice President for Livelihood and Outreach Programs said.

well-preserved mangrove forest can provide an ecosystem of interconnected benefits promoting biodiversity in marine life and a reserve of valuable resources. Beyond this, the collective efforts of the community are vital to the preservation of the environment. As enables the growth of so many communities, we are also enabling these communities to lead the preservation of environment in their areas," Ms. Angeles added.

"We are particularly drawn to this project which is a first in terms of our partnerships here in the country. Mangrove trees have an enormous capacity only to absorb greenhouse gases making them ideal in bringing about climate benefits but they also enrich the biodiversity as well. 



TRECE MARTIRES, Cavite – The health officers of the local government units (LGUs) in the First District of the province convened for the first time with Cavite First District Representative Jolo Revilla to discuss plans for the district's health care system.

Congressman Revilla also revealed various infrastructure projects for health facilities in the first district such as the dialysis centers in Rosario and Kawit towns, Mega Rural Health Unit in Rosario, the public city hospital in Cavite city, the completion of the Noveleta infirmary, and the enhancement of our own District Hospital.
