SSS RACE campaign probes delinquent entreps in Cavite town

The Social Security System rolled out its Run After Contribution Evaders (RACE) Campaign in the municipality of Naic this October 14 to intensify the campaign correcting errant business owners/employers.

The activity was headed by SSS Luzon South 1 Division Acting Head Edwin S.



Igharas, and SSS Rosario Branch Head Eva E. Tomenio wherein ten delinquent establishments were visited and were issued written orders to which they must respond within fifteen (15) days to settle the obligations due.

According to SSS records, more than P 2M in obligations due are expected to be paid by these establishments.

This is a non-compliance under the Social Security Act of 2018 (RA 11199) which will affect the benefits of 139 employees. The employer may also be prosecuted if they would not settle the obligation on the said date.

Acting Head Edwin Igharas encouraged delinquent employers to apply for SSS' penalty condonation programs which will give them the opportunity to settle their obligations in lighter methods or thru installment payment terms.

"You can avail of our penalty condonation programs such as the Pandemic Relief and Restructuring Program 3 (PRRP 3), and Enhanced Installment Payment Program that can be availed until November 22, 2022. Also, there are the Contribution Penalty Condonation Programs for business and household employers," Igharas explained.

On the other hand, Ms. Tomenio advised concerned and interested employers to visit their branch office at 248 Abutin Building, Barangay Tejeros Convention for proper coordination with the Account Officers. (RBF/PIA-Cavite)

World Food Day 2022: Leave no one behind

ore than 150 countries around the world are celebrating World Food Day (WFD) in more than 50 languages and through hundreds of activities and programs, making it the most

celebrated United Nations (UN) day of the year.
Food is a basic need. It gathers government and private sector to discuss – and implement – policies and processes that will ensure food security. It gathers families, friends and strangers to talk and build relationships that strengthen communities. It also creates heroes who work hard to produce, plant,

harvest or transport food to sustain our world.

The significance of World Food Day, established by the Food and Agriculture Organization (FAO), is highlighted by the involvement of key people in

launching this year's celebration.

In Rome, headquarters of the FAO, Director-General QU Dongyu, officially launched this year's celebrations on Oct. 14. Attending the meeting were the mayor of Rome, the heads of the other UN Rome-based agencies, and the executive director of the World Food Programme (WFP). Giving special messages were Pope Francis, the president of the Italian Republic Sergio

Mattarella, and UN Secretary-General António Guterres. In the Philippines, President Ferdinand R. Marcos, Jr., who is also the Agriculture Secretary, will lead the celebration and the start of week-long activities tomorrow. Giving special messages will be Senator Cynthia Villar, chairman of the Senate committee on agriculture, food and agrarian reform, and country

officials of the FAO and WFP.

Around the world hundreds of private sector groups and non-government organizations are also celebrating the day with various activities like feeding programs.

The activities support World Food Day 2002's theme - "Leave no one behind, through better production, better nutrition, a better environment, and a better life."

For as we are aware, food also defines what separates people - the bountiful presence of food on the table states privilege; its absence describes the poor.

As FAO defines the challenge: Our globalized world is one where our economies, cultures, and populations



are becoming increasingly interconnected. Some of us are vulnerable because of who we are or where we live, but the reality is that we are all fragile. When someone is left behind a chain is broken. That impacts not only the life of that person, but also ours."

It focuses on the reality that millions of people live with hunger and malnutrition. Around the world, as many as 828 million people suffer from hunger and 3.1 billion people - almost 40 percent of the world's population - cannot afford a healthy diet, a FAO statement said.

In the Philippines, the proportion of poor Filipinos in 2021 was recorded by the Philippine Statistics Authority at 18.1 percent, or 19.99 million Filipinos who live below the poverty threshold.

The call to "Leave no one behind" is a big challenge.

Food scarcity has been pushed by many factorsconflicts, climate change, rising prices, and recently, the Covid pandemic.

Today, a "global solidarity" is needed to transform agrifood systems to foster inclusive economic growth, and achieve sustainable development," a FAO statement said.

World Food Day helps raise awareness of the crucial need for successful agriculture policies to ensure that there is ample food for everyone.

Meanwhile, what can one person reading this editorial do to celebrate World Food Day? Donate cash or food to an organization that works to fight hunger in the Philippines. Volunteer to teach livelihood skills to people poor communities. Get involved in agriculture.

Moreover, women have specific hygiene needs. Specially on the access to sanitary products and disposal systems to manage their menstrual hygiene and pregnancy.

this, With Department of Science and Technology (DOST) Region 02 through the program Community Empowerment Science and Technology (CEST) geared towards establishing and improving the water management of these farflung communities in Cagayan Valley.

The DOST-CEST program is a package of S&T interventions that aims to build empowered, progressive, and resilient communities. CEST is DOST's response to the government's whole of the nation approach in support of reaching the marginalized sectors like farmers. fisherfolks, indigenous people, women's organizations, and of those residing Geographically Isolated and Disadvantaged Areas or **GIDAS**

One of the beneficiaries of CEST is Sitio Amilan in barangay Baliuag, Penablanca Cagayan. One of the reasons the area was chosen is because of their lack of access to safe drinking water adequate sanitation.

Residents in this area outsource water from streams and springs accessible only through the pace of the mountain. Thus, the scarcity of water is experienced especially during summertime, and also a challenge during the wet season due to the slippery trek.

Through the CEST program, the community will be given access to clean and potable water. This is also one of the goals of the DOST to promote health and sanitation that will serve avenue of an opportunities for safe water and other domestic uses of water in the Region.

DOST R02 in partnership Pentur Farmers Agriculture Cooperative funded a total of P445,000 for the provision of a water distribution system to the community.

On October 14, 2022,



the turnover of the funds was led by the Assistant Regional Director for Field Operation Services Engr. Sylvia Lacambra together with Science Research Specialists Ms Rowena Guzman and Engr. Benjamin Nicdao and Project Assistant Mr. John Benedic De Asis.

This project will solve the sufficiency and easy access of water supply in the area most especially the women in connection with their specific hygiene needs and personal use.

Moreover, this will be a great benefit to lessen the risks of acquiring waterborne diseases that will improve community's educational and economic opportunities.

One of the goals of this project is also to explore the gender dynamics of the residents in the sustainability and functionality of their water supply systems, with the aim of addressing approaches to women's empowerment in the water

DOST02 will also be

providing assistance on laboratory and consultancy services including the training and maintenance of the project. It is also necessary to involve all the users of the community in order to identify potential contaminating sources and misuse of land management that can contaminate water.

The bucket of hopes and dreams of the community is now finally coming to life. With the continuous assistance of DOST R02 the limitations and challenges of the community will be

resolved.

adoption of The MEDOWW Treatment System technology is one of DOST-CALABARZON'S answers to the call of the Local Government Unit of Mabini (LGU-Mabini) for a science and technologybased solution to mitigate environmental pollution brought about by untreated wastewater. Generally, the technology works to improve the wastewater management at the Municipal Tourism Office Building and Public Market, both located at Anilao Proper. The technology uses a flexible design for domestic wastewater treatment and establishes an effective combination of anaerobic and aerobic mechanisms. It is built with several chambers and operates with the application of Vigormin organominerals which hastens the decomposition of harmful bacteria that lodge in septic tanks.

The application of Vigormin helps in the bioremediation and at the same time in the settling of pollutants or pollution load. The reason for having several chambers in the design is to allow settling which results to lowering of the particulate settleable solids (PSS). globally competent STI champions to support the national innovation agenda, ushering the transformation of municipalities and cities into smart, resilient, and sustainable communities, and undertaking collaborative science, technology, and innovation initiatives and strategies for s o c i o e c o n o m i c development and welfare of the public.

During the meeting, one of the cited DOST Programs was the Small Enterprise Technology Upgrading Program (SETUP) which capacitates Micro, Small, and Medium Enterprises (MSMEs) through funding technological adoption. SETUP alone has over 8,732 assisted MSMEs as of June 2022.

Another significant contributor to the achievement of DOST goals is the Community Empowerment thru

Science and Technology (CEST) program. CEST interventions in the regions aim to enhance the quality of living in remote communities in the country as it addresses difficulties in accessing jobs, health and nutrition, disaster risk reduction activities, and e n v i r o n m e n t a l conservation.

The program has already assisted 1,113 communities from 2016 to the 3rd quarter of 2022. Meanwhile, the budget cut on the DOST for CY 2023 limits the execution of the planned PPAs and affects the intentions to scale up programs.

The Assistant Secretary for Finance and Strategic Planning, Maridon O. Sahagun, joined the discussions on the enhancement of financial management and the strategic plans on how to increase the budget. In support of this,

Mabborang, is looking to accumulate resources to fund pilot-tested programs for nationwide rollout such the Grassroots Innovation for Inclusive Development (GRIND), the Innovation, Science, and Technology for Accelerating Regional Technology-Based Development (ISTART), and the Smart Sustainable Communities and Cities (Smart City).

The GRIND program will gear towards identifying grassroot innovations for jumpstarting community-based livelihood through processing intellectual properties resulting in commercialization of technology is a laransformation.

The iSTART program, on the other hand, impels local government units (LGU) to advance regional development through investment direction, recommendation on policies, accreditation and

deployment of researchers, scientists, and engineers, to name a few of its interventions.

Lastly, the Smart City program by definition is the maximizing of scientific and t e c h n o l o g i c a l advancements to produce h i g h - p e r f o r m i n g communities in aspects of human capital, human wellbeing, environmental quality, governance, and urban planning.

All these programs in its entirety ultimately coincides with the socioeconomic agenda of the DOST. The DOST and its regional offices, all of which were represented during the meeting, assures the strengthening of Science, Technology, and Innovation in the country.

The DOST aligns its priorities in support of the agenda set by the current administration to contribute not only to countryside development but to national growth essentially p e r s o n i f y i n g #OneDOST4U.


