Why COP27 matters to PH now more than ever


that in a place called Sharm El-Sheikh in Egypt, a very important two-week event called COP 27 has started, shaping up as perhaps the most consequential gathering of world leaders that will determine the future of this planet and the lives of the most vulnerable. The 110-million plus Filipinos, ironically, are part of this most vulnerable segment. And yet, again, majority of us are not even aware of COP27, which has far-reaching consequences, especially to the fourty generations.

COP27, short for Conference of Parties, is the 27th United Nations Climate Change Conference. It opened last Nov. 6, 2022 and will conclude on Nov. 18. The Philippine contingent, composed of members from Congress, various departments, and environmental groups, is led by Environment Secretary Maria Antonia Yulo-Loyzaga.

During the opening remarks given by UN Climate Change Executive Secretary Simon Stiell, he signaled that a "new era begins and we begin to do things differently." "Paris (COP21) gave us the agreement. Katowice (COP24) and Glasgow (COP26) gave us the plan. Sharm El-Sheikh (COP27) shifts us to implementation. No one can be a mere passenger on this journey. This is the signal that times have changed," Stiell said.

This opening couldn't be more appropriate as this year's UN Climate Conference opens against a backdrop of extreme weather events worldwide, an energy crisis propelled by the war in Ukraine, and scientific data reiterating that the world is not doing enough to tackle carbon emissions and protect the future of the planet. We don't need to look far to feel this climate crisis, as the country is still reeling from the devastating impact of Severe Tropical Storm

The importance of COP cannot be stressed further



enough as it is not only the biggest and most important annual climate-related conference, but it brings together presidents, prime ministers, CEOs, climate advocates, scientists, researchers, media, etc. in one forum to do something concrete and immediate to address climate change. In the words of Stiell, plans are already done; it is now time for action.

"The heart of implementation is 'everybody, everywhere in the world, every single day, doing everything they possibly can to address the climate crisis," said Stiell. "There are those that are going forward, further, and faster than everyone else. These are examples to be followed. There are those who just need to be nudged into taking further action, to go beyond business-as-usual. There are others who need support so they're able to do everything they possibly can for their countries and communities. And then there

are those who still refuse to act unless others do. They will not be allowed to slow down our collective response. Let's not let positioning block progress. All of us have to do everything we are capable of doing."

The opening of the COP27 bodes well as a lot of nations have recognized the urgency to address the climate crisis. Our country's representatives will assert the call for bolder climate action and demand the delivery of what is due for developing countries. "(We) hardly produce any greenhouse gas emissions, yet (we) suffer the most and continue to bear the brunt of the adverse impacts of climate change," said Loyzaga.

As the days go by for COP27, we wait in anticipation for the outcome of various high-level meetings and negotiations. Will we be at the losing end? Or are we able to bargain well for the sake of the nation's future? We only have high hopes for COP27.

The Provincial Government of Cavite has received and approved an unsolicited proposal from the Original Proponent for the financing, design, construction, operation and maintenance of a 27.06-Km toll road named the CAVITE-BATANGAS EXPRESSWAY PROJECT (the "Project") traversing through the Municipalities of Silang, Amadeo, Tagaytay, Indang, Mendez, Alfonso in Cavite and Nasugbu, Batangas, with the following description:

- The Toll Road will have four (4) lanes with two (2) 3.5-m lanes per direction. Each direction will have an inner and outer shoulder width of 1.0-m and 2.5m, respectively. The road surface shall be constructed with Asphalt-Concrete Pavement (ACP); and
- There will be three (3) access/interchange points in (1) Silang, Cavite, (2) Tagaytay, (3) Nasugbu/Alfonso.

The Provincial Government of Cavite invites local and international companies to submit comparative proposals under a Competitive Challenge Bidding Process to finance, design, construct, operate and maintain the Project under a 35-year concessional period.

The competitive bidding for the Project will be conducted in accordance with the procurement rules and procedures applicable to unsolicited proposals set out in Provincial Ordinance No. 002-S-2012 otherwise known as "A Code Adopting and Pursuing a Public-Private Partnership (PPP) Approach Towards Development, Creating a PPP Regulatory Authority, and Providing Appropriations and Incentives Therefore and for Other Purposes" ("Cavite PPP Code") and as amended under Provincial Ordinance No.368-2022,

The Three-Stage/ Three-Envelope System for the solicitation of comparative proposals are first prequalified based on minimum legal, technical and financial qualification requirements set by the PGC. In line with the PPP Code, the qualification criteria used in confirming the eligibility of the Original Proponent will

be the same requirements imposed on potential challengers. Only eligible challengers that qualify shall have their Technical Proposals opened for evaluation. If they pass the technical evaluation, their Financial Proposals will be opened for the PGC's consideration. The Original Proponent will have the right to match the Financial Proposal of the highest ranked challenger.

The Request for Comparative Proposals (RFP) consisting of the: (1) Invitation to Pre-qualify and Submit Competitive Proposals; (2) Instructions to Challengers; (3) Draft Joint Venture Development Agreement (JVDA); (4) Draft Tollway Concession Agreement (TCA); and (5) Minimum Performance Standards and Specifications (MPSS) will be available for purchase and distribution at the Office of the Provincial Bids and Awards Committee (BAC), 2/F Cavite Provincial Capitol, Trece Martires City, Cavite Province from 27 October 2022 to 12 December 2022.

To obtain a copy of the RFP and participate in the Competitive Challenge, any interested party must register and submit a written Expression of Intent, sign the prescribed Non-Disclosure Agreement, and pay the non-refundable participation fee of One Million Pesos (PHP 1,000,000.00) on or before the last day of registration and purchase of RFP. The Forms of the Expression of Intent and the Non-Disclosure Agreement may be downloaded from the official PGC website at https://cavite.gov.ph.

Challengers must submit their Qualification Documents, Technical Proposals and Financial Proposals as one bid package not later than 24 January 2023, 2:00 P.M. at the BAC Office, unless otherwise advised.

WHEREAS, Section 468 (a) (1) of the same Act provides in part that the Sangguniang Panlalawigan, as the legislative body of the province, shall approve ordinances and pass resolutions necessary for an efficient and effective provincial government;

WHEREAS, the Sangguniang of Panlalawigan of Cavite passed Resolution No. 82-S-2009 which was intended to implement the Recommended Minimum Professional Fees for Anatomic Pathology Consultation issued by the Philippine Society of Pathologists, Inc. in 2008;

WHEREAS, there is a need to adjust the minimum mandatory fee schedule of professional fees for pathologists as prescribed


