## DOST disaster food passes palate of kids

The Department of Science and Technology's disaster food passed the palate of kids in Quirino.



This was confirmed thru the consumer survey of DOST through the Industrial Technology Development Institute in collaboration with the Provincial Science and Technology Office Quirino and Municipal Social Welfare Development Office of LGU-Diffun on Ready-to-Eat (RTE) foods to 20 senior citizens and 20 elementary school children in the Province of Quirino on December 6, 2023.

This activity aims to evaluate the acceptability of RTE retort foods – Ginisang Monggo and Chicken Corn Soup as an aid for disaster relief

efforts in the country.

During the taste testing, participants tried each pack of RTEs and provided useful feedback to determine the acceptability of the products for all ages. This is to ensure and determine when the preferences of each age group are attained without compromising its nutritional value.

Communication is considered the lifeblood of progress. The press considered as the fourth estate has an immense power to share public opinion, influence policy decisions and foster an information culture, that values and supports scientific development, according to Mabborang.

As communicators, the press can make complex scientific terms more accessible understandable by the general public, the DOST official added.

#### **BIRTHOF PAPI**

PAPI chairman emeritus Johnny Dayang, recalled how the organization was established in 1974 when there was no media organization yet and there were few newspapers. PAPI to this day, after 27 years, continues to struggle to serve the nation "and very active in expanding the frontier of press freedom," Dayang said. He was a former president or official of PAPI, Manila Overseas Press Club (MOPC)), National Press Club (NPC).

Sen. Robinhood C. Padilla, chairman of the Committee on Public Information and Mass Media, whose video message was played to about 150 Congress guests, cited the importance the media plays in information dissemination.

step in empowering families for nationbuilding.

"Housing is a basic need. To enable Filipinos to participate in nationbuilding, we must first support the family unit. Providing safe homes for those affected by calamities or without a home has been our first step to transforming their lives," he said.

SMC has built homes and communities in various areas nationwide, including Iligan City, Cagayan de Oro, Bukidnon, Negros Oriental, Davao, Surigao, and Bohol, among others.

By the time the pandemic happened in 2020, SMC's program had evolved from simply building houses to advancing holistic community development.

Its latest housing community in Sariaya, Quezon serves as a model. It features disaster-resilient and eco-friendly homes and amenities that include a multi-purpose center, covered court, livelihood center, e-library, as well as a fishermen's wharf and a public market ran by the residents themselves.

Training programs on entrepreneurship, personal finance, food processing, farming, and other income-generating activities have also been provided to residents.

In partnership with the Technical Skills

**Development Authority** (TESDA), SMC has extended this skills and livelihood training program nationwide, while assisting informal settlers in various locations secure titled properties and build permanent homes in various locations.

"Wherever San Miguel operates, progress follows. Our aim is to ensure that those we help are equipped for longterm success," Ang said.

"But just as important as housing and jobs is having a sense of community. Being part of a supportive network is essential for their longterm success," Ang said.

This is what brought the company to its current flagship social development program, the World Better SMC

Community Centers.

The project utilizes SMC's unused properties well as other resources, to scale up the capabilities of partner organizations, to address pressing issues at the community level.

SMC currently has four Better World Community Centers: Better World Tondo, a food bank, feeding, learning, and health center; Better World Diliman, a ready market for excess farm produce to support local farmers; Better World Cubao, a center for women's health and issues that also has a clinic and livelihood training facilities, and Better World Smokey Mountain, a learning center for adults and children living in the former Smokey Mountain landfill.

outlined in the DOE Department Circular No. 2017-11-0011, specifically Rule VI Section 23, which mandates the mandatory calibration and sealing of dispensing pumps every 90 days.

According to the circular, dispensing pumps used in retail outlets must undergo proper calibration and subsequent sealing by authorized entities. Under Section 24, these authorized calibrating entities are identified as the City or Municipal Treasurer and the DOST-National Metrology Laboratory (NML).

The training received a touch of distinction with the warm welcome remarks from Atty. Edith C. Napalan, City Treasurer of Bacoor. Leading the charge was Engr. Brigido K. Casanova, Science Research Specialist II and Laboratory Head of DOST Batangas-Regional Volumetric Calibration Laboratory (RVCL) and assisted by Mr. Mark Anthony B. Acidella, PTA VI of DOST- Cavite.

The training, attended by a total of 66 participants, commenced

with an introduction to mandates of DOST in the calibration and verification of measuring instruments used in petroleum products.

The participants delved the history, requirements, and components of fuel dispensers, covering topics such as preparation, preconditioning, regulatory tests such as electronic display, zero setting, price computing, nozzle cut-off, to name a few, and metrological controls during verification. 
