# Senator Bong Go lauds healthcare outreach in Cavite City

Senator Bong Go conveyed his gratitude for the effective healthcare outreach organized by Geraldine Borromeo, the ASIAN School of Advanced Technology Inc.'s class president, at Villa Porta Covered Court, Barangay San Roque in Cavite City on Sunday, 18 February.

The ASIAN School of Advanced Technology Inc., recognized under Technical Education and Skills Development Authority in Region IV-A, offers a program in Caregiving (Elderly) NC II. This program is designed to equip students with the necessary skills and knowledge to provide quality care for the elderly, focusing on their physical and emotional needs.

The event, which catered mostly to senior citizens, aimed to provide essential medical services to those in need, reflecting the school's dedication to nurturing future caregivers equipped with compassion and competence.

Go's Malasakit Team also attended and provided grocery packs, shirts, vitamins, and balls for basketball and volleyball to select medical mission beneficiaries.

As a proponent of improving healthcare access, Go, who chairs the Senate Committee on Health and Demography, highlighted the availability of medical aid programs at the Malasakit Centers in General Emilio Aguinaldo Memorial Hospital in Imus City and Southern Tagalog Regional Hospital in Bacoor City.

The Malasakit Centers program celebrates its 6th year this year. It was institutionalized under Republic Act No. 11463, which Senator Go principally sponsored and authored in 2019. The program has assisted around ten million indigent patients according to DOH with 159 Malasakit Centers operational nationwide.

Senator Go also advocated for 12 Super Health Centers in the province to make certain that primary care is within reach of Filipinos, especially those in far-flung areas. Through the collective efforts of the Department of Health, led by Dr. Teodoro "Ted" Herbosa, local government units, and fellow lawmakers, sufficient funds have been allocated under the DOH for the construction of more than 700 Super Health Centers. Go, the vice chair of the Senate Committee on Finance, has also backed multiple road upgrades in Cavite, Dasmariñas, General Trias, Imus, and Tagaytay. Furthermore, support has been extended for the rehabilitation and enhancement of

the municipal fire station in Noveleta, as well as the refurbishment of covered courts in various barangays in General Trias City. Additionally, there is support for acquiring ambulance units for the local governments of Indang and Trece Martires City, and for enhancing a sports facility at Cavite State University in Indang.





# DOST turns over high-speed sewing machine for IP weavers in Bukidnon

The Department of Science and Technology turns over an industrial highspeed sewing machine to the Damugu Weavers Association, a group of IP women weavers in San Rafael, Talakag, Bukidnon on January 12, 2024 through the Grassroots Innovation for Inclusive Development (GRIND) program.



Aside from the industrial high-speed sewing machine, the 37 IP weavers will also be given skills and product development training and technical assistance on their trademark registration for Intellectual Property protection.

"DOST under the GRIND Program supports the grassroots innovations and aims them to be more competitive and easily noticed in the market and become profitable for the community," said DOST Assistant Regional Director and GRIND Coordinator, Virgilio M. Fuertes.

Irene Mae L. Sinhayan, the President of the Damugu Weavers A s s o c i a t i o n , wholeheartedly commits to actively supporting the realization of projects geared towards fostering positive impacts within the Indigenous Peoples (IP) weavers' community in Brgy. San Rafael, Talakag, Bukidnon.

"We are happy because, for 5 years now, this is the first time our organization receives a grant project from the government," Ms. Sinhayan said.

Damugu Weavers



Association, composed of 37 IP members predominantly Talaandig, ranging from 21 to 77 years old, has been weaving since 2019. They use a grass called sudsud (Cyperus rotundus), which is abundant in their locality.

Their elders have found a way to manually process the grass by drying, flattening, weaving it into mats, and later on turning it into a variety of other products such as bags, laptop cases, and table runners.

Bae Silma Sabinoy, an elder member of Damugu, expressed heartfelt gratitude for DOST's acknowledgment of their needs. She affirmed their ongoing commitment to working collaboratively, striving for a resilient and enduring partnership with DOST.

"Salamat kaayo DOST kay inyo me nga nakita ug inyo me nga natabangan," (Thank you very much DOST for seeing us and for helping us) Bae Silma said.

The collaborative efforts between DOST X and Damugu Weavers Association symbolize a joint dedication to resilience, growth, and positive enduring transformation at the grassroots level. several recommendations to further strengthen its 'institutional capacity' that, he said, would be useful in guiding the agency towards creating a media that is safe and free from fear as envisioned by President Ferdinand Marcos Jr. in partnership with relevant government agencies including the CHR.

Gutierrez also said the CHR's plan to create a separate media alert mechanism to be called. 'Alert system for media human rights violations (ALISTO) as proposed by the National Union of Journalists of the Philippines (NUJP), should align with the current alert mechanisms of AO1 and that of AO35 to ensure its effectiveness in quickly addressing and validating all reported cases of alleged attacks against the members of the press.

"Looking back, we note that the NUJP made a presentation as regards ALISTO last October 27, 2023, where two assistant secretaries from the Presidential Communications Office (PCO) and the AO1 staff were unfortunately not allowed to participate in the discussion despite being invited.

"Had this not been the case, the PCO and AO1 could have provided their inputs leading to a synergy of effort towards our common goal of protecting the members of the press," Gutierrez said.

"There is really no need to 'reinvent the wheel,' so to speak. But there is really a need to strengthen

(PCO), Center for Media Freedom and Responsibility (CMFR) and other agencies. Collaboration is the key here," Santos stressed. "Let's put our acts together." With the above agencies in mind, any potential perpetrator against media people will have a second thought in attacking newspeople, Santos said. Stakeholders in the media industry should likewise join.




