The LTO-LGU Interconnectivity Program or the Single Ticketing System, plays a vital role in enforcing traffic laws, where real-time data from the LTO's database is now accessible through the handheld devices used by Bacoor's traffic enforcers.

Under the agreement, Bacoor's traffic aids can now issue On-the-Spot Traffic Violation Receipts (OVRs) that will be directly linked to the motorist's record with the LTO.



### Gov Roque and DOST sign partnership to mainstream innovations in local plans

Governor Roque of Bukidnon and DOST-10 recently inked a partnership to mainstream science, technology, and innovations in local development plans through the Innovation, Science, and Technology for Accelerating Regional Technology-Based Development (iSTART) program of DOST.

Integrating the STI lens in Bukidnon's local developmental plans will significantly contribute to province's development. With its focus on introducing science, technology, and innovation-based solutions, **iSTART** promises to address LGU challenges while nurturing entrepreneurship, bringing about economic growth and new job opportunities, attracting new investors, ensuring a bright future for the province.

Furthermore, Provincial Planning and Development Officer of Bukidnon, Engr. Jesrel B. Mangubat was at the MOA signing and supported the DOST 10 initiative to capacitate local planners on STIs.

"We thank DOST 10 for helping us. This initiative benefits our office and staff and will help us better serve our people here in Bukidnon," said Engr. Mangubat.

Ladizar C. Guno, PPDO staff of Bukidnon, also recalls how the Training of the Trainers (TOT) conspired with the DOST 10's recent engagement with LGU Kadingilan last December 2023.

"When I attended the Enhanced Local Climate Change Action Plan Workshop

Kadingilan facilitated by DOST 10, there was an opportunity for planners in Kadingilan to learn how to use STI to improve their plans. And I believe it is equally important to relay this opportunity not only in Kadingilan but to the whole province," said Ms Guno.

The Training of the Trainers (TOT) is set to be conducted in May this year with a focus on harnessing STIs for comprehensive development. Specifically, the training will cover topics such as STI Integration into Provincial Development and Physical Framework Plan (PDPFP) and Comprehensive Development Plan (CDP), STI Mainstreaming for Cities and Municipalities through the CDP, Enhancing the LGU's Vision with STI Perspective, and STI Plan Writeshop.

To date, the Provincial Government of Bukidnon

(PGB) has been one of the proactive partners of DOST 10 iSTART. Through the Memorandum of Agreement, the Province of Bukidnon will be the first province in Northern Mindanao to mainstream Science, Technology, and Innovation (STI) to their local development plans and leverage science, technology, and innovation for sustainable regional development.

Innovation, The Science, and Technology for Accelerating Regional Technology-based Development Program, or iSTART, serves as a platform for strategically aligning DOST technology transfer programs and projects, engagements of RSEs, and R&D conduct to bridge gaps and reduce inequalities for regional development. The integration ensures that demerit points are promptly assigned to the driver's license subsequently after committing a traffic violation.

According to LTO guidelines, drivers who have accumulated demerit points or traffic violation records are no longer eligible for the 10-year validity of driver's license and could face suspension or revocation depending on the severity and frequency of violation.

Asec. Mendiza delivered the message on behalf of Transportation Secretary Jaime Bautista, where the secretary noted that the digitization of government processes is in line with the mandate of President Ferdinand R. Marcos Jr., under the Bagong Pilipinas brand of governance.

"The Department of Transportation, through the Land Transportation Office, intends to streamline traffic violations and fines throughout the country by institutionalizing this system. This is also a part of President Ferdinand Marcos Jr.'s program of digitalizing government systems and processes to establish better interconnectivity among agencies," the statement reads.

LTO believes that the single-ticket system will bring convenience and improve compliance for motorists, and will lessen the corrupt practices of some traffic enforcers.

"We can see that the single-ticketing system will bear many benefits, not just for the local governments but for motorists as well. In this way, we can fight corruption and the wrongdoings of motorists

who test our traffic enforcers, and the traffic enforcers who don't have integrity," Mendiza added.

Meanwhile, Revilla said that the program will expedite the process of delivery services to motorists in the city and will establish a more efficient system for paying fines and other traffic-related transactions which promotes transparency and efficiency.

"The LTO-LGU Interconnectivity program not only streamlines the ticketing process but also introduces a more accessible approach for violators to pay fines online, thereby reducing the inconvenience of physical transactions," the local chief executive said.

Once implemented, the DOTr and LTO said that the local single-ticketing system of Bacoor may become the model of observation for the future implementation of the same traffic system to other cities and municipalities nationwide. (RF/PIA-Cavite; with reports from Bacoor City Information Office)

In short, the films that feature in the Fortnight are cinematic statements of art for art's sake. And such are the short films that are being shot in Dapitan, and why they are meant for the Fortnight.

Or so implies French director and film curator Dominique Welinski, the producer of the program called Directors' Factory, which aims to mentor budding filmmakers under the umbrella of the Director's Fortnight.

Since 2013, they have been shooting short films on location in their partner countries all over the world, and now they're back in Asia. It's their first time in the Philippines, and they're filming in the only place where national hero Dr. Jose Rizal was ever exiled.

The four short films are shot under the mentoring of Lav Diaz, 2024 Directors' Factory, and overseen by Welinski, who is staying in Dapitan for the duration of the filming.

The whole program is co-produced by Epic Media Productions, Inc. and Welinski, in partnership with DW (France) and the support of Dakak Resort, City Government of Dapitan, Quezon City Film Commission, Qcinema, Anima Studios of Kroma Entertainment, and CMB Film Services in the Philippines and Cineli

For his part, Dapitan City Major Seth Frederick "Bullet" Jalosjos explains that he has always been supportive of the arts and sports, and that by supporting big events such as this, the city, in fact, gets massive publicity for its tourism campaign. "We do whatever we can to promote Dapitan," ne said.

For now, Dapitan is shooting for Cannes. And it just might be the one shot that will put it front and center on the map.

"The fact of the matter is that as legislators and law enforcers, we have to work hand-in-hand. Whatever instruments we wield, whether it be guns or pens, our goal is the same: to protect and uplift our communities and the whole nation," said Zubiri.

"To this end, the Senate has endeavored to develop legislation in support of the evolving needs of the police force," the Senate chief added.

started Zubiri quantifying this legislative support by mentioning the passage in 2021 of Republic Act No. 11549 or the "Height Equality Act" that reduced the height requirement for not only police recruits but also officers of firefighters and jail and corrections officers.

"We know that a good cop is not defined by their height - what counts is their courage, their commitment, and their integrity. And so this law opened the doors for many more Filipinos to enter the police force and dedicate themselves to the service of our people," the senator from Bukidnon said.

Zubiri added that just last month, the Senate passed on third and final reading

the PNP Organizational Reforms Act that aims to update the old structures of the PNP and strengthen and streamline its leadership, organization and management.

"We will be institutionalizing offices such as the Directorial Staff and the Area Police Command across the country, to fortify their

roles and integrate them better into the police force," Zubiri said.

The Jail Integration Act, which will transfer provincial and subprovincial jails from the supervision of LGUs to the supervision of the BJMP, was also passed on third and final reading last week in the Senate.

"Under the expert management of the BJMP, we hope to create a more efficient and standardized system of management for all Persons Deprived of Liberty, no matter where they are serving their time," Zubiri explained.

The bill, he continued, will also complement the Heinous Crimes Facility Act that was passed in the 18th Congress and has obtained funding this year.

"With that supermax facility in Mindoro, we hope to decongest our jails, and we hope to establish a managed better penitentiary system that will help low-level offenders have a truly rehabilitative time in prison, away from the influence of high-level offenders," Zubiri noted.

He also mentioned that the committee report for the BFP and BJMP Rank Classification Act is out and is ready for plenary debates.

Apart from legislation targeting institutional improvement, Zubiri said the Senate is also working on bills that will help with the arms procurement of the police force, namely the amendments to the **Government Procurement** Reform Act and the Self-Reliant Defense Posture

"The SRDP Act, in particular, is very important to me, because I believe that we should be able to produce our own defense needs, on our own time - instead of relying on our foreign allies for the bulk of our arms procurement," he declared.

The PNP can also look forward to the PNP Forensic DNA Database Act, which Zubiri believes will revolutionize criminal investigation procedures and keep the country at par with global standards in forensic sciences and practices.

"As you can see, the Senate is all in with our support for the PNP and its partner agencies. We value deeply your great selflessness and sacrifice, and we recognize your work to be foundational to our country's growth. We cannot, after all, pursue progress without first securing peace," Zubiri

"And so the Senate is always here to work with you in our shared responsibility engendering genuine and lasting peace in our communities and in the country." (PIA-NCR)

"This Tramo access ramp provides another option for motorists heading to the airport, and other areas in Paranaque City and Cavite province. We believe it can help relieve overall traffic congestion in the area, and improve traffic flow within the vicinity of the airport," Ang said.

Public Works Secretary Manuel Bonoan led the inauguration of the new access ramp and credited company the for supporting the government's efforts to build vital infrastructure to sustain the country's economic growth.

"The Tramo access ramp has been in San Miguel's drawing board for a long, long time because they knew it would enhance the efficiency of

NAIA expressway, and improve the mobility of motorists going to the airport," Bonoan said.

Bonoan said further improvements on NAIAx are being studied by their agency, as grantor of the concession, in partnership with SMC, to improve the flow of traffic to airport terminals, given growing demand.

"The Department of Public Works Highways will always be there to support and implement these projects to improve traffic flow especially here in Metro Manila," he added.

For his part, Ang remained firm in the company's commitment to work closely with the government, as it pursues infrastructure projects that benefit Filipinos.

"San Miguel will continue to pursue these vital infrastructure projects, in close coordination with our government, because of their benefits to our people and economy. Through these projects, we also create jobs, improve the mobility of goods and services, and make our cities and regions more primed for growth. All these serve to support and sustain our growing economy," Ang said.
