Cavite fishermen net a bounty of sardines ROSARIO, Cavite: Residents in this coastal

ROSARIO, Cavite: Residents in this coastal town are celebrating the unusual amount of "tamban" or sardines caught by local fishermen in the past few weeks.

Mike Concha, president of a fisherfolk group in Rosario, said that a fishing boat can bring home an average of 48 buckets of sardines per trip.

"That's equivalent to around 864 kilos of tamban fish caught every day," Concha said. "Before we only catch 5 to 10 buckets per day."

Concha said one bucket of sardines can be sold for P700 at the fish port.

"For almost a month now, our catch has always been like this," he added.

Concha said the artificial coral reefs planted in the waters off Rosario in 2021 may have contributed to the bountiful harvest of the fisherfolk here.

He also said the fishermen here thanked Tata Idrong or San Isidro Labrador, their patron saint.

DOST-CALABARZON teams up with USHER Technologies for USHER Web Portal Orientation

DOST-CALABARZON, in collaboration with USHER Technologies Inc., conducted an orientation on the USHER Web Portal and maintenance of USHER units installed in San Pedro City, New City Hall, and Cabuyao City Hospital last March 11, 2024.



The orientation was led by Mr. Jordan Gabriel and Engr. Michael Baylon of USHER Technologies. The discussion emphasized crucial aspects of disaster management, focusing mainly on earthquake preparedness and the utilization of the USHER Web Portal for data management and reporting.

During the orientation, representatives from the City Disaster Risk Reduction and Management Office (CDRRMO) of each city received comprehensive guidance on appropriate actions to take during and after earthquakes, with an emphasis on safety protocols and response strategies. Additionally, maintenance was conducted on the usher units installed in the cities to ensure their operational readiness and utilization by the beneficiary LGUs.

Moreover, the session covered the utilization and management of data through the USHER Web Portal. Attendees were trained on harnessing the platform's capabilities to generate reports and analyze data, enhancing their decision-making processes during critical situations.

Engr. Baylon highlighted, "Papano ngayon yung data, paano natin kukuhanin? So we have now the portal, and then for accessibility we have the mobile application. Upon this building is performing during the earthquake, the devices will collect data consolidated to this usher controller, papasok sa portal, generate alert data, alerted to SMS at email, and yung critical warning and good alert status."

It's worth noting that DOST-CALABARZON, OCD IV-A, LGU-Cabuyao, and LGU-San Pedro signed a Memorandum of Agreement for a one-year benefaction of the Universal Structural Health Evaluation and Recording System (USHER) which ended on September 22, 2022. However, DOST-CALABARZON avails a three-year maintenance package as part of the premium service option offered by USHER Technologies, which covers until September 2025.

The Universal Structural Health Evaluation and Recording (USHER) is a DOST-funded technology that detects infrastructure damage moments after an earthquake. It is designed to monitor and assess the structural health of buildings. Developed by USHER Technology Inc., this system offers realtime insights into the integrity of structures, enhancing disaster resilience and promoting proactive maintenance.

The orientation session served as a significant step towards enhancing the disaster preparedness and response capabilities of Cabuyao and San Pedro, emphasizing the importance of collaboration and innovation in building resilient communities. With continued efforts and collective engagement, stakeholders remain committed to cultivating a culture of safety and preparedness in the face of evolving challenges. (By Harley G. Margallo)

The Technology Application and Promotion Institute (DOST-TAPI) launched the Call for Abstracts for its Invention and Innovation programs, which offer a range of funding opportunities to propel techdriven ventures to success.

Dubbed as the Further

Forward campaign, DOST-TAPI's Call for Abstracts invites eligible proponents to submit their abstracts in applying for its current program offerings, including the Technology Innovation for Commercialization (TECHNiCOM), Venture Financing Program (VFP), and I-Tech Lending Program.

Submission of abstracts is open until March 31, 2024 at 5 PM. Only proponents with approved abstracts will have the opportunity to develop their submissions into fullblown proposals through the proposal enhancement activities to be held during the face-to-face regional writeshops.

This year's call puts premium on the following priority sectors for TECHNICOM and VFP: Smart Electronics, IoT and Automation in Industrial Settings, Software/ platform-as-a-service, Robotics/Mechatronics,

System Transport Technologies, Machining and Fabrication Innovation, Water Resource Management Technologies, Renewable/ Sustainable Energy Technologies, Nutraceuticals, New Farming Technologies, Farm Mechanization and Digital Integration, and Disaster Risk Reduction Technologies. These sectors were identified based on the DOST-Harmonized National Research and Development Agenda and Sustainable Development Goals. They also contribute to the economic growth of our country, promising readiness for pre-commercialization and commercialization.

Recognized as one of DOST-TAPI's flagship programs, TECHNiCOM provides multimillion grants to precommercialization projects and targets to fast-track the market

readiness of locallydeveloped technologies.

The program is open to tech-based startup companies, state universities and colleges (SUCs), private higher education institutions (HEIs), and research and development institutions (RDIs).

In addition, VFP offers a soft loan of up to P2 million to tech-based MSMEs in the hopes of boosting their commercialization efforts and capaciting them to satisfy growing consumer demands. Eligible applicants for VFP include MSMEs with 60 percent Filipino ownership in operation for at least three years.

Beneficiaries of TECHNiCOM and VFP were recognized in DOST-TAPI's culminating activity, Lunduyan, held last September 2023. More than a celebration of Filipino ingenuity, Lunduyan served as an avenue to connect the beneficiaries with potential investors to further their t e c h n o p r e n e u r i a l endeavors.

Meanwhile, the I-TECH Lending Program, in collaboration with the LANDBANK of the Philippines (LBP), offers a specialized lending window featuring lowinterest financing for the commercialization of patented inventions.

This program is geared towards aiding Filipino

inventors in securing funding, specifically for the acquisition of capital and labor required for expanded production. I-TECH is open to individual inventors and enterprises with a deed of assignment.

This call for proposals represents an opportunity for as piring technopreneurs to access crucial support and resources to advance their projects and contribute to the country's innovation ecosystem.







2 SENATORS PUSH FOR 'MARIJUANA' LEGALIZATION WITH SAFEGUARDS IN PLACE



QUALIFIED patients may soon receive therapeutic and palliative benefits from medical cannabis or marijuana under Senator Robinhood Padilla's proposal while Sen. Ronald 'Bato' Dela Rosa said safeguards are already in place in the measures allowing the use of the plant.

Sen. Padilla sponsored Senate Bill No. 2572 or the proposed Cannabis Medicalization Act of the Philippines.

On the other hand, Sen. Dela Rosa assured that safeguards are in place in the proposed law allowing the use of cannabis for medical purposes. As a co-sponsor of Senate Bill No. 2573, he said the measure, among others, contains comprehensive standards for the medicalization of cannabis, from cultivation to distribution, as well as stringent licensing requirements for physicians, pharmacies, and industry players and establishment of a monitoring system. "Moreover, this act includes provisions against misuse and abuse, such as the prohibition of recreational use," the former police chief added.


DOST-1, partner agencies, ink MOU for 2024 HANDA Pilipinas Luzon Leg
