Khervy Reyes, Provincial Administrator for Community Affairs Mr. Alvin Mojica, DTI-Cavite Business Development Division Chief Revelyn Cortez and PCLEDO Entrep Division Head Ms. Liza Gabatan.

Entrepreneurs in Cavite who gathered for one of the

biggest affairs to capacitate them under the banner "Future-Proof MSMEs: Converging Stakeholder for Inclusive Growth" were welcomed by Provincial Administrator for Community Affairs Mr. Alvin Mojica who also delivered an inspiring message on behalf of Governor Boying Remulla.





DOH PROVIDES BASIC TRAINING ON ACUPUNCTURE, VENTOSA AND MOXIBUSTION TO HEALTH WORKERS OF CALABARZON

THE Department of Health (DOH) - CALABARZON (Cavite, Laguna, Batangas, Rizal, Quezon) concluded the first two batches of "Basic Training on Acupuncture, Ventosa And Moxibustion For Selected Medical Doctors and Public Health Nurses of Calabarzon to promote the rational and safe use of traditional medicine held at St. Giles Hotel, Makati City from July 17-21, 2019.

"We have seen the increase of traditional medicine in recent years and today people are going back to basics - using herbal supplements to stay fit and healthy. The demand continues to rise and it is important to be selective of what traditional method or approach to use - safety must be the primary consideration," Regional Director Eduardo C. Janairo stated.

"Traditional and alternative healthcare have been gaining popularity for the treatment of various ailments such as acupuncture, ventosa and moxibustion which are the commonly known methods. Although they are getting popular in the medical and wellness sector, we still have to make sure that these procedures are properly applied and practiced by health professionals with the utmost safety to avoid any incident," he emphasized.

In 1997, the DOH headed the passage of Republic Act 8423, known as the Traditional and Alternative Medicine Act (TAMA) which laid the way for the manufacture of

alternative medicines from certain herbs that are proven, safe, effective for utilization.

Janairo recounted that the TAMA Law of 1997 led the way for the establishment of the Philippine Institute of Traditional and Alternative Health Care (PITAHC) which incorporates traditional and alternative medicine in the national health care system.

"In CALABARZON, we have created the Traditional, Complementary and Alternative Medicine (TCAM) program with the objective of providing and incorporating the benefits of traditional medicine and the advances in alternative technology."

"Sa complementary at alternative medicine anyone can benefit, me sakit man o wala. Each person will respond differently to each practice gaya ng acupuncture na nakakatulong hindi lang sa may mga chronic pain, effective din ito sa mga mayroong arthritis at sakit ng ulo," he emphasized.

Janairo added that the TCAM

program in the region will be the gateway to strengthen primary health care from the households, community and within each service delivery network in the municipalities and provinces.

"We will also introduce other complementary and alternative system of medicine such as the Ayurveda, Naturopathy and Homeopathy."


The five-day training will focus on acupuncture (a form of treatment that involves inserting very thin needles through a person's skin at specific points on the body), ventosa (placing special cups on the skin for a few minutes to create suction) and moxibustion (a form of heat therapy where "moxa", a substance obtained from dried leaves, are burned on or very near the surface of the skin).

"This training will be the first step towards achieving our goal of integrating traditional and complementary health care into the primary health care delivery system at the same time upholding our country's traditional medicine heritage," he concluded.

We condemn the article's insinuation of negligence the part of PhilHealth's officers past and present as malicious. In a meeting last Sunday, June 24, 2019, between the PDI and Senior Vice Pres. Dennis and Acting Senior Manager Atty. Ernie B. we provided all the necessary proof that the actions of the Corporation including its office staff from the Regions to act on the uncorroborated reports of fake receipts given by liaison office based recruitment agencies to our members. Because of complaints brought to attention of POEA on fake receipts between 2017, this agency called for 'hearings' by recruitment agencies concerned and PhilHealth which was attended by the head of PhilHealth POEA field office, Mr. Ken Sarmiento and Prosecution Department lawyers. Like complaints and evidences were submitted NBI for investigation since 2015. A meeting also conducted sometime between late 2017, early 2018 with the Department of Labor, Employment including POEA officials to discuss receipts and reintegration of PhilHealth in POEA- IT collection system. Reintegration have allowed PhilHealth to collect direct recruitment agencies or OFWs themselves an lessened avenues for fraud. Mr. Sarmiento assigned to submit updated reports so POEA take further action against the subject erring officers of recruitment agencies. We take the report's callous magnification of figures we believe renders the report inaccurate and malicious. Fake receipts issued to OFWs amount only to P1.2 million and not P17 million as peddled by the reporters as truth. To conclude the premiums of all 7,257 OFWs were far grossly baseless. Lastly, we condemn as well allusions that the alleged inaction on the senior officers was because of "promotion jockeying for positions to benefit themselves, challenge the authors of these reports and called "Eli" to show proof of their allegations, the good persons of all officers and past PhilHealth Presidents mentioned. We strongly believe, subjecting government institutions and officials unfounded accusations in the arena of public are works of cowards. We challenge instead whether from our stakeholders or from officers and staff with sufficient proof of corruption and negligence within PhilHealth's ranks to file complaints and enable the Corporation to cleanse its ranks.

SSS President and CEO Aurora C. Ignacio said the pension fund deployed P1 billion each for three Balanced Fund Mandates, three Pure Equity Fund Mandates, and one Pure Fixed Income Fund Mandate. An investment mandate is an instruction to manage the pool of capital or funds, using a specific strategy and within certain risk parameters.


Earlier, SSS opened the bidding to hire nine local fund managers to manage the P9 billion investible funds which are divided

equally to three mandate namely: Ceded Fund Mandate, Equity Fund Mandate, Pure Fixed Income Fund Mandate.

Ignacio said the fund managers underwent an open and competitive bidding and transparent evaluation process. The bidding process for P7 billion was deployed to qualified fund managers. Under the Balanced Fund Mandate, SSS selected Rizal Commercial Banking Corporation, BPI Asset Management, and SSS

We need to strengthen primary health care and we need to work together to ensure the success of the Universal Health Program. *Ang primary health care ay pakaimportante ng health system kung wala kayo!*" Secretary of Health Francisco T. Duque III stated and addressed the 1,993 newly hired health professionals after they took their oath in Laguna on June 14,

They will enjoy full benefits similar what a permanent employee receives."

Corporation and ATRAM Trust Corporation who will each manage P1 billion investible fund. For Pure Equity Fund Mandate, BPI Asset Management and Trust Corporation, Metropolitan Bank and Trust Company, and Philequity Management, Inc. will each handle P1 billion investible fund. Meanwhile, BPI Asset Management and Trust Corporation was entrusted to oversee P1 billion investible fund for the Pure Fixed Income Fund Mandate.

"The SSS management believes that it will benefit from the investment value-added services of the fund managers such as training, access to proprietary

investment analysis and information and acco business analytics," Ignacio said.

Under the old charter of the SSS, the pension fund allowed to appoint local or foreign fund manager to manage the IRF.

SSS' investment reserve fund as of the end of the period stood at P495.6 billion wherein bulk of it, 41 percent is invested in government securities, 19 percent in equities, another 19 percent in loans to member and bonds, 7 percent in real estate and 1 percent mutual fund.

"The remaining P2 billion allotted for two local fund managers will be open for rebidding this year," Ignacio said.



DEPARTMENT OF HEALTH - CALABARZON (Cavite, Laguna, Batangas, Rizal, Quezon) successfully concluded the 3rd Municipal Leadership and Governance Program (MLGP) Colloquium for Mayors and Municipal Health Officers of eight municipalities of the region who completed the 18-months partnership program with the United Nations of the Philippines on June 20, 2019.

"The best way to address health inequity in the rural areas is to capacitate local executives and health officers to enable them to establish their own community health system that will be responsive and suitable to the health needs of their people," Regional Director Eduardo C. Janairo stated in his message during the 3rd MLGP Colloquium

"Now that these local officials who have undergone the training program knows the importance of health, and learned what they need and what they lack in their areas, through their scorecards, the next thing to do to identify and pool resources and establish a plan for the continuity of the instituted health programs for the benefit of the people in these communities," he emphasized.

As part of their course output, municipal health leaders together with their health officers will work to improve their health performance indicators which is color-coded to show how their performance is compared to the external and internal benchmarks set by the 2010 national target and to the 2008 national average - green means excellent performance which merits sustenance

and incentive; implies comparative good performance must be maintained and optimized to the target goals red means fair and is lower than the baseline.

According to Janairo, the willingness to complete the course and get into the leadership program are the factors that are considered in selecting the participants. "We announce the opening of the course and then they apply two's - the mayors and the municipal health officers. They must form a team in order to develop their local health system."

Their journey begins by presenting to them their current health status of the municipality as shown by indicators and how they will improve and accomplish it by a period of 18-months. "Usually those that have passed and initiative to develop
