**PLDT users in Bacoor: add “8” to make a call**

STARTING October patrons of Philippine Long Distance Telephone customers in Metro Manila and some areas will have 8-digit landline numbers in order to make a call.

The National Telecommunications Commission (NTC) had instructed carriers to shift to 8 from 7 numbers "to address the insufficient number of assignable exchange codes," PLDT said in a comment. Competitor Globe Telecom declared a similar effort.





"xxx he called me to ask for some advice. I told him, I would accompany him," sabi sa FB page ni Belmonte.

Wala nang narinig na balita tungkol sa imbestigasyon dito, mula nang maupo ang alkalde, kaya ang mga tanong – ano na ang nangyari, may inimbestigahan ba, may kinasuhan ba, may sinibak pa sa trabaho?

Naayos ba ang permit ng di-pinangalanang negosyante, at sa imbestigasyon ba, may mga negosyante bang lumutang upang magsabi rin ng

Bacoor, Cavite.

## CALABARZON REGIONAL DIRECTOR JANAIRO HEADS NATIONAL DENGVAXIA TASK FORCE

**TO properly address and manage concerns surrounding the effects on the use of the Dengvaxia vaccine including its apparent harmful results to children who received the vaccination, Department of Health (DOH) Secretary Francisco T. Duque appointed DOH-CALABARZON (Cavite, Laguna, Batangas, Rizal, Quezon) Regional Director Eduardo C. Janairo as Chair of the National Dengvaxia Task Force for CALABARZON, Central Luzon and Metro Manila as part of health care provider network under the Universal Health Care Framework.**

"We need to harmonize efforts and provide similar services and activities, support and assistance for the three regions. Basically, Kung ano ang ginawa namin sa CALABARZON ito ang susundin namin for the two regions. Kailangang hanapin natin lahat ng nabakunahan. Bigyan ng physical examination, bantayan at palakasin ang kanilang mga resistensya dahil ito lamang ang makapagbibigay ng proteksyon sa anumang sakit na pwedeng dumapop sa kanila," Regional Director Eduardo C. Janairo stated.

"Kailangan nating mag-karoon ng vaccine and patient tracking kasama na dito ang referral system dahil kailangan natin silang i-profile at bantayan

upang malaman kung anuman ang mangyari sa kanila sa loob ng limang taon mula ng sila ay makabukunahan. Lahat ay hahanapin natin at walang dapat maiwan," he added.

Under the Department Personnel Order No. 2019-2458 dated June 10, 2019, DOH established the Task Force for Regions CALABARZON, Central

Luzon and Metro Manila to address the Tetravalent Dengue vaccination concerns.

Janairo explained that the objective of the National Task Force is to establish a whole of government and whole of society management team to oversee the implementation of activities for more equitable provision of

services for all the regions concern.

In 2016, the DOH launched the Dengvaxia immunization and was implemented in the three regions including region 7 as requested by its congressional representative. In 2017, it created panic and concern among the parents of children who received the vaccine because of the analysis and announcement made by its manufacturer.

A total of about 833,000 Filipino children were given the controversial Dengvaxia vaccine.

"It is equally important to recommend funding for the purpose of establishing a research agenda for this purpose to find out if there really is a correlation between the Dengvaxia vaccine and the reported deaths allegedly caused by the vaccine because as of now wala pa rin talagang makaka-pagsabi kung mayroon nga itong kinalaman," Janairo disclosed.

# Biotech success story continues to captivate kids in Davao City

THE animated version of the only children's book in the country which attempts to explain agricultural biotechnology to young kids continues to captivate public elementary school children from Magallanes Elementary School and Bolton Elementary School in Davao City.



More than fifty students recently trooped to the Department of Education (DepEd) Library Hub in Davao City to watch the said animation which talks about a town in Mindanao that was totally devastated by a typhoon but recovered and prospered when the town folks started planting biotech corn.

The story which was authored by Legacy Monsanto Philippines Corporate Affairs Lead, Chat Garrido-Ocampo, was inspired by the true story of Aling Conching Reyes from Lambayong, Sultan Kudarat. Aling Conching lost everything to Typhoon Frank in 2008 but still stuck to farming and was able to recover and succeed in life.

When Ocampo met Aling Conching, she was moved to write about the latter. "I really felt Aling Conching's inspiring story had to be told because not only did she get herself out of the claws of poverty through farming but she was also able to help an entire town transform from a life of poverty to that of prosperity," Ocampo said.

Meantime, DepEd Library Hub Librarian

Rosalie Antipuesto said that the animation is a creative way of helping children have a basic understanding of agricultural biotechnology while stirring them to look at agriculture as an interesting and promising field.

"By listening to the story, the kids were able to appreciate better the work of our farmers." Said Antipuesto. "The kids were also inspired by how Aling Conching became successful through hard work and because her unfailing faith in God. The story effectively shared a lot of important lessons to guide these kids."

It has been eight years since Legacy Monsanto Philippines first conducted story-telling sessions based on Aling Conching's story. "When the book came out in 2011, we started our story-telling activities and we have already reached more than 10,000 kids since then," said Ocampo. "Hopefully, Aling Conching's story will find its way in classroom discussions as an excellent example of how people and communities can prosper through modern agriculture."

In addition, non-severe dengue could be treated in primary care facilities with a package of P7,000."
