
### DOST-FPRDI botanists discover new Hoya subspecies

# President Duterte appeals to Filipinos to vote wisely for the country's progress

TAGAYTAY CITY, CAVITE — Former political adviser Francis N. Tolentino's 49<sup>th</sup> birthday celebration last January 3 was made extra special with the presence of the country's chief executive, President Rodrigo Roa Duterte.


The event held yesterday at Signtua Hall, Tagaytay International Convention Center, was attended by special guests accompanying the president namely Silvestre Bello, Ronald "Bato" dela Rosa, Bong Go and several LGU officials from Southern Tagalog led by former governor Jönvic Remulla.

In his speech, President Duterte mentioned his ardent hope for the positive result of the plebiscite for the passing of the Bangsamoro Organic Law (BOL) to effectively pursue the progress

and development of Mindanao. "I hope and I pray that something good will come out of the BOL. Though the plebiscite is forthcoming, we have every reason to believe that it would pass the people's will at sana magkaroon tayo ng kapayapaan because if not mahirapan tayo," Duterte said.

According to Pres. Duterte, the presidency was a gift from God and in return he will do

## CALAX operations to start a year-early with funding secured

PROVINCE OF CAVITE, — The Cavite-Laguna Expressway (CALAX) project is seen to start commercial operations of some segments in the Laguna side as early as July next year with the funding for the construction and concession secured by a loan.

Metro Pacific Tollways Corp. (MPTC) Chief Financial Officer Christopher Daniel C. Lizo disclosed that the company had closed the P24.2-billion loan with six banks namely BDO Unibank, Inc.; UnionBank of the Philippines, Inc.; Rizal Commercial Banking Corp. (RCBC); Bank of the Philippine Islands (BPI); Security Bank Corp., and Land Bank of the Philippines.

The loan is intended to finish the P35.43-billion (45.29-kilometer) CALAX project, funding the Laguna and Cavite segments.

The first 10 kilometers of CALAX on the Laguna side is scheduled to open in July, a year earlier from schedule while the entrance from the Cavite side might be delayed since substantial right of way from the Department of Public Works and Highways (DPWH) is not yet given.

"Some sections ahead, some sections delayed. We're opening Sections 6 to 8, which is from Mampasalan to Sta. Rosa, July. So that's ahead of schedule... Cavite, admittedly delayed. Kulang pa yung right of way (Right of way is still lacking)," explained Mr. Lizo.

Meanwhile, MPCALA Holdings President and General Manager Roberto V. Bontia revealed that the Cavite side is targeted to start construction by first quarter next year.

"They will start hopefully first quarter of next year," he said.

CALAX is targeted to open by July 2020 which will connect the Manila-Cavite Expressway (CAVITEx) to the South Luzon Expressway (SLEX) giving much convenience to commuters with reduced travel time from the two points by half from one hour and 30 minutes to forty five minutes.





International Plant Names Index (IPNI) in 2016. It was discovered by DOST-FPRDI's For. Jennifer M. Conda, Mr. Fernando C. Pitargue Jr., and Dr. Ramiro S. Escobin.

Conda explained the process of discovery: "Our team collected cuttings of the plant from the Quezon Protected Landscape in 2012. Immediately after the first flowers bloomed, we sent samples for examination to Dr. Dale Kloppenborg, a renowned Hoya expert from the United States. He then confirmed that it was a new subspecies, which showed several similarities with *Hoya meliflua Blanco ex Merr.* but with some notable differences. Results were published in *Hoya News*, a publication devoted to studies about Hoya, and listed in the IPNI."

According to her, the calyx lobes (sepals) of the new subspecies are tongue-like and long, as compared to the broadly oval to oblong of the *Hoya meliflua Blanco ex Merr.* Its corolla lobes (petals), meanwhile, are elongated and have serrated edge, in contrast to the latter's broadly triangular lobes.
