

isang krimen ay mapatunayang walang criminal liability o pananagutan sa batas, hindi sila dapat kasuhan, ayon sa panukala, at isasailalim sila sa isang

programa para magbago at maturuan ng tamang asal. Tulong, hindi kulong ang dapat sa mga batang biktima ng mga nakatatandang utak-kriminal.



De La Peña led the turnover of the Hybrid Electric Road Train to the Local Government of Cauayan City relative with the opening of Smarter City Readiness Workshop on January 25-26, 2019 here. DOST Secretary Fortunato T. de la Peña said, "With the development in Science and Technology, it is our task to bring this innovations to the people."This Hybrid Electric Road Train is designed and fabricated by Filipino engineers from the DOST's Metals Industry Research and Development Center will help address the mass transportation in the city and other urban areas, Secretary dela Pena stressed.

Meanwhile Cauayan City Bernard Faustino M. Dy in his acceptance speech said, this turn-over is a confirmation of a wonderful consequence of partnership of the LGU, Academe and line-agencies. It has a maximum speed of 50kph and is powered by a hybrid engine that runs on either diesel fuel or electric batteries. The rear coach generates the power for the entire transport.
