

# DOH CALABARZON RECORDS 1645 MEASLES CASES AND 40 DEATHS IN 45 DAYS



DOH-CALABARZON (Cavite, Laguna, Batangas, Rizal, Quezon) yesterday February 14 conducted another emergency response meeting to address the rapidly increasing measles cases with Provincial Health Officers (PHOs), City Health Officers (CHOs), Municipal Health Officers (MHOs), National Immunization Program (NIP) Coordinators and Provincial Health Team Officers (PHTOs) and Development Management Officers (DMOs) of the region.

Regional Director Eduardo C. Janairo outlined the latest directives and key strategies in the on-going mass immunization against measles. "We will be implementing key strategies on measles outbreak response including surveillance, public awareness and education, vaccination and taking care of measles patients in health care facilities," he stated during his presentation of plans and objectives at the New World Manila Bay Hotel on February 14, 2019.

"Because of the severity and the comprehensive coverage of the measles outbreak DOH will be collaborating with the

## MARCOS BATS FOR VAT EXEMPTION FO ALL MEDICINES

### Calls for review of Cheaper Medicine Act

GOVERNOR Imee Marcos today called for a review of the Cheaper Medicines Act as she pushed for the exemption from the value added tax (VAT) of all medical drugs to make health services more affordable to the Filipino people.

Marcos has been proposing the removal of the VAT imposed on medical drugs to bring down the prices of medicines and make them more accessible to the poor.

"Para sa durating na taon, nais kong tuluyan ng mawalan ng VAT ang mga gamot sa 2019. Kung matatanggal ang VAT sa gamot, bababa ang presyo ng mga ito at higit na maraming mga kababayan nating mahihirap ang makakabili nito," Marcos said.

She lamented the Cheaper Medicines Act, or the Universally Accessible Cheaper and Quality

# Editorial

## UMPISA NA NG SIRKUS

**M**AITUTURING na isang malaking palabas o sirkus ang halalang ginaganap sa ating bansa, at nito ngang nakaraang linggo, nag-uunahan na parang karera ng sasakyan ang mga kandidato upang makabingwit ng boto sa taumbayan. Sa loob ng 90-araw na campaign pe-riod ng mga kandidato sa Senado at kongresista ng partylist group, tulad ng dati, matutulig tayo sa mga kamangha-mangha, nakagugulat at makatindig-bala-hibong talumpati ng mga partido politikal; mabibingi tayo sa mala-imposibleng pangako na mga proyektong iaalay sa atin upang hanguin tayo sa kahirapan, bigyang lunas ang mga problema natin sa kalusugan, trabaho, edukasyon, at iba pang mga pangako upang mapaniwala na sila nga ay dapat nating iboto. Daig pa ang mga tunay na artista at mang-aawit at mananayaw, kakanta kahit boses-ipis, kahit

parehong kaliwa ang mga paa at mistulang sirkero sa entablado ang mga kandidato; at kahit hindi opisyal ang kampanyahan sa mga lokal na puwesto sa mga pamahalaang lokal, noon pang nakaraang taon ay nagsimula na sila na tayo ay sinusuyo. inaarteahan at binobola; may kasamang payakap-yakap, pahalik-halik at patapik-tapik sa balikat ng mga botante.

Mistulang maamong tupa ang mga kandidato na pati ang langit at ang buwan ay ipangangako upang iparamdam na tayo ay kanilang mahal na mahal.

Nagbababad sila sa lamayan, nagboboluntaryong ninong at ninang; kayluwag magbukas ng palad sa mga nanghihingi ng tulong; laging nasa kapilya o simbahan at nagpapakabanal mapaniwala na sila nga ay mga totoong lingkod-bayan.

Sa mga tiwali at garapal, lantaran na sila sa vote buying na isang mabisang "pampatalino" at sa mga ayaw pabola, kasama naman ang pananakot at panggigipit sa mga botanteng hindi kapanalig.

Hindi na bago ang hinalang may mga opisyal ng Commission on Elections (Comelec) na nagpapasuhul sa mga kandidato at gagawin ang lahat ng milagro at hokus-pokus upang maipanalalo at madeklara ang panalo ng mandarayang kandidato.

Isa nga sirkus politikal ang eleksiyong Pilipino. Kaya maging matalino at iboto lamang ang tunay na magseserbisyo, at hindi ang may bisyong magnakaw sa kaban ng bayan.

Government to request for the extension of immunization schedules beyond regular hours and implement be able to provide supplemental immunization activity (SIA) from February to March; Department of Transportation to provide transport in times of emergency; the World Health Organization who will be assisting in the development of checklist for LGUs; the Armed Forces of the Philippines for the deployment of medical personnel in GIDA and conflict areas and ensure the safety of personnel; the Philippine National Police and Bureau of Fire Prevention to provide for additional personnel and logistical support; the Philippine Information Agency for the continues advocacy and awareness promotion; and the private partners and societies who will be assisting in the awareness campaign and also to augment vaccination teams," Janairo enumerated.

"Everyone's cooperation and support are essential to be able to successfully prevent the spread and lessen the cases of measles in the country. Even incumbent

local officials can help in the dissemination of information by including measles information in their tarpaulins and campaign materials provided it will be properly placed in designated poster areas." "We will be targeting to vaccinate a total of 430,292 children in CALABARZON from a projected population of 15,936,725. In Cavite, we will be aiming to immunize 113,064 eligible children; in Laguna - 90,160; Batangas - 79,839; Rizal - 87,019; and Quezon - 60,210," he disclosed. According to the Regional Epidemiology and Surveillance Unit (RESU), Antipolo City in Rizal still holds the highest cases of measles in the region with 441 followed by the City of Binan in Laguna with 126 cases; Municipalities of Rodriguez and Taytay in Rizal with 105 and 95, respectively; and 91 cases in Lipa City, Batangas. A total of 1,645 measles was recorded with 40 deaths from January 1, 2019 to February 14, 2019 compared to 66 cases and 2 deaths with the same period in 2018. "With everything in place, we are expecting cases to decrease next month," Janairo assured.

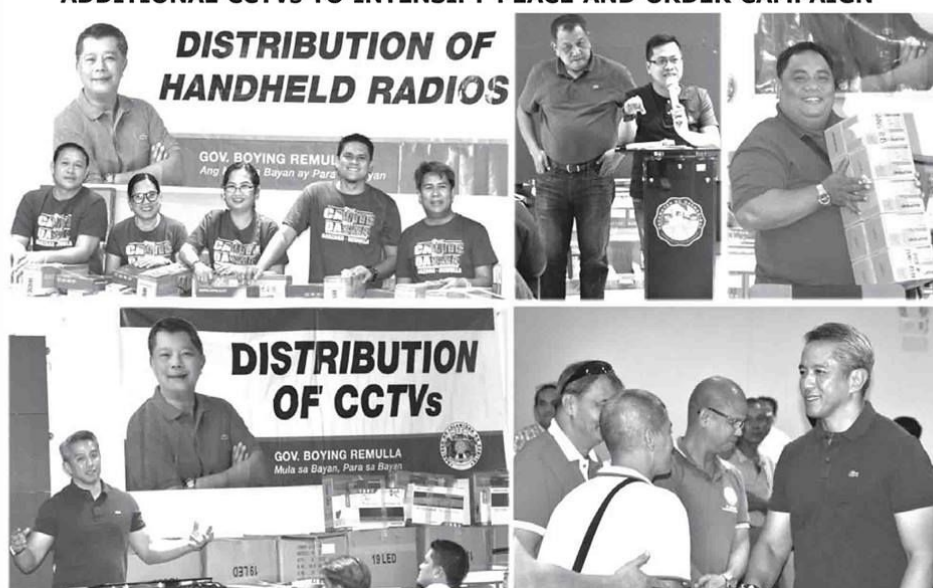

### ADDITIONAL CCTVs TO INTENSIFY PEACE AND ORDER CAMPAIGN

Medicines Act of 2008, failed to make medicines more affordable to the people because of provisions included in the law that favor the interests of big pharmaceutical companies in the country.

"We need to revise the Cheaper Medicines Act and make it more people-friendly. Ang daming nag-lobby na iba't-ibang sectors nung ginagawa ang batas kaya hindi nito nakamit ang tunay niyang vision - ang ibaba ang presyo ng mga gamot para mas maraming Pilipino ang makabili nito," Marcos said.

The Cheaper Medicines Act was enacted into law with the end goal of making medicines more affordable and accessible to the people, especially the poor who cannot afford to buy expensive prescription drugs for their illnesses.

But 10 years after the law was passed, prices of medical drugs, especially for critical diseases and illnesses, remain exorbitant.

Marcos said one way to bring down the prices of medicines is by removing the VAT imposed on all medical drugs.

She said the VAT exemption on the sale of vital medicines for diabetes, cholesterol and hypertension will not be enough.

"Hindi sapat ang VAT exemption sa mga gamot para sa diabetes, cholesterol at hypertension. Kailangan lahat ng gamot ay maging VAT exempt na para bumaba ang presyo nila," she stressed.

The Tax Reform for Acceleration and Inclusion Act, or TRAIN law, mandates the removal of the 12 percent VAT on medicines for diabetes, high cholesterol and hypertension. The exemption takes effect on January 1, 2019.

The VAT exemption will apply to the "sale by manufacturers, distributors, wholesalers and retailers" of the medicines, which will be identified by the Food and Drug Authority.

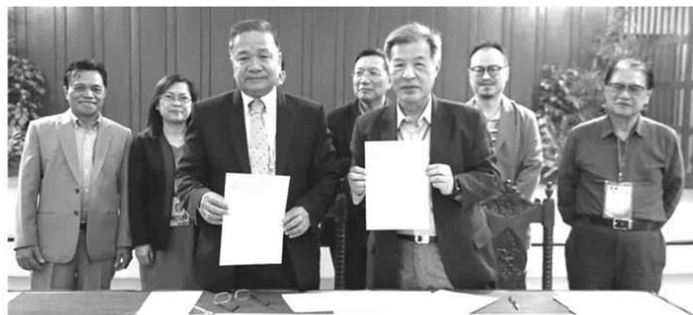

The MOU signing, held Jan 25 at the university's SM Rolle Hall, is a side activity of the Networking/Matching and Welcome Dinner hosted by International and Local Collaboration and Linkages Office (ILCLO), headed by its director, Prof. Ma. Soledad M. Lising.

The event was part of the Delegation's mission to explore not only Metropolitan Manila, but also the CALABARZON Region, comprised of the provinces of Cavite, Laguna, Batangas, Rizal and Quezon, for matching the interests of International Industry-University Collaborations, Student Recruitments, Research Collaborations, English/Chinese Learning Industry and University Social Responsibility Projects with Taiwanese Business Association in the Philippines and its partners like CvSU.

## Go, Roxas in; Osmeña, Dela Rosa out in Pulse Asia 'Magic 12'

**FORMER** Special Assistant to the President Bong Go and former Interior Secretary Mar Roxas entered the "Magic 12" in the latest Pulse Asia senatorial survey released Friday.

Although Roxas ranked 8th to 15th in the December survey, which the poll firm also considered a possible win the upcoming elections, the opposition bet ranked 7th to 14th in the January survey. Around 41.8 percent of the respondents said they would vote for him.

Former Sen. Serge Osmeña suffered the biggest

drop from 38.8 percent (8th to 13th) in December to 37.7 percent (10th to 15th).

Former PNP chief Ronald "Bato" dela Rosa's ranking also dropped from 8th to 15th in December to 11th to 16th in January.

Despite not entering the "Magic 12" this time, Osmeña and Dela Rosa are still considered as probable winners

in the senatorial elections as Pulse Asia considers the top 15 names.

Sen. Grace Poe maintained her lead with an overall voter preference of 74.9 percent, followed by Sen. Cynthia Villar with 60.5 percent, Taguig Rep. Pia Cayetano with 53.3 percent and former Sen. Lito Lapid with 53.0 percent.

Reelectionist Sens. Nancy Binay and Sonny Angara ranked 3rd to 7th and 3rd to 9th, respectively.

## ANGONO PETROGLYPHS



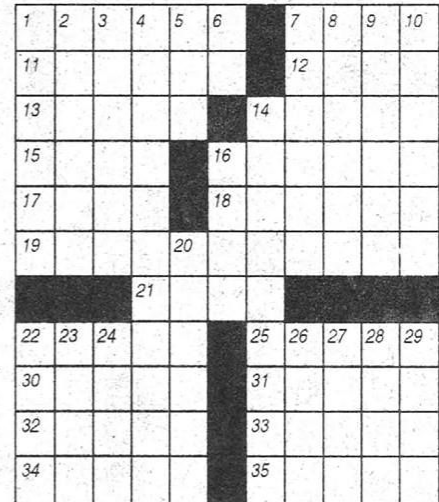
