Cavite terminal seen enhancing trade, supply chain innovation

THE newly inaugurated container terminal at the MetroCas Industrial Estates-Special Economic Zone (MIE-SEZ) is being counted on to enhance trade in the province and supply chain innovation in the Philippines overall.

In a statement, the Philippine Economic Zone Authority (PEZA) said Asian Terminals, Inc. (ATI) inaugurated the Tanza Container Terminal, Inc. Thursday.

The partnership calls for ATI and DP World to serve as the barge terminal operator. They will explore collaboration with MetroCas Properties, Inc. to transform MIE-SEZ "into a smart and world-class mixed-use economic zone."

MIE-SEZ was proclaimed by President Ferdinand R. Marcos Jr. through Proclamation No. 513 on April 1. The proclamation identified six parcels of land

(401,141 square meters) in Tanza, Cavite, as the site of MIE-SEZ. MIE-SEZ is expected to bring in P500 million in investments and the employment

of 200 skilled workers. The terminal has a 100,000 twenty-foot equivalent unit (TEU) annual capacity, and a 2,500 TEU static capacity.

Record-Breaking Performance

During the Annual Stockholders' Meeting held on April 23, 2024, SM Prime announced its highest-ever recorded income, reaching PHP40 billion in consolidated net income, marking a 33% increase from 2022. Additionally, the company's revenues surged by 21%, soaring to PHP128.1 billion, a notable growth from the previous year. DOST, LGU Valencia grant tech upgrading support to IP coffee producers

The Department of Science and Technology and the Local Government Unit of Valencia City in Bukidnon granted technology upgrading support for the Arabica coffee production of MANTALA, Inc., a group of 147 IP farmers in Sitio Migtulod, Mt. Nebo. The project was approved with the signing of a Memorandum of Agreement recently.

The technology upgrading covers various coffee processing equipment such as coffee roasting machine, coffee dehuller, etc. that aims to improve the quality and overall processing time of the coffee.

DOST region X will also provide training on Food Safety and Good Manufacturing Practices (GMP) to the coffee farmers, which have pivotal roles in the acquisition of the License to Operate issued by the Food and Drug Administration.

LGU Valencia has also committed to assist the association in building their coffee processing facility worth 2 million pesos. Moreover, the said LGU requested the inclusion of proposed construction of a warehouse with multipurpose drying pavement at Šitio Migtulod, in the Provincial Commodity Investment Plan (PPCIP) of Bukidnon, with a project cost of 15 million pesos.

With these packages of interventions, the firm is expected to acquire a sustainable source of n of Agreement recently. income and provide quality job opportunities in the locality, boosting the local economy.

At the opening ceremony, Valencia City Mayor Azucena Huervas underscored the significance of this project in fostering economic empowerment within the local community of Valencia City.
