

personal mobility. It must be safe and properly fitted because it becomes an extension of their body," he emphasized.

A wheelchair is the most commonly used assistive device to enable mobility for persons who have difficulty in walking. The device is an essential tool which allows them to go from one place to another. provide opportunities like work, study and enjoy cultural activities and access services like health care. Acquiring wheelchair skills increase the autonomy and self-esteem of disabled persons who learn how to use them properly.

According to Ms. Paulina A. Calo, Nurse V and PWD Regional Coordinator, the training package will help to increase the knowledge and skills of wheelchair and service users providers on the proper use and maintenance including how to stay fit and healthy in wheelchair; increase the of service number personnel trained in basic level wheelchair service delivery; improve the competencies of service wheelchair

delivery; and achieve greater integration of wheelchair service delivery rehabilitation within services.

The World Health Organization developed the Wheelchair Training Service Package: Basic Level following the release of the 2008 Guidelines on the Provision of Manual Wheelchairs in less resource settings. It is estimated that about 70 million people worldwide requires wheelchairs but only 5-15% have access. Most of these have acquired them through donations which are frequently of poor quality and not suitable either for the users or their environment.

The first batch of trainees was attended by 23 personnel from the province of Laguna including 17 PWDs and federation officers from various societies.

CARD MRI The peak of success

TO start a small source of living was Leah Ebrado's plan for her husband's first salary. She knew construction work is heavy work for him that's why she planned to venture into making folding bed out of rattan plastic. Leah learned from her neighbors that the raw materials needed to create such craft are not expensive.

Leah recalled that in 2004, the plastic rattan used for weaving costs P38 per yard while a recycled folding bed frame is only P30 per piece. "We just need to buy a paint to enhance the color of the folding beds," said Leah adding that the paint before is just around P50 per 250 milliliter can.

Leah grew up in Batangas City. When she married Edwin, a native of Talisay City, they decided to settle down and stay for good in Cebu. Her husband's hometown is known for rattan plastic folding bed as its primary source of livelihood, which also encouraged Leah to venture into it.

"At present, we are producing 20 pieces of rattan plastic folding bed per week and sell them at a wholesale price of 400 to 450 pesos per piece to our regular buyers. During peak seasons like December, we receive more orders. That is why we need to look for more junk shops in different barangays or munici-palities that could supply us with frames, said Leah.

In preparation for peak seasons, according to Leah, they usually purchase frames in advance. Hence, the need for additional capital is needed. Then she met CARD SME Bank, a thrift bank that provides comprehensive microfinance and business loans to microentrepreneurs.
Prior to becoming a

member of the bank, Leah was a member of Center for Agriculture and Rural Development (CARD), Inc., (A Microfinance NGO) that also provides microfinance loans and community development programs. "On December 18, 2017, I

Now, Lea and her husband are continuously working together in making folding beds in their small backyard that serves as their production place, "We hope to cater to more orders for us to be able to acquire a bigger and wider production place," Lea concluded.
