### **DOST now ready to certify** more than 22,000 teacher-EBs in CALABARZON

DOST-CALABARZON in partnership with the Commission on Elections (COMELEC) once again takes the lead in the certification of 22,194 Electoral Board (EB), previously called as Board of Election Inspectors, in CALABARZON region for the upcoming 2019 May elections.

A total of 34 certifiers and 2 quick response teams composed of DOST-CALABARZON, DOST-PCAARRD, DOST-PCIEERD, DOST-ASTI, and DOST Central Office staff will start on the certification of the teachers on March 5 until March 16 for Laguna, Batangas, Rizal, and Quezon and until March 23 for Cavite.

The public school teachers will undergo written and practical exam on the use of Vote Counting Machine (VCM) to assess their readiness on the upcoming elections. They will be first given a seminar and training on the proper operations of the VCM by the COMELEC

before the certification handled by DOST.

RA 9369 mandates the DOST to oversee the certification of EBs trained by COMELEC in line with the use of VCMs for the automated elections.

This is the fourth time that DOST handled the EB certification. There will be more than 171,000 EBs to be certified all over the country.

## MEASLES IMMUNIZATION CAMPAIGN IN ANTIPOLO CITY GETS BOOST FROM DOH-NDP

DOH-CALABARZON (Cavite, Laguna, Batangas, Rizal, Quezon) has already employed nurses through the Nurse Deployment Program (NDP) to boost the on-going Anti-Measles Mass Immunization Campaign in region on March 1, 2019 and were already deployed in all municipalities of the province.

These NDPs will provide boosts to the on-going vaccination campaign as they will serve as additional manpower and vaccinator that will render house-tohouse vaccination in remote and hard to reach areas of the provinces," Regional Director Eduardo C. Janairo stated.

In Antipolo City, which recorded the highest number of measles cases at 856 as of March 7, 2019, the regional office deployed 52 NDP nurses to help in the

immunization campaign.

According to the Antipolo City Health Office, the city government also hired additional 25 nurses to assists in campaign aside from their regular staff and barangay health workers (BHWs) deployed in various barangays. As of March 5, 2019, Antipolo City has already vaccinated a total of 55,461 children.

The Regional Epidemiology an Surveillance Unit (RESU) reported a total of 4,673 cases from January 1, 2019 – March 7, 2019. From this figure there are a total of 179 confirmed measles cases. A total of 101 deaths recorded, 14 of these were vaccinated, 81 are not

vaccinated and 6 have unknown vaccination status.

Measles cases from various provinces of the region –
Cavite with Batangas with – 661; Laguna with 697;
Batangas - 495; Rizal – 2375; and Quezon with 455.
According to Janairo, although measles cases continue
to increase, there is already a downward trend as
evidence of the continuing efforts of our health workers including non-government in the mass immunization campaign. "We have been receiving positive response from various vaccination teams especially those doing the house-to-house visits as parents are already the ones bringing their children to health workers to be ones bringing their clinical to react workers to vaccinated against measles. "Hindi na nahihirapan ang ating mga health workers sa pagbabakuna dahil karamihan sa kanila, sinasalubong na sila at dala na ang kanilang mga anak na pababakunahan."
"Although may takot pa rin sa ilang mga magulang

dahil sa pangambang dulot ng bakuna, mas may pangamba sila maaring mamatay ang anak nila kapag nagkaroon ng tigdas. Malaking tulong din ang ating mga NDPs dahil mas marami ang magbabahay-bahay, magbabakuna at magbibigay ng tamang impormasyon

sa mga magulang tungkol sa tigdas", he added. There are 229 NDPs employed in CALABARZON. Cavite has 31; Laguna with 31; Batangas - 20; Rizal - 136; and Quezon - 11.

NDP is one of the programs under the DOH Human Resource for Health Deployment Programs, which annually hires and deploys nurses, doctors, dentists, midwives, medical technologists, pharmacists and other allied health workers to geographically isolated and disadvantaged areas (GIDA) and other poor communities in the country to augment the shortage of health workers in these areas.

The NDPs are employed to ensure that adequately trained and skilled health workers are distributed throughout the country ro provide accessible and quality medical services by hiring and deploying 243 doctors, 9,138 nurses, 3,650 midwives, and 241 dentists in farflung areas, particularly in municipalities that do not have any health worker."

armed groups operating in the CALABARZON region and the activities that they initiated to curtail the proliferation of left-leaning groups. He urged the council members particularly the local chief executives to be on guard and to not let these groups infiltrate their localities. He announced that Cavite was declared as a province with Stable Internal Peace and Security last December 4, 2018 and proposed for the creation of a Provincial Task Force to End Local Communist Armed Conflict to spearhead local anti-insurgency measures

The report on anti-drug abuse initiatives and drugfree status of LGUs was presented by Agent Theonette Solar of the Philippine Drug Enforcement Agency which showed that Tagaytay City and the municipalities of Amadeo, Magallanes and Mendez have been declared drug-free by the Regional Oversight Committee on Dangerous Drugs. The municipalities of Alfonso, General Emilio Aguinaldo and Maragondon have achieved 100% drug-free barangays but are yet to be declared drugfree municipality pending the setting up of Balay Silangan, a reformatory institution for drug-pushers which was included in the criteria for declaring drug-free cities and municipalities.

In the afternoon, the PDC- Full Council Meeting was called to order by Provincial Planning and Development Coordinator Jesus Barrera. The discussion proper for new businesses started with the presentation of Mr. Sammy C.M. Yip of Ove Arup & Partners Hong Kong Ltd. on the Bataan Cavite Interlink Bridge (BCIB) Project that aims to ease the traffic congestion and provide convenience in Metro Manila and South and North Luzon gateway, and provide opportunities for economic growth. The said project sought the endorsement of the PDC to the Regional Development Council.

Updates and Status of Solid Waste Management in the province was tackled by Ms. Anabelle Cayabyab, Head of the Provincial Government-Environment and

Natural Resources Office, revisiting the 10-year solid waste management plan of the province and the different LGUs. Governor Boying Remulla stressed that the current focus is primarily on water security pertaining to the depleting sources including the aquifer and that it is important for LGUs to look into their development direction in order to ensure that the environment is protected to sustain future needs.

Arch. Armando Alli of Century Peak Corporation discussed the Cavite Land Reclamation and Development Project (5 islands Land Reclamation Project). DTI-Cavite Provincial Director Noly Guevara presented the 2019 Cities and Municipalities Competitiveness Index and encouraged the local chief executives to enhance data collection and submission in order to improve their performance.

Highlight of the event was the awarding ceremony of the 2018 Seal of Good Financial Housekeeping and the top performing LGUs on the Manila Bay Rehabilitation Program. All the 23 cities and municipalities as well as the province of Cavite passed SGFH while twelve LGUs passed for the Manila Bay rehabilitation program. These include Magallanes, Maragondon, Baccor City, Carmona, Imus City, City of Gen. Trias, Gen. Mariano Alvarez, Tagaytay City, Rosario, Mendez, Naic and Noveleta. The award was conferred by DILG IV-A Regional Director Manuel Gotis and Governor Remulla. Likewise, Local Government Operations Officers were recognized for their performance. - (PICAD)

The Pawikan patrollers patiently collect and gather eggs of pawikan and bring them safely to the Pawikan

Nursery area.

As of this breeding season 2018-2019, there are a total of 3,794 hatchlings carefully released to the coastal waters resulting to the increase in numbers of hatchlings released compared to previous years.

Mr. Deonilo L. Bersamina, ABC President commended

the local communities for their vigilance to conserve and protect the pawikan. He reiterated the importance of the conservation, "the more pawikan we protect and release, the more it will come back again in 20 years to lay another generations of their species, and we should be very grateful that our town has been part of their journey."

PENR-Officer- Cavite For. Unlayao explained that the conservation measures for the pawikan should also include protection of its natural habitat saying, "Sana po mahalin natin hindi lamang po ang mga pawikan kundi pati ang ating kapaligiran."


