

Imus Legacy Projects highlighted in 3rd State of the City Address

IMUS CITY, CAVITE – Earlier today, the city government of Imus held its 3rd City Council (Special) Meeting wherein Honorable City Mayor Emmanuel L. Maliksi delivered his State of the City Address at the Imus National High School – Main (Covered Court).







overcoming adversities alone**

BACOOR CITY, CAVITE — Her forbidden love forced her to leave her hometown and leave behind everything she grew up and believed in and now, a new found love brought her back home.

This is the story of Jocemay Rosales Togonon, a widow at the age of 57, a simple sales assistant for 30 years at the Duty-Free Philippines and a mother to a 27-year old daughter whom she raised alone.

Jocemay or simply 'Jo' to her friends and co-workers is a native of Butuan City, the sixth of seven brood of five female and two male siblings. They were educated in reputable schools in Butuan and all seven are professionals as raised by an educator father and a well-known dressmaker called Pingping Rosales.

After graduating with a BS Industrial Management course from a college in Cebu, Jocemay taught college algebra in their hometown. Not particularly fond of the subject during her student days, she became the best algebra teacher having understood the subject while teaching it.

A perky young lady who loves sports and music, she had a number of suitors but found love with the number one school athlete, a student who was younger than her.

Their fondness for each other became evident that called the attention of the school administrator, her grandmother – the aunt of her mother. And as expected, she was forbidden to continue with the relationship which gave much shame to the family.

This forced her to leave her hometown and sought her fate in Manila.

In Manila, she and her youngest sister rented a room and went on looking for work. She landed a job as a secretary in a Hindu church where she eventually was introduced to Christianity. Later, she was converted to being a Born-again Christian.

Not long after, in 1989 she applied with the Duty-Free Philippines and qualified as a Sales Assistant in the prestigious company. She loved her job as she learned so much about international brands of world-class products, found new friends and earned much.

This was also where she met her husband, Rolando Lagrisola a stock clerk who wooed her and eventually won her heart. They got married without her parents' knowledge of her being pregnant at that time.

Their marriage was a pleasant one, Rolly being very supportive of Jo with the house chores, a loving husband and a doting father to their daughter Krysta.

After two years, ambition drove Rolly away; he found a good job in Japan. His work was very rewarding having a good salary, enough to invest in a house and lot in Imus, Cavite. He sent money

regularly for the next four years.

And then the unexplainable happened, he started evading her calls which later totally was gone. She spent days, weeks and months wondering, calling, asking her husband's friends of his whereabouts, of what could have possibly happened to him. As if he vanished.

Desperation brought much sadness for this young mother and her daughter, and then one night she cried her heart out to God and asked that God show her in her dream whatever happened to her husband but that night, she slept so soundly and peacefully for the first time since this ordeal started. God answered her prayer and she accepted the reality that her husband abandoned them and that she need not worry for God will take care of everything.

She moved on with her life being a single mother and raised Krysta who is now a nurse at a private hospital in the city of Bacoor. She moved in with her sister in Bacoor because she could no longer afford to pay their house in Imus.

Karma would have it because, after more than twenty years, her husband came back from Japan, all sickly and old. He wanted to come back to his family and was asking for forgiveness which Jocemay had given a long time ago but firmly told her daughter that he has no place in their family anymore.

Eventually, after two years of suffering from his illness, Rolly died without seeing Jocemay. She did not even shed a tear for him because they had dried up during the years she struggled alone. Her heart stoned up cold and her sacrifices made her strong.

At times she became lonely, she took the advice of her Christian friends and had an Australian beau, but their love life was short-lived because they were not meant to be' for each other.

These days, Jocemay is sweetly singing love songs and makes herself up pretty well because of her new found love, a former classmate who sought her on Facebook. She had returned home to Butuan to spend New Year much to the delight of her sisters and brothers and all this is because of her inspiration which she fondly calls Marmay. Their love story may not be perfect but it is a work in progress.

Truly, these sayings "love is much sweeter the second time around" and "God works in wondrous ways" are for real.... Jocemay will attest to these. (Ruel Francisco, PIA-Cavite)

DOH TURNS-OVER EQUIPMENTS FOR MALARIA ELIMINATION HUBS IN CALABARZON

TO further improve the Malaria service in the region, DOH-CALABARZON (Cavite, Laguna, Batangas, Rizal, Quezon) provided equipment to the five Malaria Elimination Hubs located in the provinces to be used for diagnostic and entomological training, quality assurance, and research and development.

"We will continue to provide all the support needed in the fight against Malaria to attain our

objective of eliminating malaria by 2020 or the sooner the better. There are still three provinces in

the region still to be declared and we will ensure that every resident of these affected

municipalities will be malaria-free," Regional Director Eduardo C. Janairo stated during the turn-over ceremony held at the BSA Towers, Ortigas Center, Mandaluyong City.

"We need to have reliable diagnosis, highly effective and appropriate treatment and preventive measures to manage and implement malaria interventions," he emphasized.

He also reminded local health officials to make sure that the donated equipments will also have funds for preventive maintenance and preservation. "It is important na hindi mapabayaan at bigyan natin ng halaga lahat ng mga kagamitan na ating mga natatanggap dahil ang mga ito ay napakainportante sa ating trabaho, lalu na at nagagamit natin ito to ensure quality

malaria services, timely detection of infection at immediate response."

Among the equipments donated were stereoscope microscope, desktop computer package with printer and uninterruptible power supply (UPS), chinstrap, coverall, faceshield, global positioning system (GPS), gloves, hard hat, visor bracket and carabao bait trap (CBT).

In CALABARZON, only two provinces were declared as Malaria free namely, Cavite, and Batangas.

According to the 2018 Malaria status, there is a total of 4,933 cases reported. From this figure, 4,847 were local cases and 86 were imported cases. The National Capital Region has 27 confirmed cases and CALABARZON has 7 confirmed cases recorded. Palawan accounts for 94% of the cases.

Malaria Elimination Hubs are established in epidemic-risk and malaria free provinces/cities

with the responsibility of overseeing and sustaining malaria-free status of different respective provinces and cities.

The hubs will ensure anti-malaria interventions in areas with stable and unstable transmission of malaria, and shall sustain provisions of anti-malarial diagnostic, treatment and preventive measures in epidemic-risk, malaria-prone and malaria-free areas. It will also ensure that anti-malaria services are accessible to all clients and community members even in malaria-prone or malaria-free areas.

The Philippines envision the country to be Malaria Free Philippines by 2030. The goal is to reduce malaria incidence in the Philippines by 90% in 2022.

Currently, there are 50 provinces declared as malaria free, 27 provinces in various malaria stage elimination and 4 provinces with Malaria cases recorded according to the National Malaria Elimination Program.

Isang kilalang ekonomaista, isa si Salceda sa mga pangunahing may-akda ng House Bill 5828 na ipinasa ng Kamara noong 2017 at nakabinbin ngayon sa Senado. Ang panukalang bersyon ng Senado ay aprubado na rin nito sa ikalawang pagbasa.
