DOST programs to generate 6,000 more jobs for Filipinos in 2024 Butuan City - For many years, the Department of Science and Technology

Butuan City - For many years, the Department of Science and Technology (DOST) has continuously recognized the significant role of the Micro, Small and Medium Enterprises (MSMEs) in driving innovation, creating employment opportunities, and fostering economic growth in the country through its Small Enterprise Technology Upgrading Program (SETUP).



SETUP is DOST's key strategy to stimulate investments in urban, periurban, and rural areas. Through the years, the SETUP has been transitioned to different phases of program implementation to make it relevant to the changing needs and requirements of MSMEs.

Under the program, assisted MSMEs have been empowered to address their technological problems through the acquisition of appropriate technologies, and the adoption of DOSTgenerated systems and other science and technology (S&T)-based interventions, such as consulting and training services. Among others, the SETUP assists MSMEs in testing their products for compliance with international standards, package and label their products, and create and manage databases and information systems. It also links them to national and international organizations for the provision of raw material sources, markets, training, financing, and equipment

design and fabrication. A visit to two of the successful SETUP-assisted MSMES in the Caraga Region – the RM Wood Product Industry and the Villa Tuna Foods Corporation – offers a glimpse to how these firms generated economic opportunities for local production in the region through technological initiatives.

The RM Wood Product Industry, owned and operated by Mr. Rodolfo B. Pertacorta, applied for SETUP assistance in 2022 to address rising production demands and market growth.

After the DOST intervention, the firm's workforce has grown to 118 from its previous 70 workers. It now produces eight to 10 crates of plywood per 24-hour shift and 2,220 sheets of veneer per day. It has likewise acquired assets estimated at PHP15,000,000.

Also, through the DOST Regional Office in Caraga, the firm plans to establish a laboratory that will specialize in wood, which is seen to generate additional jobs and improve the economic development of the region.

On the other hand, Mr. Archie Moreno, president of Villa Tuna Foods Corp., applied for SETUP assistance to expand his

business and create job opportunities for those affected by the COVID-19 pandemic. The business is based in Montalban St., Bayanihan Pob. in Butuan City,

Through the SETUP program, the company acquired a 3,000kilogram-capacity reefer van (cold storage), effectively cutting its storage expenses and improving its storage capabilities. Prior to the acquisition of the reefer van, the firm outsourced its storage requirements to Gentech.

Today, the company operates eight branches across Mindanao, including two (2) in Butuan City. The Montalban Branch alone has an estimated capitalization of PHP2,000,000.00, reflecting the company's steady growth and success.

The project visit to the two MSMEs was led by DOST Undersecretary for Regional Operations, Engr. Sancho A. Mabborang, and DOST-Caraga Regional Director Noel Ajoc.

DOST vows to continue to improve its efforts to support and encourage MSMEs to embrace new technology and develop their entrepreneurial abilities to improve their operational effectiveness, increase productivity, and strengthen the competitiveness of their


products and services. Since 2022, DOST has assisted 9,612 firms and projects nationwide in the sectors of food processing, furniture, marine and aquatic resources, agriculture, pharmaceuticals, ICT and electronics, gifts, housewares and decor, metals, and engineering.

P100k reward offered for capture of Palawan ex-Gov IN its continuing pursuit for justice for fallen members of the press, a arrested last April 29, 2024 strengthens the managed to get

P100,000 reward is being offered by the government for anyone who can provide solid information leading to the arrest of former Palawan governor, Joel Reyes, the identified mastermind in the 2019 murder of Puerto Princesa City broadcast journalist, Gerardo Valeriano 'Doc Gerry' Ortega.

Usec. Paul M. Gutierrez, executive director of the Presidential Task Force on Media Security (PTFoMS), said the reward money would come from the Presidential Anti-Organized Crime Commission (PAOCC) under Usec. Gilbert Cruz.

"Since my assumption into office, the PAOCC has been a strong supporter of the PTFoMS' activities. In the case of Doc Gerry, Usec. Cruz and I agreed that his killing has already dragged on far too long. Justice has been denied to him and his family far too long," Gutierrez said.

He stressed that the murder of Ortega and other slain journalists, remain a priority of the Marcos administration thru the PTFoMS.

With the reward offer, Gutierrez expressed confidence it will bolster the efforts in the manhunt and subsequent arrest of Reyes, who has been in hiding since last year after Supreme Court the cancelled his bail and ordered him re-arrested to face trial for the killing of Ortega.

The PTFoMS head also called on other civicminded citizens and those advocating for justice to put their money where their mouth is by contributing to the reward. "While any act of violence, especially deserves murder, condemnation, it is not enough. Let us all work together in proving that no one is above the law by raising the reward for the arrest of Reyes," Gutierrez said.

The official also bared that last June 10, 2024, he met with the private counsels of the Ortega family, together with representatives from the office of Department of Justice (DOJ) secretary, Jesus Crispin Remulla, to discuss the developments in the case.

Based on experience, Gutierrez noted that the offer of reward money incentivized people to step forward and give information to the whereabouts of suspects leading to their arrest.

Gutierrez was referring to the cases of Misamis Occidental radioman Juan "DJ Johnny Walker" Jumalon and, Kidapawan broadcaster Eduardo "Ed" Dizon, where the public coordinated and eventually provided details on the whereabouts of the gunmen in these killings that led to their arrest.

Jumalon's gunman Julieto Mangumpit, also known as "Ricky," was

"The MySSS Pension Booster is not just an ordinary retirement savings plan. It's a safe, convenient, and tax-free investment opportunity that allows you to earn your income from contributions. By participating, you can attain your savings goal, ensuring a comfortable retirement." Macasaet said.

Two schemes in one program

SSS Vice President for Benefits Administration Division Joy A. Villacorta said that the MySSS Pension Booster consists of mandatory and voluntary schemes.

Villacorta said that the mandatory scheme automatically enrolls SSS members contributing to the Regular SSS Program. It gives an opportunity to save more beyond the threshold.

"Rest assured, your contributions and earnings themselves freed on bail in 2018 and both ran for public office in the 2022 elections where Reyes lost as governor.

"For as low as P500 per payment in the voluntary scheme of MySSS Pension Booster, members can add to their savings which grows over time. It's a flexible scheme as members may contribute any amount, with the maximum based on limits set by our collection partners," Villacorta said.

Villacorta said that for urgent cash needs, they can withdraw their total contributions including its investment earnings because SSS allows partial or full withdrawal of their savings in the program. "However, we encourage you to stay in the program for at least five years to maximize the potential earnings on your savings Villacorta emphasized.

She added that for those who want to use their savings in the program to augment their retirement funds, they have the option to get their total contributions plus interest when they get their retirement, total disability or death benefits from the Regular SSS Program, which is also tax-free.


