PH human rights consultation rolls across country







The relief on surcharges and interests on the Tax on the Transfer of Real Property Ownership in the Province of Cavite is hereby granted in support of the extension of the Estate Tax Amnesty Program of the Department of Finance until 14 June 2025.

SECTION 2. REPEALING CLAUSE. All executive issuances, orders rules and regulations or parts thereof inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

SECTION 3. EFFECTIVITY. This Ordinance shall take effect immediately after its approval and compliance with the posting and publication requirements.




