"Cavite City is now inder a state of calamity," Mayor Denver Chua announced on his Facebook page on Tuesday afternoon.

In another post, the city government said the declaration was based on the mayor's and the Local Disaster Risk Reduction Management and Council's endorsement

their calamity funds. The move would also be a mechanism to control ► CAVITE CITY • 5 CAVITE, Philippines – Prime Solar, a subsidiary of Enrique Razon-led Prime Infrastructure, inaugurated on Wednesday, July 17, a 64-megawatt (MW) solar power plant in Maragondon, Cavite.

Prime Infra completes its Maragondon solar power plant more than a month after they inaugurated its sister 64-MW power plant in Tanauan, Batangas. This comes a year after Prime Infra broke ground.

"The completion of the Maragondon solar power plant is a significant milestone on Prime Infra's energy portfolio," said Prime Infra president and CEO Guillaume Lucci on Wednesday.

"This represents one-half of our entire project which is a sister plant in Tanauan." The company says both plants can power 84,000

households.


