Rosario residents join forces for coastal clean-up through DOLE's TUPAD Program



On July 16, 2024, First District Representative Jolo Revilla and the Office of the Provincial Public Employment Service Manager (OPPESM) organized a coastline clean-up drive in Wawa I, Rosario, Cavite as part of a joint effort to save the environment and support local livelihoods. The cGMP portion addressed several topics, including the Quality Management System, which guarantees consistent product quality and adherence to regulatory standards. It also covered Production and process controls, which oversee and fine-tune manufacturing



processes to ensure precision. Equipment maintenance was emphasized to ensure that machinery operates effectively and reliably. Additionally, Sanitation and hygiene practices were highlighted as essential for preventing contamination and maintaining a clean production environment. These components collectively uphold the overall quality and safety of food products.

Under the topic of FSH, the training covered different categories of food hazards, including biological, chemical, and physical contaminants that can jeopardize food safety. It also addressed control mechanisms for mitigating these risks. Participants learned preventive measures such as proper hygiene practices, effective cooking methods, and appropriate food handling techniques to prevent contamination. The seminar emphasized the importance of monitoring



and verification methods to ensure adherence to food safety practices and their effectiveness. Additionally, corrective actions were discussed as procedures to address and resolve issues when food safety controls fail. Participants gained an understanding of regulatory compliance, including the food safety

regulations and standards required for legal adherence.

Participants actively took part in workshop activities designed to enhance their practical knowledge and skills in food safety. These activities included hands-on training in proper handwashing techniques

and exercises aimed at identifying both physical and biological hazards.

PCC clears Cavite, SDC deal to develop Sangley airport

The Philippine Competition Commission (PCC) has cleared the Cavite provincial government and SPIA Development Consortium (SDC) deal for the development of the Sangley Point International Airport (SPIA) Project in Cavite.

House of Investments, Inc. (HOI), which is part of SDC, said in a regulatory disclosure on July 23 that it received the PCC resolution on the same day. HOI filed the notification with PCC last March in compliance with the Philippine Competition

Act in connection with the proposed joint venture (JV) for the SPIA project.

Other members of SDC include Cavitex Holdings Inc., Samsung C&T Corp., MacroAsia Corp., Munich Airport International GmbH, and Ove Arup & Partners Hongkong Ltd.

SDC and the Cavite provincial government signed on February 6, 2023 a JV and development agreement for the \$11 billion SPIA Project.

The signing clears the way for the consortium to begin preparatory work on

the airport project.

On September 14, 2022, the Cavite provincial government officially awarded the contract to SDC, whose members also signed their Consortium Collaboration Agreement during the same event.

The awarding came after no firm challenged the consortium's unsolicited proposal until the August 17, 2022 deadline for the project's competitive challenge process.

SDC submitted its unsolicited proposal for a joint venture with the Cavite provincial government to develop

SPIA in 2021, after the latter declared as failed the second bidding for the project in October 2021.

SPIA is envisioned as a two-runway airport with annual capacity of 80 million passengers, expandable to four runways that can handle as many as 130 million passengers a year.

The airport project aims to provide a premium gateway that will initially serve as an alternative to the Ninoy Aquino International Airport (NAIA) and is designed to meet an expected increase in demand for air transport in the next 30-

40 years.

The project includes the construction of a four-kilometer connector road with provisions for rail connectivity, as well as fully-integrated logistics and aviation support facilities.

With the development of the first runway, SPIA can operate as a satellite runway to immediately relieve the extreme congestion of the runway at NAIA.

The consortium said the SPIA development is expected to create 50,000 jobs and be a catalyst project to bring in foreign direct investment.

PROVINCIAL ORDINANCE NO. 452-2024

AN ORDINANCE STRENGTHENING THE RABIES PREVENTION AND CONTROL PROGRAM OF THE PROVINCE OF CAVITE

Introduced and Sponsored by: Hon. Reyniel A. Ambion
Chair, Committee on Health, Nutrition and Population

Co-sponsored by: All Sangguniang Panlalawigan Members

WHEREAS, Section 15, Article II of the 1987 Philippine Constitution declares that the State shall protect and promote the right to health of the people and instill health consciousness among them;

WHEREAS, it is stipulated in the Republic Act No. 9482 or also known as the *"Anti-Rabies Act of 2007"* that the control, prevention of spread, and eventual eradication of human and animal rabies shall be provided;

WHEREAS, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, states that the local government unit shall ensure and promote the general welfare of its constituents, to include among others, the promotion of health and safety;

WHEREAS, rabies is a preventable disease that is spread primarily by bites and contact with infected animals' saliva. Due to its

high death rate, it remains a public health problem in the Philippines. According to the World Health Organization (WHO), 59,000 people die each year from rabies, 97% of which are transmitted by dogs;

WHEREAS, rabies can be controlled, prevented, if not totally eradicated, by implementing a concerted and comprehensive rabies-control program such as mass vaccinations and conduct of advocacy campaigns on responsible pet ownership;

WHEREAS, there is an existing Provincial Ordinance on Rabies Prevention and Control Program in the Province of Cavite last 2015, however, due to the continues rising of animal bite cases in the Province from 2018 to 2023, there is a need to reiterate and strengthen the legislative measure;

WHEREAS, in 2015, the world called for action by setting a global goal of zero human dog-mediated rabies deaths by 2030, worldwide;

NOW, THEREFORE, on motion of Hon. Ambion, duly seconded by Hon. Sison and unanimously approved by the Members present, be it enacted by the Sangguniang Panlalawigan of Cavite in a session duly assembled that:

Section 1. Short Title. This ordinance shall be known and cited as, ***“The Cavite Rabies Ordinance 2023”***.

Section 2. Declaration of Policy. It is hereby declared the policy of the Provincial Government of Cavite to ensure healthy lives, promote well-being, protect and enhance the health and safety of Caviteños. It is also the objective of the Provincial Government of Cavite to eliminate rabies annually and declare Cavite as Rabies-Free by 2030.

Section 3. Scope. This ordinance shall cover all matters pertinent to the protection and promotion of the health of the people. A system for the control, prevention of the spread and eventual eradication of human and animal rabies shall be provided and the need for responsible pet ownership should be established within the Province of Cavite.

Section 4. Definition of Terms. For the purpose of this ordinance, the following terms shall mean:

- a. **Animal Health Worker** – refers to the person (frontline animal health worker) who will take care of the health of the animals
- b. **Animal pound** - refers to a public enclosure for stray animals
- c. **Animal vaccination** - refers to rabies vaccination of dogs, cats and all other warm-blooded animals by a licensed government or private veterinarian and trained individual such as animal health worker under the direct supervision of a licensed government veterinarian. The services of the said trained individual shall be limited only to rabies vaccination of dogs/cats and only during government mass vaccination campaigns
- d. **Bitten** - refers to an act by which a dog/cat seizes cuts or grips with its teeth where the skin of a person has been wounded, pierced or scratched
- e. **Cat** - refers to a common quadruped domestic animal belonging to the Order Carnivora (male or female), scientifically known as *Felis domesticus*
- f. **Concerned Officials** - refer to barangay officials, health workers, police officers or government veterinarians
- g. **Direct Supervision** - refers to range supervision where physical presence of the veterinarian within the barangay is necessary
- h. **Dog** - refers to a common quadruped domestic animal belonging to the Order Carnivora (male or female), scientifically known as *Canis familiaris*
- i. **Euthanasia** - refers to the process of painless death to dog/cat and other animals
- j. **Impound** - refers to seizing and holding of animals in the custody of the law
- k. **Owner** - refers to any person keeping, harboring and or in charge, care or control of a dog and cat including his/her representative
- l. **Warm-blooded animals** - refer to animals that maintain constant body temperature regardless of the temperature of the surroundings

- m. **Public Place** - refers to any place open to the public like parks, malls, markets, streets, etc.
- n. **Rabies** – refers to a highly fatal disease caused by a lyssavirus, transmitted mainly through the bite of an infected animal and is characterized by muscle paralysis, hydrophobia and aerophobia, and other neurological manifestations
- o. **Rabies transmission** - refers to the transmission or passage of the rabies virus through a bite by an infected animal, or through contamination with virus-laden saliva on breaks in the skin and of mucous membranes such as the eyes, the lips, the mouth, or the genital organs
- p. **Rabies Vaccination/Immuno prophylaxis of Humans** - refers to the inoculation of humans, with modern day rabies vaccines or rabies immunoglobulin, by a trained doctor or nurse under the supervision of a qualified medical practitioner
- q. **Registration fee** - refers to a fee provided by the animal owner, for the purpose of registration of their pet animal
- r. **Post-exposure Prophylaxis (PEP)** - refers to an anti-rabies treatment administered after an exposure to rabies, which include local wound care, rabies vaccine, with or without anti-rabies immunizing agent
- s. **Pre-exposure Prophylaxis (PREP)** - refers to rabies vaccination administered before an exposure to rabies to those who are at high risk of getting rabies
- t. **Stray animal** - refers to any dog or cat leaving its owner's place or premise and no longer under the effective control of the owner
- u. **Animal or Human Barbiturates** - refer to drugs that depress the function of the central nervous system.
- v. **Spaying** - refers to the removal of the reproductive organs of female dogs and cats
- w. **Tandok** - Traditional/folk medicine done by placing a deer horn over the wound
- x. **Neutering** - refers to the removal of the testicles in male dogs and cats
- y. **Microchip**- refers to a chip implanted under the skin of a domestic animal as a means of identification

Section 5. Provincial Rabies Prevention and Control Council (PRPCC). The Provincial Rabies Control Council is hereby established and shall implement the Rabies Prevention and Control Program in the province. The Provincial Governor as the Chair, shall lead, recommend and assist in the formulation of policies and guidelines on all matters pertaining to rabies prevention and control measures.

Section 5.1. Provincial Rabies Prevention and Control Council (PRPCC) Composition. The PRPCC shall be composed of the following:

Chair:	Provincial Governor
Co-Chair:	Provincial Veterinarian (animal side)
Co-Chair:	Provincial Health Officer (human side)
Secretariat:	Office of the Provincial Veterinarian (OPV)

Members:

1. Sangguniang Panlalawigan Chair, Committee on Health, Nutrition and Population and Committee on Agriculture and Agrarian Reforms
2. Superintendent, Department of Education (DepEd)-Cavite
3. Provincial Director, Philippine National Police- Cavite
4. Provincial Director, Department of the Interior and Local Government (DILG)-Cavite
5. President, Cavite State University
6. President, Association of Municipal Health Officer (AMHOP)
7. Representative, City/Municipal Veterinarian Office
8. President of the City/Municipal Agriculturists Association- Cavite

9. President of Cavite Mayors' League
10. President of Liga ng mga Barangay (LnB)- Cavite
11. Office of the Provincial Environment and Natural Resources Officer (OPENRO)
12. Representative, Civil Society Organizations
13. Representative, Provincial Department of Health Office (PDOHO) –Cavite
14. President, Philippine Veterinary Medical Association (PVMA)-Cavite Chapter

Section 5.2. Functions of the Council. The members of the council shall perform their respective functions and responsibilities:

A. Office of the Provincial Veterinarian (OPV)

1. Formulates policies and guidelines on all matters pertaining to rabies prevention and control measures for approval of the Provincial Governor.
2. Ensures that all dogs/cats are properly registered, immunized according to current guidelines and issued a corresponding animal tag/microchip and vaccination card/ certificate.
3. Ensures the availability and adequate supply of animal anti-rabies vaccine and allocate funds to augment the implementation of the Local Rabies Prevention and Control Program (LRPCP), particularly on the financing of supplies of rabies vaccines, tag/microchip and vaccination card/ certificate.
4. Ensures the enforcement of R.A 9482 or "*The Anti-Rabies Act of 2007*" and Section 6 of Republic Act No. 8485 or "*The Animal Welfare Act of 1998*".
5. Prohibits the trade of dogs for meat.
6. Prohibits the use of electrocution as a euthanasia procedure.
7. Requires pet shops to post information regarding rabies and responsible pet ownership;
8. Undertakes free anti-rabies vaccination of dogs/cats in coordination with Cities/Municipalities, giving priority to the areas with high incidence of rabies.
9. Maintains and improves animal rabies surveillance system.
10. Strengthens the Information Education and Communication activities on rabies prevention, control, eradication and responsible pet ownership.
11. Establishes and maintains rabies-free zone in coordination with the City/ Municipal Veterinary Offices and City/Municipal Agriculture Offices.
12. Encourages collaborative activities with the PRPCC members and other concerned sectors.
13. Acts as the secretariat of the council.

B. Office of the Provincial Health Officer (OPHO)

1. Ensures the availability and adequate supply of WHO pre-qualified and FDA approved and Registered rabies vaccines, Rabies Immunoglobulins (RIG) in animal bite treatment centers at all times and shall coordinate with other implementing agencies and concerned CSOs for this purpose.
2. Encourages the LGUs for fund allocation from National Tax Allotment (NTA) for the procurement of rabies vaccines.
3. Provides Pre-Exposure Prophylaxis to high risk personnel, such as, but not limited to, laboratory staff, veterinarians, animal handlers, vaccinators and other persons working with rabies virus for free.
4. Coordinates with the Office of the Provincial Veterinarian in the development of appropriate health education strategies to inform the public on rabies prevention and control and responsible pet ownership.
5. Maintains a human rabies surveillance system in coordination with Provincial Epidemiology and Surveillance Unit (PESU).

6. Encourages collaborative activities with the PRPCC members and other concerned sectors.
7. Conducts Health Promotion Activities in the prevention and control of human rabies in coordination with the Health Education and Promotion Unit (HEPU).
 - a. Celebration of the Rabies Awareness Month every March under Executive Order No. 84, series of 1999
 - b. Celebration of World Rabies Day every September 28 of each year and thereafter
8. Acts as Resource Person/Facilitator during training/orientation/ workshop.
9. Procures, allocates and distributes WHO pre-qualified and FDA approved and Registered rabies vaccines, Rabies Immunoglobulins (RIG) and other logistics needed for the program implementation.
10. Ensures proper cold chain management of rabies vaccines and RIG.
11. Conducts monitoring and evaluation.
12. Conducts assessment and certification of Animal Bite Treatment Center/Animal Bite Center.

C. Department of Health

1. Develops and cascades relevant policies and guidelines to LGUs to improve the implementation of the program.
2. Ensures the availability and adequate supply of human anti-rabies vaccine and Rabies Immunoglobulin (RIG) in animal bite treatment centers at all times and coordinates with other implementing agencies and concerned NGOs;
3. Encourages the LGUs to appropriate funds from Internal Revenue Allotment (IRA)/National Tax Allotment (NTA) for the purchase of rabies vaccines.
4. Provides and augments rabies vaccines and RIG to all government ABTCs through the Center for Health Development (CHD).
5. Provides Post-Exposure Prophylaxis at the minimum expense to individuals bitten by animals suspected of being rabid which will consist of the initial vaccine and immunoglobulin dose.
6. Provides Pre-Exposure Prophylaxis to high-risk personnel, such as, but not limited to laboratory staff, veterinarians, animal handlers, vaccinators and other persons working with rabies virus for free.
7. Provides Training on Animal Bite and Rabies Management for Doctors and Nurses and relevant technical assistance to LGUs for the implementation of Rabies Prevention and Control Program.
8. Conducts assessment of Animal Bite Treatment Center and Animal Bite Center for DOH-ABTC/ABC Certification.
9. Ensures proper management of logistics to include forecasting, storage and distribution.
10. Coordinates with the DA in the development of appropriate health education strategies to inform the public on rabies prevention and control and responsible pet ownership.
11. Develops and maintains a human rabies surveillance system.
12. Encourages collaborative activities with the Department of Agriculture, Department of Education, Department of the Interior and Local Government, Department of Environment and Natural Resources, Non-Government Organizations, People's Organization and other concerned sectors.

D. Provincial Department of Health Office (PDOHO)-Cavite

1. Represent the DOH in the Provincial/City/Municipal Local Health Board to advocate the implementation of the Rabies Prevention and Control Program.
2. Acts as technical consultant/resource person on health development.
3. Guide the MHO/CHO in formulation of local health policies adopting national priority policies, program and projects.

4. Coordinate and facilitate Technical Assistance needed by the LGUs in terms of Rabies Program implementation.
5. Facilitate adoption of localized health promotion framework strategy and assist municipal/city in the implementation of population-wide rabies health promotion program, projects and activities.
6. Provide technical assistance to Animal Bite Treatment Center/Animal Bite Center DOH-Certification.
7. Assist in monitoring and evaluation of rabies program implementation.
8. Facilitate request of MHO/CHO for rabies vaccines, RIG and other commodities procured by DOH-CO and CHD.

E. City/Municipal Health Offices/Animal Bite Treatment Centers

1. Ensure funding requirements needed for the management of rabies exposures, pre-exposure prophylaxis and for the operational system.
2. Ensure the availability and adequate supply of WHO pre-qualified and FDA Approved and Registered rabies vaccines, and Rabies Immunoglobulins (RIG) in animal bite treatment centers at all times.
3. Provide Post-Exposure Prophylaxis (PEP) at the minimum expense to animal bite patient which will consist of the rabies vaccines and rabies immunoglobulin dose.
4. Provide Pre-Exposure Prophylaxis to high risk personnel, such as, but not limited to, laboratory staff, veterinarians, animal handlers, vaccinators and other persons working with rabies virus for free.
5. Integrate Rabies Prevention and Control Program to the regular health services.
6. Coordinate with the City/Municipal Veterinary Offices and City/Municipal Agriculture Offices in the development of appropriate health education strategies to inform the public on rabies prevention and control and responsible pet ownership.
7. Maintain a functional rabies surveillance system.
8. Conduct Health Promotion Activities in the prevention and control of rabies.

F. City/Municipal Veterinary Offices and City/Municipal Agriculture's Offices

1. Establish and strictly implement the Local Rabies Prevention and Control Program (LRPCP) on their respective localities in compliance with R.A 9482 or "*The Anti-Rabies Act of 2007*" and its Implementing Rules and Regulations, and ensure that the City/Municipal Rabies Coordinating Council must also be created.
2. Ensure that dogs/cats are subject to rabies vaccination, registered and issued a corresponding animal tag and vaccination card/certificate signed by the duly licensed government veterinarian.
3. Strictly enforce the animal impounding activities and field control to eliminate stray animals.
4. Ensure that dogs/cats are leashed or confined within the premises of the owner's house or owner's fenced surroundings.
5. Allocate funds to augment the implementation of the Local Rabies Prevention and Control Program (LRPCP), particularly on the financing of supplies of rabies vaccines, tag/microchip and vaccination card/certificate.
6. Ensure the enforcement of Section 6 of Republic Act No. 8485 or "*The Animal Welfare Act of 1998*".
7. Enact additional local ordinances that will support the Provincial Rabies Prevention and Control Program that will include the regulation of treatment locally known as "*tandok*".
8. Submit report to and coordinate regularly with the Provincial Rabies Prevention and Control Council.
9. Prohibit the trade of dogs' meat.
10. With respect to cities and first class municipalities, establish and maintain an animal pound where impounded dogs/

cats shall be kept, in accordance with Section 8 herein: Provided, that the other municipalities, shall, on their own, establish an animal pound or opt to share the expense of establishing and maintaining an animal pound with other adjoining municipalities and/or with private animal shelters and control facilities.

11. With respect to cities and municipalities with City/Municipal Veterinarian or a licensed veterinarian working in an agriculture office, he/she will prohibit the use of electrocution as a euthanasia procedure and will use only humane procedures in killing of animals. The licensed veterinarian will use the most scientific methods available as may be determined and approved by the Council.

12. Appoint a veterinarian and establish a veterinary office in every city and first-class municipality, provided that the other municipalities shall, on their own, opt to share the expense of having a veterinary office.

13. Require pet shops to post information regarding rabies and responsible pet ownership.

14. Advise the City/Municipal Mayor on all matters pertaining to the improvement of LRPCP.

15. For purposes of ensuring the administrative feasibility of implementing the provisions of this ordinance, the LGU shall collect the fines. All fines collected shall be used for the enhancement of the Local Rabies Prevention and Control Program within the locality concerned.

16. Responsible for catching stray dogs and cutting head samples of suspected rabid dog for rabies virus confirmation.

G. President of Cavite Mayors' League/President of Liga ng mga Barangay (LnB)- Cavite

1. Establish or revitalize Local Rabies Prevention and Control Committees for active surveillance and monitoring of dog movements (especially stray).

2. Implement the Provincial Rabies Prevention and Control Program (PRPCP) in all cities/municipalities and barangays.

3. Strictly enforce and monitor dog leashing and confinement in all barangays.

4. Conduct a mandatory routine census to update dog population in all barangays.

5. Adopt measures on compulsory dog registration, vaccination and impounding of stray animals.

6. Encourage the residents of barangays not to resort to "tandok" as remedy to rabies disease.

7. Disallow the trade, selling of dog meat, dog farming, and/or slaughtering of dog for consumption.

8. Include in the Mayors' League/LnB Regular Meeting Agenda the LRPCP and report the status of rabies program implementation at city/municipal and barangay level.

9. Improve the performance of each barangay in implementation of the rabies program through incentive system as well as penalties for best and worst barangay.

10. Establish a Search for Best Barangay that strictly implemented the rabies program.

11. In all the Barangays, designate the Sangguniang Barangay, Chairman on Committee on Agriculture as Barangay Animal Control Officer.

H. Department of Education (DepEd)

1. Strengthens rabies education program through information dissemination/campaign.

2. Assists in the dog and cat mass immunization campaigns in the community.

3. Encourages collaborative activities with the PRCC members and other concerned sectors.

4. Integrates proper information and education on responsible pet ownership in the relevant subjects in the Elementary and High School levels.

I. Philippine National Police- Cavite

1. Formulates and implements measures that will totally remove all stray dogs in the city/municipality.
2. Disseminates information and adopts measures on dog registration and vaccination.
3. Leads in the enforcement and provides assistance and security to PRCC members during implementation of the stray dog control program.
4. Participates and assists the PRCC in the proper implementation of the program.
5. Assists in dog population control based on Implementing Rules and Regulations of Republic Act No. 8485.

J. Department of the Interior and Local Government (DILG) -Cavite

1. Ensures compliance of the LGUs with their responsibilities as defined in this ordinance.
2. Issues relevant orders and circulars for the implementation and monitor compliance of the LGUs in support of the Rabies Program.

K. Civil Society Organization and the Academe - Agencies tasked to implement the anti-rabies program shall seek the assistance and participation of CSOs and Academe in any of the following activities:

1. Community mobilization.
2. Health education/information dissemination on Rabies and responsible pet ownership.
3. Mass anti-rabies campaign.
4. Promotion of the anti-rabies campaign during pet or any animal shows
5. Surveillance/reporting of rabies cases in animals and humans
6. Any other activities geared towards the prevention and complete eradication of Rabies.

Section 6. Observance. The following health promotional program shall be observed with appropriate activities through the Office of the Provincial Veterinarian and the Office of the Provincial Health Officer;

- a. Celebration of the Rabies Awareness Month every March pursuant to Executive Order No. 84, series of 1999
- b. Celebration of World Rabies Day every September 28 of each year as a global health observance

6.1 The following activities are in observance of the Rabies Awareness Month and World Rabies Day;

- a. Mass anti-rabies vaccination
- b. Mass spaying and castration
- c. Formulation and distribution of IEC on responsible pet ownership/Rabies Awareness
- d. Dog show
- e. Pet Fare/Fun Run
- f. Quiz Bee on Rabies
- g. Poster and Logo making contest

Section 7. General Provisions.

I. Responsibilities of Pet Owners. All pet owners shall adhere to the following guidelines:

1. Have their dog/cat registered and regularly vaccinated against rabies and maintain a vaccination card/certificate which shall contain vaccinations history of dog/cat, for accurate record purposes
2. The registration fee shall be shouldered by the pet owner, amounting to Php20.00 but not more than Php35.00. Upon registration and vaccination, the City/Municipal Agriculture personnel or City/Municipal Veterinarian shall provide the owner with a dog/cat tag/microchip and vaccination card/certificate duly signed by a licensed Government Veterinarian. If no tag/microchip and vaccination certificate were issued to the owner, no registration fee shall be collected.
3. Animal tags shall be securely displayed at all times. The animal tags are non-transferrable from animal to animal or from owner to owner. If any tag is lost or stolen, damaged or illegible, the owner to which the same was issued shall be entitled to receive a duplicate/replacement upon presentation of the vaccination card/certificate and subscribed affidavit in case of loss, plus replacement fee of Php30.00.
4. Submit their dogs/cats for mandatory registration.
5. Maintain control over their dog/cat and not allow it to roam the streets or any public place without a leash.
6. Be a responsible owner by providing their dog/cat with proper grooming, adequate food and clean shelter.
7. Within twenty-four (24) hours, report immediately any dog/cat biting incident to the concerned officials for investigation or for any appropriate action and place such dog/cat under observation by a government or private veterinarian.
8. Assist the dog/cat bite victim immediately and shoulder the medical expenses incurred and other incidental expenses

relative to the victim's injuries.

II. Impounding Field Control and Disposition of Unregistered, Stray and Unvaccinated dogs/cats - Unregistered, stray or unvaccinated dogs/cats shall be put in animal pounds and disposed of, taking into consideration the following guidelines:

1. Unregistered, stray or unvaccinated dogs/cats shall be impounded and kept in the City/Municipal designated animal pound.
2. Impounded dogs/cats not claimed after three days from the animal pound shall be placed for adoption to qualified persons, with the assistance of an animal welfare CSO, when feasible, or otherwise disposed of in any manner authorized, subject to the pertinent provisions of Republic Act No. 8485, otherwise known as the Animal Welfare Act of 1998.
3. A fee shall be paid by owners of impounded animal to the city/municipal concerned, pursuant to Section 8 hereof.

III. Dog/Cat Population Control - There is a need to control the dog/cat population and minimize the number of stray animals. As such, it is hereby mandated:

1. That the Office of the Provincial Veterinarian, Office of the Provincial Health Officer, DepEd, PNP-Cavite, DILG-Cavite, Academe, City/Municipal Veterinary Offices and City/Municipal Agriculture Offices, President of Cavite Mayors' League/Liga ng mga Barangay of Cavite with the assistance of CSOs shall undertake an educational and promotional campaign on responsible pet ownership, including the option of spaying or neutering their dogs/cats.
2. That the LGUs shall provide an incentive system whereby owners of dogs/cats which have been spayed or neutered will be given a subsidized or discounted pet registration fee.
3. That dogs/cats which have been impounded three times shall only be released after having been spayed or neutered, at the expense of the animal owner.

Section 8. Penalties. For any violation of the provision of this ordinance, the following penalties shall be imposed:

1. Pet owners who fail or refuse to have their dog/cat registered and immunized against rabies shall be punished by a fine of Two Thousand Pesos (Php2,000.00).
2. Pet owners who refuse to have their dog/cat vaccinated against rabies shall be liable to pay for the vaccination of both the dog/cat and the individuals bitten by their pet animal.
3. Pet owners who refuse to have their dog/cat put under observation after said animal has bitten an individual shall be meted a fine of Five Thousand Pesos (Php5,000.00) or imprisonment of 1 year, or both at the discretion of the court.
4. Pet owners who refuse to have their dog/cat put under observation and do not shoulder the medical expenses of the person bitten by their pet animal shall be meted a fine of Five Thousand Pesos (Php5,000.00) or imprisonment of 1 year, or both at the discretion of the court.
5. Pet owners who refuse to put leash on their dogs/cats when they are brought outside the house shall be meted a fine of Five Hundred Pesos (Php500.00) for each incident.
6. An impounded dog/cat shall only be released to its owner upon payment of a fine of not less than Five Hundred Pesos (Php500.00) but not more than One Thousand Pesos (Php1,000.00).
7. Any person found guilty of trading dog/cat for meat shall be fined Five Thousand Pesos, (Php5,000.00) per animal and imprisonment of one (1) year, or both at the discretion of the court.
8. Any person found guilty of using electrocution as a method of euthanasia shall be fined not less than Five Thousand Pesos (Php5,000.00) per act or imprisonment of one (1) year or both at the discretion of the court.
9. If the violation is committed by an alien, he or she shall be immediately deported after service of sentence without any further proceedings.

Section 9. Implementing Rules and Regulations. The Office of the Provincial Governor through the Office of the Provincial Veterinarian, Office of the Provincial Health Officer, Office of the Provincial Legal Officer and the Provincial Rabies Control Council shall formulate the necessary rules and regulations within sixty (60) days from the effectivity of this ordinance.

Section 10. Separability Clause. If any provision of this ordinance is declared invalid or unconstitutional, the other provisions

not affected thereby shall remain in full force and effect.

Section 11. Repealing Clause. All ordinances, rules and regulations inconsistent with this Ordinance are hereby repealed and/or modified accordingly.

Section 12. Effectivity. This Ordinance shall take effect after its approval and compliance with the posting and publication requirements.



PROVINCIAL ORDINANCE NO. 457-2024

AN ORDINANCE REQUIRING ALL RESIDENTIAL, COMMERCIAL, INDUSTRIAL ESTABLISHMENTS, AND BOTH PUBLIC AND PRIVATE INSTITUTIONS IN THE PROVINCE OF CAVITE TO ESTABLISH A RAINWATER HARVESTING SYSTEM

WHEREAS, Section 468 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, states

that the Sangguniang Panlalawigan, as the legislative body of the province, shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the province and its inhabitants;

WHEREAS, Section 3 (i) of the same code, provides that local government units shall share with the national government the responsibility in the management and maintenance of ecological balance within their territorial jurisdiction;

WHEREAS, Section 16 of the same code, provides that, "every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare";

WHEREAS, Section 20 (d) of R.A. 9275 also known as the Philippine Clean Water Act of 2004 declares that each LGU shall, through its Environment and Natural Resources Office (ENRO) established in Republic Act No. 7160 take active participation in all efforts concerning water quality protection and rehabilitation;

WHEREAS, Section 2 (b), Article 1 of R.A. 9275 states that it shall be the policy of the state to promote environmental strategies, use of appropriate economic instruments and of control mechanisms for the protection of water resources;

WHEREAS, based on a study presented during the Cavite Water Summit 2017, Cavite is at the critical stage of ground water extraction;

WHEREAS, rainwater harvesting promotes self-sufficiency helps conserve water and allows people to plan for more efficient use of the water resources in the future;

WHEREAS, to enable the province to contribute to the United Nations Sustainable Development Goal (SDG) 6, an ordinance to this effect is necessary.

NOW, THEREFORE, on motion of Hon. Sison, duly seconded by Hon. Austria, Jr., Hon. Cantimbuhan and unanimously approved by the Members present, be it enacted by the Sangguniang Panlalawigan of Cavite in a session duly assembled that:

SECTION 1. SHORT TITLE. This Ordinance shall be known and cited as the "Rainwater Harvesting Ordinance In The Province Of Cavite".

SECTION 2. COVERAGE. This Ordinance shall cover all residential, commercial, and industrial establishments and both public and private institutions to be constructed within the Province of Cavite.

SECTION 3. DEFINITION OF TERMS. For purposes of this ordinance, the following terms shall mean:

1. **Commercial establishments** – refer to establishments used for commercial purposes, such as a bar, restaurant, private office, fitness club, oil rig, retail store, bank or other financial institution, supermarket, automobile or boat dealership, or any other establishment with a common business area;
2. **Industrial establishments** - refer to any establishments engaged in manufacturing or processing, including, but not limited to factories, foundries, mills, processing plants, refineries, mines and slaughterhouses;
3. **Public and private institutions** - refer to all government-owned and private-owned institutions such as schools, colleges, universities, hospitals, day care centers, nursing homes, personal care homes, parks, sports centers, and wet and dry market;
4. **Residential** - refers to residential building units in subdivisions and houses outside subdivisions to be constructed;
5. **Rainwater Harvesting** - refers to a simple strategy by which rainfall is gathered and stored for future usage;
6. **Rainwater Harvesting System** - refers to a process which involves collection and storage of rainwater with the help of artificially- designed materials, that runs off natural or man-made catchment areas e.g. rooftop, compounds, rocky surface, hill slopes or artificially repaired impervious/semi-pervious

land surface;

7. **Water treatment** - refers to any process that improves the quality of water to make it more acceptable for a specific end-use.

SECTION 4. METHODS TO COLLECT RAIN WATER. Simple rainwater harvesting system options may be applied, from simple rain barrels to more elaborate structures with pumps, tanks, and purifying system:

1. Rain Barrels - This method is the most common and one that many people are familiar with. This involves installing a barrel at a gutter downspout to collect rainwater. The actual barrel may be a recycled barrel or a new commercially -available rain barrel.

2. Dry System - This method is a variation of a rain barrel set-up, but it involves a larger storage volume. Essentially, the collection pipe "drys" after each rain event since it empties directly into the top of the tank.

3. Wet System - This method involves locating the collection pipes underground in order to connect multiple downspouts from different gutters. The rainwater will fill the underground piping and the water will rise in the vertical pipes until it spills into the tank. The downspouts and underground collection piping must have water-tight connections. The elevation of the tank inlet must be below the lowest gutter on the house.

SECTION 5. MANDATORY PROVISIONS

1. All residential, commercial, and industrial establishments and both public and private institutions to be constructed within the Province of Cavite are required to set up a Rainwater Harvesting System;

2. The design, construction and maintenance of the drainage system shall integrate the design principles of the Rainwater Harvesting System to allow the proper harvesting, storage and utilization of rainwater;

3. Pervious and impervious surfaces in roads, open air parking areas, recreational and sports facilities and other large open establishments shall be designed to catch rainwater to reduce storm water peak flow and surface runoff.

SECTION 6. IMPLEMENTING AGENCIES. The Office of the Provincial Engineer (OPE), Office of the Provincial Environment and Natural Resources Officer (OPENRO), together with the Local Government Units (LGUs) shall formulate the Implementing Rules and Regulations (IRR) of this Ordinance within sixty (60) days upon its approval.

SECTION 7. MONITORING AND EVALUATION. For strict implementation and effectiveness of this ordinance, the Office of the Provincial Engineer through local chief executives or deputized representatives shall be designated for its monitoring and evaluation.

SECTION 8. COMPLIANCE PERIOD. - All residential, commercial and business establishments and private and public institutions to be constructed are mandated to comply within thirty (30) days upon approval of the Implementing Rules and Regulations (IRR).

SECTION 9. REPEALING CLAUSE. All previous ordinances, resolutions, executive issuances or rules and regulations or parts thereof, whose provisions are inconsistent with or contrary to the provisions of this Ordinance, are hereby deemed repealed, amended or modified accordingly.

SECTION 10. APPLICABILITY CLAUSE. The provisions of existing ordinances, resolutions or executive orders dealing with related, which are not contradictory with this Ordinance, are hereby adopted as an integral part of this Ordinance.

SECTION 11. SEPARABILITY CLAUSE. If, for any reason, any section/s or provision/s of this Ordinance is/are held unconstitutional or invalid, the section/s or provision/s not affected thereby shall remain in full force and effect.

SECTION 12. EFFECTIVITY. This Ordinance shall take effect after its approval and compliance with the posting

and publication requirements.


