



Dasma fire victims transferred to new homes in Cavite town

About 50 families affected by the fire that razed down more than 80 houses in Barrio Sta. Cruz 1 in the city of Dasmariñas on April 7, 2021 were recently transported to community in St. Mary Magdalene Ville in the coastal municipality of Naic.

The coordination P15,000 plus essential between the city government of Dasmariñas thru the City Disaster Risk Reduction & Management Office (CDRRMO), and the City Social Welfare Development Office (CSWDO) and the municipal government of Naic made possible for the family relocatees to get a chance to have their own decent homes.

Dasmariñas City Mayor Jenny Austria-Barzaga personally came to oversee the orderly transfer of her constituents as she handed each family with financial assistance of

Process Improvement of PHP Noodle Haus in Brgy. Taliba, San Luis, Batangas" which comprises the transfer of FNRI's Squash Canton technology among others. Hence, the conduct of this seminar on GMP was deemed relevant in ensuring that food safety system is in place before they commercialize the squash canton technology.

Nine production workers partook the training with strict compliance to the imposed health and safety protocols in light of




