During the May 2019 Imus City local elections, Advincula ran unopposed.



This is the military take-over. Civilian government still functions. The officials and members of the armed forces and other government units continue to discharge their duties as before without hindrance.

All executive departments, bureaus, offices, agencies, instrumentalities of the government, as well as granted corporations, governments of provinces, cities, municipalities, and barangays, continue to function under the present officers and employees in accordance with existing laws.

The following administrative functions under the civilian government and personnel organization and personnel management, criminal and civil cases, with certain exceptions, are closed for one week beginning this Monday for all.

• Carrying of firearms and other dangerous weapons is prohibited except by license, but without permission of the military.

• Curfew will be imposed from 12 midnight to 4 a.m. daily.

• Departure of Filipino air crews temporarily suspended except for official

simply show that the barangay council members continue to do their duties for the welfare of their barangay constituents despite the challenges faced in this pandemic.



DOH CALABARZON STRENGTHENS HEALTH SYSTEM AGAINST DELTA VARIANT TH

Department of Health (DOH) CALABARZON (Cavite, Laguna, Batangas, Quezon) continuous to strengthen its health care system against threat pf Delta Variant cases in the region.

"We have already established the "One Hospital Command Center (OHCC) in which we have link the health and medical services of our regional hospitals, particularly the Southern Tagalog Regional Hospital in Cavite and the Batangas Medical Center in Batangas. Kabilang rin sa network na ito ang ibang malalaking public hospitals sa probinsya ng Laguna, Quezon at Rizal upang magbigay ng kinakailangang health services sa ating kababayan lalo na sa mga positibo ng Covid virus. Most source of Delta infection comes from local transmission with 355 cases with the largest number also from Laguna with 102 cases.

eration Agency (JICA) of Representative Eigo Iwakawa, Cavite 2nd District Representative Min 'Strike' Revilla; and Vice 3rd District representative Alex AA' Advincula.

According to undersecretary Emil K. Jain, the design of two retard basins are based on a comprehensive flood management master plan prepared by JICA.

The two reservoirs is connected by a sluiceway for a total area of 9

hectares. According to Secretary Villar, these water reservoirs reduces flooding by 30% with inlets where flood water flows during peak volumes from the rivers of Bacoor and Imus are temporarily contained until the rains stop.

"This vast expanse of open land can also be used during summer or dry season which could be converted to a soccer field, baseball field, and open park for outdoor exercises," revealed Villar.
