

## DOH GIVES ANOTHER FIVE LAND AMBULANCES FOR COVID RESPONSE IN REMOTE AREAS IN CALABARZON

The Department of Health (DOH) — CALABARZON (Cavite, Laguna, Batangas, Rizal, Quezon) yesterday turned-over another set of land ambulances to hospitals and rural health units located in remote areas of the region for Covid 19 response and rescue.

Among the recipients were Alabat Island District Hospital in Quezon; San Jose RHU, Mataas na Kahoy RHU in Batangas; Malagasang 2 BHS in Cavite; Victoria RHU in Laguna and Ternate RHU in Cavite

in Cavite.

"We have to ensure that every rural health unit and government hospital in the region have one land ambulance to provide emergency service and transfer patient from one health facility to another to maintain the continuity of

medical care. Kailangang fully equipped at me mga lifesaving equipment na nakalagay including communication device for the management and care of the patient," Regional Director Eduardo C. Janairo stated during the turn-over ceremony held at the regional office in Project 4, Quezon City on September 28, 2020.

Each land ambulance comes with medical supplies and equipment needed for emergency including automatic external defibrillator, nebulizer, portable suction machine, examining light, aneroid sphygmomanometer, folding stretcher, scoop stretcher, heavy duty stethoscope, and oxygen cylinder.

"With all these land ambulances in place, we can expedite our Covid response in the region. Mas mabilis na ang pagresponde at pagdadala

CALABARZON has a total of 37,424 covid cases as of September 27, 2020. There are 19,521 recoveries recorded and 881 deaths. Active cases are at 17,022.

Laguna tops the province with the highest number of cases with 11,897, followed by Cavite with 10,213, Rizal with 6,979, Batangas – 6,540 and Quezon – 1,705.





#### PROVINCIAL ORDINANCE NO. 301-2020

AN ORDINANCE REQUIRING ALL PUBLIC AND PRIVATE SECTOR WORKERS AND PUBLIC UTILITY VEHICLE DRIVERS AND PASSENGERS FACE SHIELDS DURING THE CORONAVIRUS DISEASE 2019 (COVID-19) PANDEMIC AND PROVIDING PENALTIES FOR VIOLATION THE

Introduced by: Hon. Angelito H. Langit Sponsored by: All Sangguniang Panlalawigan Members

**WHEREAS,** Section 15, Article II of the 1987 Philippine Constitution provides that the State shall protect and promote the right to health of the people and consciousness among them;

WHEREAS, Section 16 of the Republic Act No. 7160 otherwise known as the Local Government Code of 1991, provides in part that every local governme exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective and those which are essential to the promotion of the general welfare. and shall ensure and support among other things, the promotion of health and safety

WHEREAS, Presidential Proclamation No. 922 and Proclamation 929, series of 2020, both issued by President Rodrigo R. Duterte, declared a State of Femergency on 08 March 2020 and a State of Calamity on 16 March 2020, respectively, throughout the entire Philippines due to COVID-19, and enjoined all agencies and local government units to render full assistance and cooperation in this time of national health crisis;

WHEREAS, in order to overcome the present threat of COVID-19 and to fight the invisible enemy, the Province of Cavite continually exerts efforts to abat

WHEREAS, Provincial Ordinance No. 276-2020, otherwise known as the Mandatory Use of Face Mask in Public Places, as amended by Provincial Ordinar 2020, is already in effect in the Province of Cavite, serving as one of its preventive measures against the spread of COVID-19;

WHEREAS, with the alarming increase of confirmed COVID-19 cases, not only in the Province of Cavite but in the whole country as well, the use of face of from wearing of face masks, will help reduce the spread of COVID-19 as it serves as an added layer of protection in conjunction with masks and also extends masks by blocking the droplet contamination;

WHEREAS, using face shields can also significantly reduce the possibility of local or community transmission especially by persons who are asymptoma already be carriers of COVID-19:

WHEREFORE, there is a need to adopt additional concrete safety measure to prevent, contain and restrict the spread of COVID-19, thus an ordinance mause of face shield is deemed necessary and timely;

**NOW, THEREFORE,** on motion of Hon. Langit, duly seconded by Hon. Gawaran and unanimously approved by the members present, be it enacted by the Panlalawigan of Cavite, in a session duly assembled, THAT:

SECTION 1. SHORT TITLE. This ordinance shall be known and cited as the "MANDATORY USE OF FACE SHIELDS BY ALL PUBLIC AND PRIVATE SECTOR AND PUV DRIVERS AND PASSENGERS ORDINANCE OF THE PROVINCE OF CAVITE".

SECTION 2. DEFINITION OF TERMS. For the purposes of this Ordinance, the following terms shall have the following meaning:

## ORDINANCE



a. Business establishments - shall include, but not limited to, restaurants, hotels, fast food chains, sari-sari stores, groceries, supermarkets, wet markets, pharmacies/ grug stores, banks, pawnshops, money changers, remittance centers, malls or shopping centers, private hospitals and clinics, factories, private companies and other commercial, entertainment, and leisure establishments, situated within the territorial jurisdiction of the Province of Cavite

b. Face Shields - shall refer to a personal protective equipment (PPE) used in conjunction with other protective equipment, specifically the face mask, giving protection and cover to the entire face (including eyes, nose and mouth) in order to reduce the exposure and emission of respiratory droplets which may be accumulated with bacteria or viruses.

c. Public sector workers - shall refer to all employees working in the local government units, government hospitals, and other national government agencies and government-owned and controlled corporations within the territorial jurisdiction of the Province of Cavite

d. Private sector workers - shall refer to all employees working in the business establishments mentioned in Section 2 (a) hereof

e. Public utility vehicles - shall refer to buses, jeepneys, and tricycles, operating within the territorial jurisdiction of the Province of Cavite

#### SECTION 3. MANDATORY USE OF FACE SHIELDS.

- a. All private sector workers working in the business establishments defined in Section 2 (a) hereof are hereby required to wear face shields, together with their face nasks, at all times, whenever they are in their areas of business.
- b. All public sector workers are hereby required to wear face shields, together with their face masks, whenever they are reporting for duty on their workplaces.
- c. All drivers and passengers of public utility vehicles are hereby required to wear face shields, together with their face masks, at all times, while riding in public utility vehicles.

### SECTION 4. PENALTY CLAUSE.

- a. If the offense is committed by the public or private sector worker, he/she shall be fined with Two Thousand Pesos (Php 2,000.00) or shall attend community service awareness campaign on COVID-19 for four (4) hours as conducted by the barangay officials or the Philippine National Police (PNP).
- b. If the offense is committed by the owner/employer/manager/administrator of the business establishments, he/she shall be meted with a fine of Three Thousand Pesos hp3,000.00).
- c. Any driver or passenger of public utility vehicle who was caught in violation of this Ordinance shall be meted with a fine of Two Thousand pesos (Php 2,000.00) or shall ttend community service awareness campaign on COVID-19 for four (4) hours as conducted by the barangay officials or the Philippine National Police (PNP).

SECTION 5. APPREHENSION - The Philippine National Police (PNP), the Municipal/City Mayors and other officials that may be duly deputized by their Local Chief executives, are hereby authorized to implement the provisions of this ordinance.

SECTION 6. SEPARABILITY CLAUSE - If, for any reason or reasons, any part or provision of this ordinance shall be held unconstitutional or invalid, other parts or provisions hereof, which are not affected thereby, shall continue to be in full force and effect.

SECTION 7. REPEALING CLAUSE - All ordinances and rules inconsistent with or contrary to the provisions of this Ordinance are hereby repealed, amended or modified accordingly. Hence, this ordinance is repealed upon declaration of the Inter-Agency Task Force for the management of Emerging Infectious Disease (IATF-EID) hat wearing face shield is no longer necessary and that COVID-19 has ceased to be a pandemic.

SECTION 8. EFFECTIVITY. This ordinance shall take effect immediately after its approval and compliance with the posting and publication requirements.


