"2. That defendants 1) SONIA O. ARIT, of legal age, a Filipino married and a resident of No. 947 Cabuco St., Caridad City, 2) NESTOR A. ARIT, JR., of legal, married, a Filipino, a resident NO. 947 Cabuco St., Caridad, Cavite City, 3) CAROLYN A. PASCUAL of legal age, Filipino married, a resident of 1587 Julian Felipe Blvd., San Antonio, Cavite City, 4) OLIVIA A. PAGTAKHAN, of legal age, married , a Filipino and a resident of NO. 417 Capt. Villareal St., Cavite City, 5) CYNTHIA A. DE GUZMAN, of legal age, a Filipino married, in a resident of NO. Capt. Villareal St., Cavite City and 6) JAIME J. ALBERTO, of legal age, married a Filipino and a resident of NO. 417 Capt. Villareal St., Cavite City. They may be served with summons and other processes of this Honorable Court at their respective addresses

"3. That plaintiff is one of the four heirs of the late Magdalena Javier Alberto ("Magdalena") and Jose Alberto;

"4. That to prove her heirship, she presents the following documents:

a. her birth certificate showing that her parents are Jose Alberto and Magdalena Javier, hereto attached as Annex A;

b. Her parent's death certificate showing that Jose died on November 28, 1990 (Annex B) while Magdalena on August 07, 2006 (Annex C); and

c. The birth certificate of all her siblings showing common parentage; Emelita J. Alberto (Annex D), Minerva J. Alberto (Annex E), Olivia J. Alberto (Annex F), Jaime J. Alberto (Annex G) and Cynthia J. Alberto (Annex H). As per attached death certificates, Amelita (a.k.a. Emelita) died on October 11, 1973 (Annex I) while Minerva on June 15, 2003 (Annex J), both before Magdalena died.

5. That Magdalena left a parcel of land with an ancestral home erected on it situated at 947 Cabuco Street, Caridad, Cavite City covered by TRANSFER CERTIFICATE OF TITLE NO. T-21639 (now TCT NO. 22588) with the Registry of Deeds of Cavite City. A faithful reproduction of a certified true copy Title No. T-21639 marked as CANCELLED is hereto attached as ANNEX K and described as follows:

"6. That she is asserting her corresponding share of ¼ part or 56.67 square meters out of the 226.70 square meters of the property left by Magdalena;

"7. That based on her recent discovery of documents, it appears that the signatures of Magdalena on the Deed of Absolute Sale In favor of defendant Sonia O. Arit dated September 3, 2004 (hereto

attached as ANNEX L) was forged;

\*8. That to prove this, plaintiff faithful reproductions of original Prudential Bank checks number 0410160, 04101159, 0410162 and 0410161 (hereto attached as Annexes M-1, M-2, M-3 and M-

4, respectively) signed by Magdalena;

"9. That plaintiff also presents the following documents bearing
the signature." the signatures of Magdalena which are markedly different from her purported signature in the questioned Deed of Sale, viz:

a, a faithful reproduction of a DOAS dated June 24, 2001 hereto

attached as ANNEX N; and b. a faithful reproduction of subdivision plan NO, Psd-04-157302 hereto attached as ANNEX O;

\*10. That as the document being spurious, it has no force and effect.

"11. That sometime in July 2017, defendant Carolyn A. Pascual confronted the plaintiff saying that she is now the owner of the lot In Issue because she had acquired it from the existing registered owner, defendant Spouses Sonia O. Arit and Nestor A. Arit

"12. That is(sic) view of this, plaintiff asked her nephew, Japheth A. Bautista, to go to the Registry of Deeds of Cavite City to secure a copy of the title with TCT NO. T-22588 and discovered that the registered owners of said property in question are still defendant Spouses Arit and that as per Tax Declaration No.02-0032-00134 the latest assessed value in P141,010, well –within the jurisdiction of this Honorable Court. Faithful reproductions of the TCT and the Tax Declaration are hereto attached as ANNEX P and ANNEX Q, respectively. The total market value is P773,383.80 (P705, 037 +P68, 346.80) as per ANNEX Q;

"13. That Magdalena could not have possibly executed the Deed of Sale in favor of Mrs. Arit to effect the Transfer of TCT T-21639 to TCT T-22588 in 2004 considering the state of health of Magdalena

at the time, mentally and physically;

\*14. That in the last quarter of 2003, Magdalena as 82 years had been frequently brought to the doctor by the plaintiff due to her severe gout or arthritis on both her toes and hands and was having back pain;

"15. That by the end of 2003, Magdalena's condition has worsened and was suffering from dementia caused by her old age and became bedridden:

"16. That sometime in July 2006, Magdalena was brought to St. Martin Clinic in Noveleta, Cavite and a month later she passed away

"17. That despite the several attempts to resolve the matter amicably with the defendants dating back to her discovery in sometime in 2008, still to no avail. Defendant Sonia Arit, kept on insisting that the deed sale(sic) she executed was valid; and




