

"We have designed our bike facilities to be enjoyed by all members of the community across all ages and biking abilities, whether it be for utilitarian or recreational purposes". Silang initially committed a total of P30M as counterpart budget to the Philippine government's allocation for TB for the year 2021 and welcomed the technical assistance packages proposed by USAID's TB Platforms which include strengthening of local TB response amid COVID-19 thru technical support in drafting or

amending the TB ordinance, capacity of Te building on preparation classified cost elimination plan, orientation on the implementation of FAST strategy in health facilities, conduct of community TB screening and implementation of TB in workplace settings.

Likewise, all the

mayors are supportive of their health offices' proposed development of the 2021 Operational and Budget Plan for TB as this will identify the necessary requirements of the city/municipality in terms of procurement of TB drugs and XRay machines, hiring of additional human human resources like nurses and medical t e c h n o l o g i s t s specifically assigned for the TB program and incentives for barangay healthcare workers serving strengthened the TB in response communities.

USAID's TB Platforms presented the need for the establishment of the Primary Care Provider Network (PCPN) and Health Care Provider

Network (HCPN) and all local government units along with their Provincial NTP coordinator have agreed that the city/municipal council along with their respective health offices will discuss how to effectively push this initiative which may include the engagement of the Samahan ng mga Barangay Kagawads (network of barangay councils) as part of the oversight committee.

These systems generally answer the call for a more rapid response agency through merging credible sources of information into a platform, and providing a means for the agency to quickly disseminate information. DRRMrelated Smart Office Systems are composed Hazard the Notification, Dissemination and Awareness (HANDA), Local Government Unit Information Dissemination System (LGUIDS), and Sensing Environmental Parameters through Telemetry (SENTRY).

Another category and seemingly the most popular among the three, is the internal operations systems. These information systems aim to support basic yet vital office operations like mobile (Human bundy Resource Management Information System-HRMIS) task delegation and document tracking (Tracking, Retrieval, Archiving Communications for Efficiency-TRACE),

project documentations retrieval and status monitoring (Information and Monitoring of Projects, Services and S&T Interventions-IMPRESSION), and financial transaction monitoring (Tracking, Retrieval, and Archiving Documents Efficiency-TRADE). These set of information systems rose to fame specifically through the nationwide rollout of IMPRESSION to all DOST Regional Offices in the country in 2018.

These systems cater not just the internal processes but also pave way for utilization the external customers and partner agencies. These systems provide a locally developed system for users to share and manage information. These knowledge generation and management systems Webinar include and Technology Channel (WATCH), Exchange of Probes, Learnings and Outputs of Researches (EXPLORE), Electronic Registration System Evaluation (EREG/EVAL), BUILD-A-STAR, and Knowledge Management Information System (KMIS).

To date, after almost a decade since the start of the Smart Office System's development, DOST-CALABARZON, together with the private and public organizations that made up of the 170 system adoptions from all over the country, are already proudly reaping the fruits of Kiko and his team's hard work and service. The relatively high number of systems adoption, and diverse list of system adopters serve as living testaments of Kiko's dedication and willingness to share solutions that go even beyond his duties and




