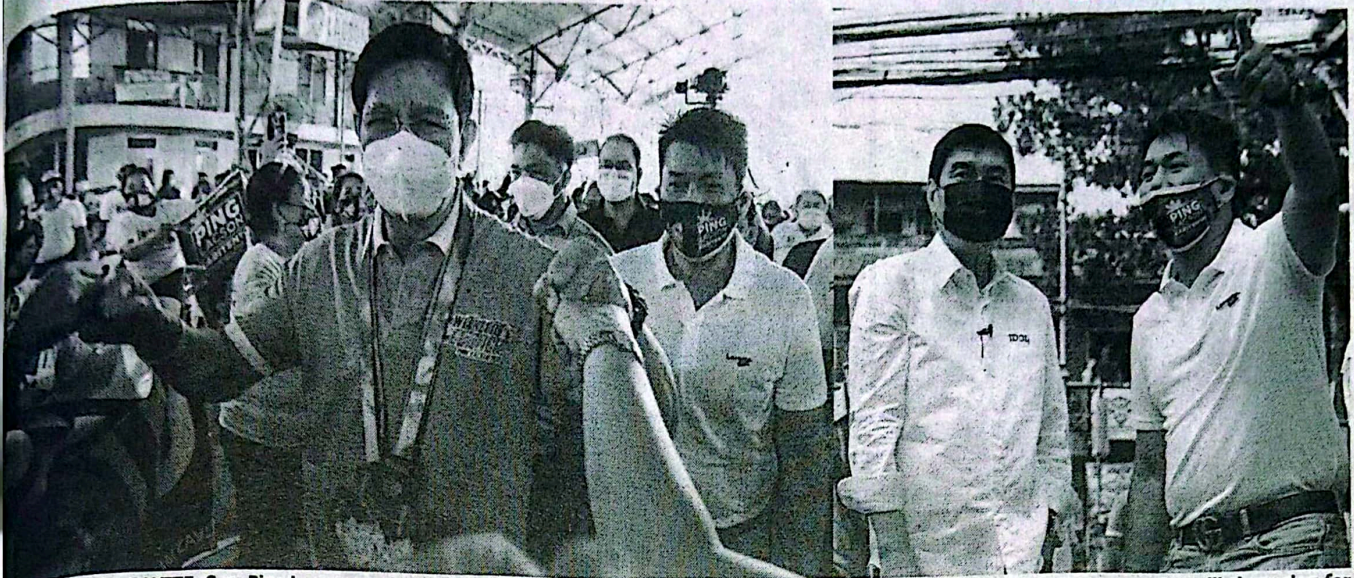

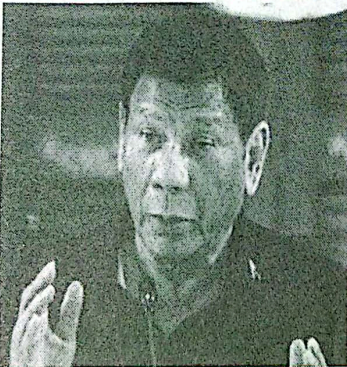

Kandidatura ni Bong Bong Marcos ikakansela ng Comelec?

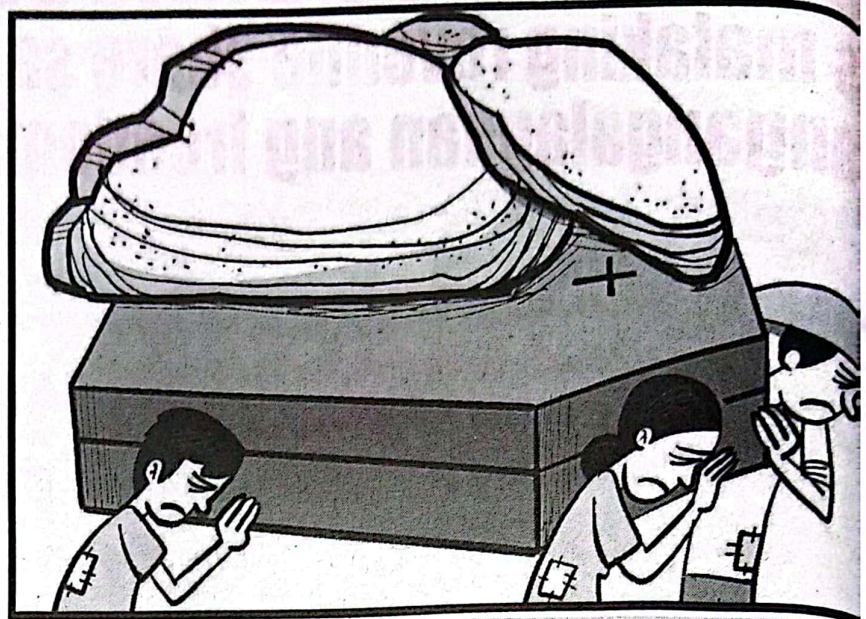
Maaring madesisyonan ng Commission of Elections (Comelec) ang petisyon sa pagkakansela sa 2022 presidential bid ni dating Sen. Ferdinand "Bongbong" Marcos Jr. sa susunod na buwan, ayon sa poll body. Ika-2 ng Nobyembre kasi nang maghain ng petisyon ang ilang grupo para ibasura ang kandidatura ni Bongbong dahil sa ilang pagsisinungaling diumano sa certificate of candidacy (COC) sa kanyang 1995 tax-related conviction na nagbabawal raw sa kanyang tumakbo sa ilalim ng batas.

"There's probably going to be something around December," pahayag ni Comelec spokesperson James Jimenez sa isang panayam noong Huwebes.

Ayon sa mga petitioners, napagdesisyonan na noon ng QC Regional Trial Court Branch 105 na guilty beyond reasonable doubt si Bongbong, anak ng diktador na si dating Pangulong Ferdinand Marcos Sr., dahil sa kabiguang maghain ng income tax returns ao magbayad ng buwis noong 1982 hanggang 1985. Aniya, "moral turpitude" na ito.

Sinentensyahan si Marcos ng siyam na taong pagkakakulong at pinagmumulta para sa paglabag ng Sections 45 at 50 ng National Internal Revenue Code para rito.

Kahit kinatigan ng Court of Appeals ang naunang guilty verdict, hindi nakulong si Bongbong at pinagmumulta na lang. Tinawag namang "nuisance petition" ni Victor Rodriguez, tagapagsalita ni Marcos, ang maniobra para matanggal si BBM sa



2022 electoral race.

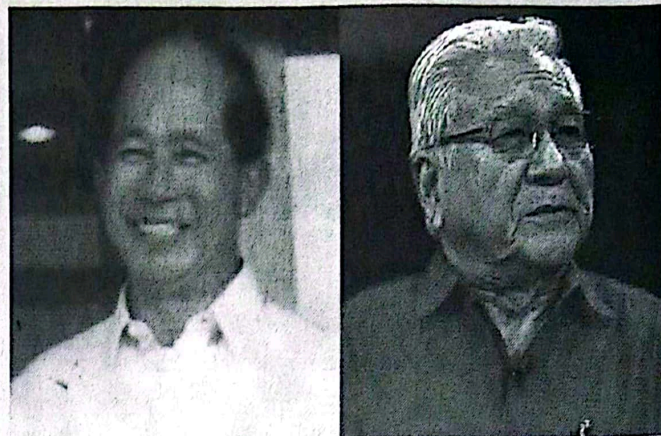

Ipinanganak sa Imus noong Hunyo 1, 1948, mag-aral si Lacson sa Bayang Luma Elementary School at nagtapos ng high school sa Imus

Institute noong 1964 at noong 1971, naging commissioned officer ng Philippine Constabulary nang magtapos sa Philippine Military Academy.

Nang likhain ang Philippine National Police, humawak ng iba-ibang posisyon si Lacson at sa panahon ni dating Presidente Erap Estrada, hinirang siya na Director General ng PNP noong Nob. 1999.

Kilalang disciplinarian, nilinis ni Lacson ang anomalya sa PNP at naitaas niya ang moralidad ng pulisya at ang tiwala ng taumbayan.

Sa kanyang talumpati, sinabi ni Lacson na sa loob ng mahabang panahon ng panunungkulan niya sa PNP at bilang senador, tinupad niya ang tungkulin at pananagutan sa sambayanang Pilipino ng

marangal, matapat at walang pag-iimbol.

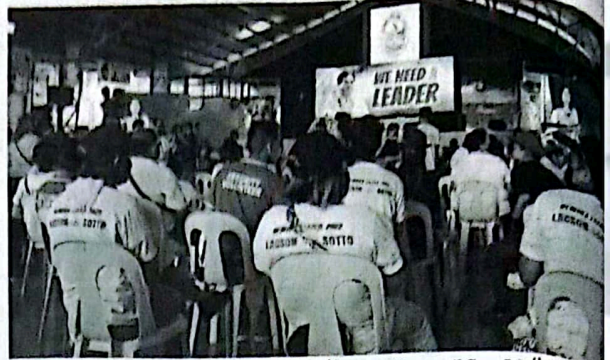
Kilalang crimebuster sa PNP, natanyag si Lacson bilang "Heneral ng Bayan" at Mr. Expose sa Senado na nanguna sa maraming imbestigasyon laban sa mga anomalya at korapsyon sa gobyerno.

Tumanggi sa pagtanggap ng alokasyong pork barrel sa paninindigang isa ito sa taksong umaakit sa mga mambabatas na masangkot sa katiwalian.

Sa Senado, kampeon si Lacson sa pagpapalakas ng local government units (LGUs) nang lakda niya ang Budget Reform Advocacy for Village Empowerment (BRAVE).

Aniya, agad niyang ipatutupad ang pagkakaloob ng dagdag na kita mula sa Internal Revenue Allotment (IRA) ayon sa Mandanas ruling na pinagtibay ng Supreme Court nitong 2019.

Sa kanilang platform ni Sotto, nagkaisa sila na ikalat at ibigay ang



dagdag na IRA sa LGUs at sa malalayo at mahihirap na lugar.

"We agreed to prioritize in our platform to make sure the budget can be used by our people especially at the local level. Ang halagang ito ay nasa atin nang national budget for 2022," sabi ni Lacson.

Kamakailan, sa isang video conference, sinabi ni Lacson na sa kanyang gobyerno, igagalang at ipagtatanggol ang press freedom at isusulong ang 'transparency in governance.'

Ipinaliwanag ng kandidatong pangulo ng Partido Reporma na ang kaloob na kalayaan sa pamamahayag, ayon sa itinatakda ng Constitution ay napakahalaga sa demokrasya.

"Ito, ang press freedom, ang mismong demokrasya," sabi ni Lacson.

Magiging lantad sa taumbayan ang gobyerno sa pamamahala niya kung sila ni Sotto ang mananalala sa eleksiyon.

"Wala kaming itatago, lahat ay bukas sa tao," aniya na idinugtung na kung paano niya nilalabanan ang katiwalian sa gobyerno ngayon, lalong mas mahigpit ang kampanya niya laban sa korapsyon kung siya na ang nasa Malakanyang.

Kasama ni Lacson sa Imus si dating House Speaker Pantaleon Garcia, at columnist broadcaster Raffy Tulfo at mga masusugid na tagasuporta.

Kailangan nang buksan nang unti-unti ang ekonomya at nang makabangon sa perwisyong dulot ng umiiral na pandemyang Covid, sabi pa ni Lacson.

Pag-aaralan din ng kanyang gobyerno kung siya ang pangulo ang batas sa ayudang pamilya at ang tungkol sa problema ng mataas na singil sa koryente, tubig at iba pang serbisyo publiko.

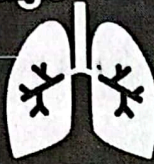

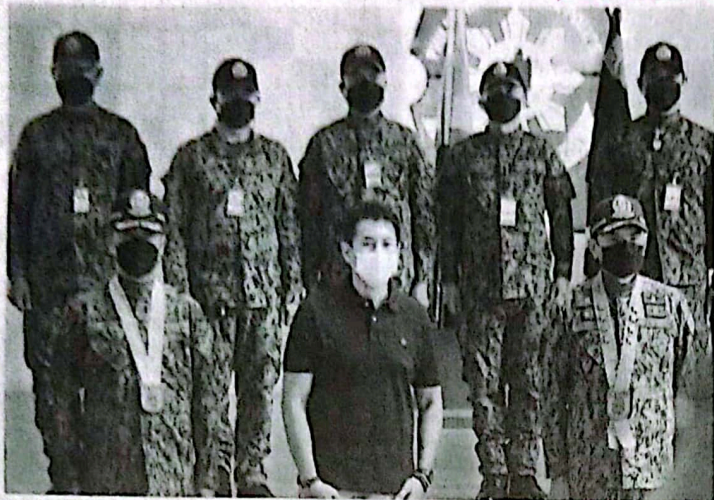

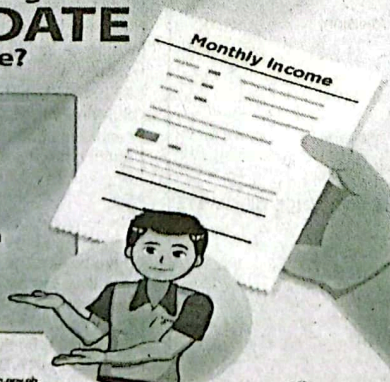
