

## FACE SHIELD PAG AARALAN PA BAGO TANGGALIN AYON SA MALACANANG?

**W**ala pa ring pagbabago sa kautusan ng Inter-Agency Task Force (IATF) tungkol sa paggamit ng face shields at kailangang maghintay ang mga atat na tanggalin na ang nasabing kautusan.

Ayon kay Presidential spokesperson Harry Roque, dapat na ipatupad pa rin ang kautusan sa paggamit ng face shields hanggang pinag-aaralan pa ang tuluyang pagtanggalo dito.

Idinagdag rin ni Roque na hindi naman nangangahulugan na hindi tatanggalin ang kautusan pero dapat hintayin ang desisyon ng IATF at ang kapasyahan ni Pangulong Rodrigo Duterte.

Humiling pa ng paumahan si Roque sa mga hindi na makapaghintay pero dapat anilyang masunod ang utos ng Executive Branch ng gobyerno.

Naklusap din si Roque sa mga local government units at sa mga mayors na nasa ilalim ng kontrol ng Presidente na sumunod sa IATF at sa kautusan ng Pangulo.

Samantala, humiling pa ng isang linggo ang Department of Health (DOH) sa mga lokal na pamahalaan bago mailabas ang recomendasyon nila kung tuluyan nang tatanggali ang paggamit ng face shields sa mga pampublikong lugar sa bansa.

Ito'y makaraang maglabas na ng kautusan si Manila City Mayor Isko Moreno, maging ang lokal na pamahalaan ng Davao City at Iloilo City na tanggulin na ang paggamit ng face shield maliban sa loob ng mga ospital at clinics.

Iginilit din ni Health Undersecretary Maria Rosario Vergeire na kailangan pa talaga ng resolusyon mula sa IATF bago legal na maipatupad ang pagtanggalo sa paggamit ng face shield.





Depektibo, kulang sa porma at walang batayan sa batas para matamo ng mga petisyoner ang hinihilngang hatol na disqualification ni BBM.

Kulang na kulang, kapos na kapos o walang napresentang tiyak na pahayag at legal basis o batayan sa batas, ang paratang na hindi kuwalipikado si BBM na tumakbong pangulo, at ano lahg ang nilalaman ng petisyon?

"... that instead of presenting factual statements and legal basis to support its claim of Marcos' Ineligibility to run for the presidency, the narratives of the 57-page petition lay down Invectives in almost all pages against the family of respondent Marcos."

"Yun kuwento o salaysay sa 57-petisyon ay tadtad o puno ng pagtuligsa, panlalain o pagpaparatang sa pamilya ng kinakasuhang si Marcos.

Sabi pa ni Divina: "It's ad hominem, or an attack against the character of the respondent, that may weaken the petitioners' position. It is the law, always, that matters."

"It is the intent that invokes the law that often justifies or bungles it. But at the end of the day, the law remains the law," sabi pa ni Divina.

Intensiyon sa paggawa ng krimen ang mahalaga sa batas, sa huli, kung and ang sinasabi o inihiutos ng batas, iyon ang masusunod, hindi ang paninira sa pagkatao o karakter ng respondent o kinakasuhan, paliwanag ni Dekano Divina.

Eto ang sabi ni dating Justice Sec. Alberto Agra, na law professor ng Ateneo University.

Hindi tax evasion; failure to file his income tax returns ang nagawa ni Marcos at, paliwanag ni Agra, "... the petition has no basis and is unlikely to move forward."

Walang batayan o basis o katwiran ang petisyon, sabi ni Agra, tulad ng sinabi ni Dekano Divina.

Paliwanag ni Agra, ayon sa Omnibus Election Code, kuwalipikado, may karapatay si Marcos sa pagka-pangulo, kasi "... there are no shortcomings in his CoC submission."

Walang kakulangari, o kumpleto sa lahat ng bagay ang isinumiteng CoC ni BBM, ayon kay Agra.

"Ang nakalagay sa batas ay kailangan sentenced, may (What the law states is: that there must be a) final judgment of imprisonment," paliwanag pa ng dating Justice secretary.

Pinagbayad lamang ng multa at walang hatol na pagkakulong ni Marcos sa desisyon ng regional trial court (RTC) sa QC, pagliliinaw ni Agra.

Hindi siya, sabi ni Agra na tagasuporta ni BBM, at hindi rin siya abogado nito. Pero ayon sa kanyang parehas na analisis sa kaso, walang krimeng tax evasion.

"... but based on his analysis of the petition, it appeared that the case is not tax evasion, but simply a failure to file his ITR," sabi ni Agra.

Sa batas, pwedeng makansela ang CoC ng sinomang kandidato, siya ay dapa o kailangang mahatulang guilty o may sala at may kasamang parusa sa hatol na mahigit sa 18 buwan na pagkakulong o kaya naman ay convicted o napatunayang ngkasala ng karumaldumal, kasuklamsuklam na krimen o moral turpitude.

Sa krimeng nagawa raw ni BBM, ito ba ay immoral o kasuklamsuklam at napatunayang ba na sinadya o intentional ang pandarata na inaanusta kay Marcos.

"Ang tanong ngayon ay 'yun bang hindi pag-file ng income tax return, 'yun ba ay crime involving moral turpitude? Siyempre hindi," paliwanag ni Agra.



# BatStateU, PPSI to honor national scientist Dr. Gavino Trono in a virtual symposium

The Batangas State University (BatStateU), through the Verde Island Passage Center for Oceanographic Research and Aquatic Life Sciences (VIP CORALS), and in partnership with the Philippine Phycological Society, Inc. (PPSI) will be co-hosting the 9th National Symposium and Scientific Meeting of the PPSI on Nov. 12-13 to which they will pay homage to the 90th birthday of national scientist Dr. Gavino Trono Jr., a Filipino biologist dubbed as the "Father of Kappaphycus farming".

Dr. Trono was conferred the rank of National Scientist of the Philippines for contributions to the study of tropical marine phycology, focusing on seaweed biodiversity. He is currently working as a technical consultant for the Food and Agriculture Organization (FAO) Aquaculture Seaweed Research and Development and is a professor emeritus of the University of the Philippines Marine Science Institute (UP MSI).

The symposium carries the theme "Phycology Under New Normal and Beyond" which headlines four (4) international scientists as plenary speakers: Dr. Victoria Chraibi, Assistant Professor of Biological Science, Tarleton State University, USA; Dr. Roberta D'Archino, Marine Biologist - Coast and Oceans, National Institute of Water and Atmospheric Research (NIWA); Dr. Suzanne McGowan, Professor of Freshwater Science, Netherlands Institute of Ecology; and Dr. Joel Cuello, Professor of Biosystems Engineering, University of Arizona, USA.

According to PPSI President Dr. Wilberto D. Monotilla, this year's

scientific program also features oral and poster sessions from professionals and students presenting a broad range of research findings related to phycology.

"The symposium will provide the ideal forum to stimulate ideas and establish collaborations as well as encourage and initiate discussions. As we journey towards our third decade in providing professional and scientific education, we aim to create a new engaging online experience with aspiring professionals by providing innovative insights and invaluable guidance and assistance from experts in the field of Phycology," Dr. Monotilla added.

Established in 2007, PPSI is steadfast to its mission of promoting the science of phycology (study of algae) in the Philippines, being the country's primary and foremost phycological society in education, research, and industry, and serving as repository of information on the phycological culture and resources in the country.

This will be the first time that the symposium will be held virtually. PPSI conducts its symposium biennially with partner

organizations and universities in some localities which include UP MSI (2007 and 2011), UP Los Baños (2009), Southeast Asian Fisheries Development Center (SEAFDEC) (2013), Mariano Marcos State University (2015), Mindanao State University (2017), and De La Salle University (2019), and Batangas State University (2021), thus serving its constituents from different regions of the country.





The senator declared, "I will make Cavite proud!"


Congressman Alvarez said that the main issue for the coming May elections is 'leadership' which the senator and his team will bring if ever given the chance to lead.


