AKO AY PILIPINO, TAAS NOO SA BUONG MUNDO!



Matapat, maayos na gobyerno ang iniwang pangako nina Bongbong at Inday Sara sa pagdalaw nila sa



CHIZ SA MGA BANKO: ILAAN ANG 10% NG LOAN PORTFOLIO SA MALILIIT NA NEGOSYANTE

Para bigyang-daan ang pagbangon ng Pilipinas matapos ang pandemya, hinimok ni senatorial aspirant at kasalukuyang Sorsogon Gov. Francis "Chiz" Escudero ang mga banko na siguraduhing mapupunta ang 10% ng mga pautang nito para sa financing ng micro, small and medium enterprises (MSMEs).
