




To vax or not to vax: Is that still the question?

At the beginning of November, the Oxford English Dictionary chose its word of the year. Quite expectedly, it opted for a word that best summarizes this 2021, a year that came at the heels of a pandemic that still continues to this day. And this word is "vax," which is short for vaccine (n) or to get vaccinated (v), or to be vaccinated (adj).

An innocent word on its own, it has taken the entire world captive, so to speak, as countries race to immunize — to vax — their populace as quickly as possible. In the case of the Philippines, the rate of vax (as a noun) as estimated by the Department of Health in its National COVID-19 Vaccination Board is currently at 662,104 persons per day. As of Dec. 27, there are around 47.86 million fully vaxed (as an adjective) Filipinos, with some 1.48 million who have received boosters (i.e. additional vax). Meanwhile, those who have received a single vax dose now total 56.95 million. This puts the total vaxx doses administered (boosters included) to 106.2 million.

Although a lot of factors affect how fast countries can vax (as a verb) its peoples, chief among these is the availability of the vax (also as a noun), some degree of reluctance remains among certain groups. Other groups are even vehemently opposed to the idea of getting vaxed.

In the Philippines, a wave of anti-vax sentiment came in the wake of the pre-pandemic Dengvaxia issue. This seems to have been completely forgotten, or at least mostly, as Filipinos are generally more in favor of getting vaxed, at least



according to statistics. It is in this regard that vax should not just be word of the year. The issue, as with anything worthwhile, is not so simple. Getting vaxed is deemed important, even necessary by governments and health experts all over the world, with campaigns urging people to get vaxed aired on TV and radio, posted online and in print. On the other hand, no government can force people to get vaxed, out of respect for the individual rights and freedoms.

When one speaks of rights and liberties, however, doesn't one have to consider impinging on other people's own rights and liberties? Does public safety, regarded mostly during our times as the populace's

ability to survive COVID, outweigh the individual choice to remain unvaxed, for one reason or another? The exercise of freedom always comes with a cost. Freedom is paid for by consequence. In the case of people not getting vaxed, the consequence can mean the health and safety, in instances the life and death, of others.


Will there ever be a situation where the health and safety of the public outweighs the rights and liberties of individual anti-vaxxers? Or will we be stuck in a tug-of-war between getting vaxed and not getting vaxed, as both seem to be a right person could claim?





DOST-CALABARZON Food Safety Team, was invited to introduce and discuss basic food hygiene practices. Mr. Libao defined jargons in the food industry, cited food safety-related laws and regulations, outlined steps to secure sanitary permits, and detailed food hygiene guidelines.

Ms. Diane Z. Ulan, Science Research Specialist I and DOST-CALABARZON Food Safety Officer, presented the FSSAT, accessible at <https://fssat.dostcalabarzon.ph>. Due to the flux of "career shifters" or individuals that shifted into home-based and online food selling, the DOST-CALABARZON developed the FSSAT to ensure that food safety is practiced by local food entrepreneurs. The digital

application provides a 46-item self-assessment checklist that covers the minimum requirements of food safety.

The DOST-CALABARZON Food Safety Team, with the assistance of the regional office's Management Information Systems Unit, is upgrading the application to give users data analytics of their strengths and items for improvement. Currently in service for 100 users representing CALABARZON-based SMEs, the FSSAT will soon be introduced to regulatory agencies such as the CALABARZON regional and provincial offices of the Department of Health and Local Government Units, to expand the reach of the application.

In his closing remarks, Engr. Francisco R. Barquilla

III, DOST-CALABARZON OIC-Assistant Regional Director for Technical Operations, encouraged the participants to make use of the FSSAT to simplify their periodic monitoring of food safety compliance. "We are currently building an Android version of the website para mas maging accessible po sa inyong lahat. Kahit naroon po kayo sa planta at naka-mobile phone ay magagamit n'yo po ang FSSAT—kahit tablet, smart phone ay ma-a-access n'ya s'ya. Batangas, Cavite local execs thank Cayetano for 'big help' from Sari-saring Pag-asa



DOST-CALABARZON-developed Food Safety Self-Assessment Tool featured in food hygiene webinar




Home-based and online food sellers were gathered virtually for the Department of Science and Technology – CALABARZON (DOST-CALABARZON) Webinar on Basic Food Hygiene and Orientation on Use of Food Safety Self-Assessment Tool (FSSAT) last 22 December 2021. More than 100 attended the online event streamed via Zoom which briefed the participants on fundamental food hygiene and promoted the use of the FSSAT.

Dir. Emelita P. Baggit, DOST-CALABARZON Regional Director, in her address referenced a January 2021 study conducted by Mariano Marcos University which found that only 8.3% among the surveyed home-based food handlers met food safety standards. "With the industry projection of annual growth of food e-commerce, we should be more cautious if our online food business and their partner delivery service are knowledgeable and consistently practicing compliance to food safety regulations," she said. To address this concern, the DOST-CALABARZON launched in November the FSSAT, a web application that assists persons engaged in the food industry to track their compliance to basic food hygiene.

To support the use of the application, Mr. Mhark Elligne A. Libao, Research Specialist II in the DOST-Batangas, and member of the
