After the four previous pisodes of featuring the technologies developed by the Department of Science and Technology's Food and Nutrition Research Institute's (DOST-FNRI), the final episode highlighted the Ready-to-Drink Green and Ripe Mango Juice with Nata which pathered a total of 63 participants from Luzon, Visayas and Mindanao. Ms. Abbie L. Padrones, Senior Science Research Specialist at the Nutritional Food Research & Development Section of the Food and Nutrition Research Institute DOST, facilitated the online discussion.

The trend of the National Nutrition Survey results from 1993-2013 shows an increasing rate of Vitamin A Deficiency (VAD) from 35.3% in 1993 to 40.1% in 2003. In response to the call to address this problem, DOST-FNRI initiated various programs which propelled a significant decrease of VAD in 2008

(15,2%). Sangkap Pinoy or the Vitamin Fortification of snack foods and processed foods is one of the most competitive programs that the institute implemented to help combat VAD. Yet, DOST-FNRI's commitment didn't stop there as they spinoff more research and development to address this problem. Fruit juices are among the considered vehicles to apply fortifications because they are the most refreshing, nutritious, affordable and highly consumed juices in the country. Given this, DOST-FNRI developed the Ready-to-Drink Green & Ripe Mango Juice with Nata to serve as a good source of vitamins and minerals and help the

body against infection.
According to Ms.
Padrones, this juice is made up of sugar, sweetened nata de coco, and natural fruit juice from green and ripe mango (carabao variety). It also has dietary fiber from nata de coco, which is a

cellulosic biomass made from aerobic fermentation of coconut milk and water. Constipation, obesity, diabetes, hypertension, and other disorders can all be avoided and treated with fiber hence, this juice is a good source of such.

The process flow in producing this juice was also presented by Ms. Padrones. She discussed every detail of the production beginning from raw materials, syrup, fortifiers, and other ingredients, to mixing ingredients all together using a cooker-mixer, pasteurization and packaging. List of some of the equipment used in processing this technology such as colloid mill (to liquefy the fruit), pulper finisher (bigger version of strainer where the size of the screen depends on the size of the fiber you want to put in the mixture), cooker mixer (for pasteurization purposes) was likewise covered in discussion. the Competitive advantages of the technology include use of natural fruit, no artificial additives, 100% vitamin C

and at least 33% vitamin A, good consumer acceptability, and longer shelf life from 6-12 months. In terms of the this cost structure, technology entails cost incurred from R&D (P1.9M), equipment cost (P700,000.00), technology licensing fee (P50,000.00) and Its suggested retail price is 15.00 pesos per 200 ml. And early yesterday March21, the Municipal Government of Noveleta led by Municipal Health Officer Dr. Maria Hilda Bucu received the vaccines and personally supervised the safekeeping procedure in the Cold Storage Facility until the official launch of the locality's vaccination program on Tuesday, March 23, 2021.

billing statement. Selfpaying individuals may also select the number of months that they will pay for - from one month to a maximum of three years. After selecting the desired payment range, the module will automatically compute the total contributions due for payment based on there declared income and indicate the due date.

After generating their SPA, the payor then proceeds with choosing the accredited collecting agent (ACA) which will process their payment. Currently PhilHealth has engaged IPAY-MYEG Philppines, Inc. as its payment partner. Other partners such a PayMaya will soon be added.

The payor will then be directed to the ACA's domain to make the

payment either using Visa or Mastercard credit, debit, pre-paid cards, or Minimal GCash. convenience and service fees will be applied to each transaction. For each successful payment, members will receive their electronic PhilHealth Acknowledgement receipt or ePAR and an e-mail or SMS confirmation.

This payment option will soon be available to Filipino Overseas Workers.

PhilHealth President and CEO Atty. Dante A. 




